SECTION B: TERMS OF REFERENCE

1. Introduction to C-BRTA

The Cross-Border Road Transport Agency (C-BRTA) is PFMA Schedule 3A Agency established through the Cross-Border Road Transport Act 4 of 1998 and provides advice, regulation, facilitation and law enforcement in respect of commercial cross border road transportation. The Act gives the C-BRTA mandate to licence commercial cross border road transport operators by issuing permits to operate. The provision of cross-border transport services in South Africa is subject to the provisions of the Cross-Border Road Transport Act. In terms of the Act, any person or organisation wishing to provide cross-border transport services must apply to the Cross-Border Road Transport Agency's Regulatory Committee for a Permit to conduct cross-border business.

The Cross-Border Road Transport Agency's (C-BRTA) thus exists, amongst others, to improve the flow of passengers and freight road transport in the region, introduce regulated competition in cross-border road transport, reduce operational constraints for the cross-border road transport industry, provide oversight and monitoring functions, and to improve the unimpeded transport flow by road of freight and passengers.

2. General rules and instructions

- 2.1. Bidders or their agents shall not make any news releases concerning this RFQ or the awarding of the same or any resulting agreement(s) without the consent of, and then only in co-ordination with, C-BRTA and its Client.

SECTION C: SCOPE OF WORK/SERVICES

Bidders are invited to quote for on-site document shredding services for a period of 36 months.

1. Background

Request for the appointment of the service provider to render on-site document shredding services and supply lockable waste paper cabinets at the C-BRTA Office for a period of 36 months.

The Agency's is required to comply with the Protection of Personal Information Act by safeguarding sensitive and confidential information. Facilities procured shredders in areas where sensitive information required to be shred immediately. Shredders can however not be the sole method of disposal, as regular cleaning out of shredder bins becomes time-consuming, specifically in high volume areas. The shredding project was undertaken to assist the Agency in its effort to recycle instead of disposing paper as normal waste. To date, for the duration of the contract, 685 kg of paper has been collected and recycled.

2. Specifications

2.1. Monthly on-site mobile document shredding services

- (a) Documents must be shredded on-site in a closed truck with the necessary equipment.
- (b) Cabinets must be emptied into locked/sealed wheelie bins for transportation from the building to the truck.
- (c) Certificate of destruction must be supplied after completion of work.
- (d) Shredding must be done on a monthly basis.
- (e) Service will include removal of already shredded paper stored in the wheelie bin.

2.2. Supply of document cabinets/bin

- (a) Supply 11 (eleven) lockable melamine waste paper cabinets.
 - i. Approximate size 500mm(L) x 500mm (W) x 1000mm (H)
 - ii. Capacity of approximately 60 kg
- (b) Supply 1 (one) lockable wheelie bin.
 - i. Green or grey
 - ii. Capacity of approximately 240 litres.
