Your attention is specifically drawn to the following amendments which have been made to the Tender document and you will be deemed to have made the necessary provisions for these amendments in your tender offer.

1. Changes to Pages 75, 107, 139, 171, 203, 235 and 267 of the Schedule of Rates

Item number **21.2.3: 7 pair, 1.5mm²/2.5mm² Pilot cables** – There was no unit of measure and no provision was made for entering a rate. Tenderers are to replace these pages mentioned above with the attached amended Pages.

2. Changes to clause 6.20 of the Scope of Work (page 360)

Clause 6.20 has been amended to read as follows:

6.20 The contractor shall dedicate for the duration of the contract for each work category, at least the following tools and equipment:

9 x Generators	4 x Welding equipment (Portable acetylene welding kit complete, including suitable PPA)
9 x Mechanical Compactors	9 x Approved non-conductive extension ladder of appropriate length
9 x Jackhammers (complete with compressor equipment)	9 x Fall arrest harness (Full Body)
4 x Heavy duty water drainage pump (complete with generator equipment)	6 x Line Vices and come-along
6 x Cable Trailers/Drum Rotators	9 x Bandit strapping machine with stainless steel strapping and buckles
9 x Fully equipped insulated Electrician's toolkits	9 x Line Tester
9 x Normal Drilling machines	9 x Clamp on ammeter
6 x Core Drilling machines (with drill bit diameter larger than 22mm and longer than 300mm)	9 x Fully equipped insulated electrician's tool kit in suitable bag
6 x Suitable tools and jointing equipment to maintain and install ABC reticulation	
6 x Rigging Equipment (ropes, slings d-shackles)	
9 x First Aid and Burnshield Kit	
9 x CO2 fire extinguisher	
20 x Spades	
20 x Picks	

Proof of ownership and/or rental for the above mentioned vehicles shall be required before commencement of contract.
