1. Background

The City of Johannesburg, through the City Manager's office was approached by Food and Agriculture Organisation of the UN to co-host the Second Edition of the Africa Forum on Urban Forests (AFUF) in Johannesburg. The event seeks to gather African city leaders, practitioners, and professionals to collectively tackle challenges and capitalize on opportunities related to urban forestry and green spaces. FAO co-organizes regional conferences across the globe in partnership with City Councils and other stakeholders. The first conference in Africa was held virtually in 2021 due to the Covid-19 pandemic. The 2nd AFUF is set to occur from 4th to 6th March 2025 in Johannesburg.

The main goal of AFUF is to facilitate collaboration and knowledge exchange among stakeholders, aiming to promote sustainable development and effective management of green spaces throughout Africa. With an expected turnout of at least 300 participants, the forum is poised to serve as a pivotal platform for sharing expertise and best practices in this essential realm of urban development.

In light of this, Johannesburg City Parks and Zoo (JCPZ) is seeking a highly qualified Professional Conference Organiser (PCO) to manage and coordinate the logistics and operations of the event. The PCO will be responsible for overseeing the planning and execution of all aspects of the forum, ensuring seamless event management, engaging stakeholders, and delivering a high-quality experience for all participants. The role will involve coordinating venue logistics, registration, speaker and delegate management, sponsorships, communications, and providing on-the-ground support during the forum itself.
