1. BACKGROUND

SFF is a wholly owned subsidiary of CEF established by the Government and came into operation in 1977. The entity is mandated by the Minister of Energy to manage and control the Strategic stocks, Strategic assets and commercialization of the assets in order to fund the government mandate.

2. SCOPE OF WORK:

SFF seek to appoint a Registered LPG Installer to prepare one Mounded LPG tank for its statutory inspection at the Avedia site, in Saldanha Bay

Tank capacity is 500m³ and diameter is 5600mm. The contractor must install a submersible pump into the tank and make any necessary modifications to the tank.

The contractor will be required to clean the tank to the satisfaction of the appointed AIA and gas free it. After the tank has been inspected by the AIA, the contractor is to install into the tank, if available, a supplied submersible pump. Into one of the top flanged inlet pipes is to be enlarged from 4" to 5".

The Hot work that will be necessary and any possibly repairs are to comply with clause 16 of the Vessels Under Pressure Regulations.

There after the tank is to be pressure tested and passed by the AIA. The tank will then be brought back into service by the contractor and site staff.

ANNEXURE 4

Certificate of Independent Bid Determination (SBD 9)

- 3.1. This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
- disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.

Bid rigging is, therefore, an agreement between competitors not to compete.
