**BACKGROUND**

Johannesburg City Parks and Zoo (JCPZ) currently has backup and recovery solution contract that is currently running that is soon coming to end, does the reason we are looking for new contract for a similar service, JCPZ has embarked on a process of improving the backup and recovery environment in order to enable business continuity management (BCM) and to support the business continuity plan of ICT, and as such JCPZ is in need of a service provider to supply and configure the end-to-end Enterprise Backup and Recovery solution. - To allow for seamless **integration** into JCPZ 's virtualization infrastructure;

- To optimize backup processes in line with business and ICT continuity strategies.

## OBJECTIVES
