3. Quotations received will be evaluated firstly on pre-compliance evaluation, then on functionality evaluation (**IF APPLICABLE**), and thereafter 80/20 point scoring basis. The 80 points will be for price and 20 points for preferential procurement specific goals.
4. No quotation will be considered from service providers employed by the state.
5. **Quotations should be valid for a minimum period of 120 days from the date the RFQ closed.**
6. All prices quoted must be VAT inclusive, service providers not registered for VAT must indicate this clearly on their quotation. For VAT vendors, if no indication is provided quotations will be evaluated as VAT inclusive.

REQUEST FOR PROPOSALS:

The Department of Trade, Industry and Competition (**the dtic**) invites interested service providers to submit proposals for the delivery of occupational health services to **the dtic** employees and its COTTI's for the duration of three (3) years.

NOTE: Should a vendor have reason to believe that the specification / Terms of Reference are not open to promote competition or that it is written based on a particular brand / product / entity; the vendor shall notify the Bid Office of **the dtic** within ten (10) calendar days after publication of the bid.

1 PURPOSE

- 1.1 The purpose of the project is to obtain the services of a service provider to provide the services of an Occupational Health Nursing Practitioner on a need basis for a period of three (3) years.

2 BACKGROUND

- 2.1 The QWL office is housed in the Employee Wellness Centre (EWC) and consists of an Occupational Health Clinic rendering primary and occupational health care services. The purpose of the Occupational Health Clinic is to assist employees in early identification through diagnosing and treating primary health care conditions, provide treatment and to refer to specialists where needed. **the dtic** Occupational Health Clinic employs an Occupational Nursing Practitioner on its payroll establishment as well as an Admin Assistant.
- 2.2 Since the resident Occupational Nursing Practitioner is the only qualified Occupational Nurse in the Occupational Health Clinic, it has become a necessity to have a Locum Primary and Occupational Health Nursing Practitioner on a need basis for when **the dtic's** Occupational Health Nursing Practitioner is out of office.
- 2.3 **the dtic** is therefore interested in entering into an agreement with a service provider who could provide a Locum Health Nursing Practitioner on a need basis. It is therefore important that QWL seek the services of a Primary and or Occupational Health Nursing Practitioner(s) on a locum basis with the appropriate expertise and competencies to render Primary and Occupational Health Services to employees at **the dtic** Occupational Health Clinic. The Locum Health Nursing Practitioner will be provided with all the necessary medical equipment, tools as well as primary health medicine to render an effective health care service.
- 2.4 The successful bidder(s) will enter into a Service Level Agreement (SLA) with **the dtic** and should **the dtic** need a Locum Health Nursing Practitioner, the SLA will be implemented. The successful bidder(s) should be able to provide services of a Locum Health Nursing Practitioner within 24 hours of receiving the request.

3 OBJECTIVES

- 3.1 The objectives of the assignment are to provide locum nursing services within 24 hours of receiving the request.
 - 3.1.1 Consistently provide an environment that promotes an environment that ensures effective and efficient service delivery through the provision of the health and wellness programmes.
 - 3.1.2 Ensure consistent primary and occupational health services to **the dtic** employees at all times.
 - 3.1.3 Minimise the potential health risks posed by the vacuum in occupational health services in the QWL.
 - 3.1.4 Provide immediate services in response to any pandemic that will affect South Africa.

4 SCOPE OF WORK

- 4.1. At any given time, when the services of an Occupational Health Nursing Practitioner are requested and the main resources are not available, the service provider must supply **the dtic** with the Locum Professional Occupational Health Nursing Practitioner together with the proof of the following requirements within 24 hours of receiving the request. The successful service provider will be responsible for the delivery of the following milestones:
 - 4.1.1 Conduct consultations, examine patients, treat and refer to the Occupational Medical Practitioner or to external health services.
 - 4.1.2 Record findings in medical files daily and maintain confidentiality.
 - 4.1.3 Manage chronic conditions daily, educate and advise on treatment as well as healthy living.
 - 4.1.4 Monitor environmental health and safety.
 - 4.1.5 Attend to first aid and emergencies.
 - 4.1.6 Report all incidences and accidents to OHS officer.
 - 4.1.7 Support health programmes and events. e.g. HIV and AIDS Day, TB, STI, SANBS, comorbidities, Cancer support group, and GEMS health screening etc.
 - 4.1.8 An ability to self-manage and work independently.
 - 4.1.9 Provide daily and weekly statistics based on consultations.
 - 4.1.10 Arrange and conduct health talks and presentations.
 - 4.1.11 Pandemic response functions:
 - a) Be responsible for monitoring and assessing the risk;
 - b) Provide health screening through thermos-scanning, questionnaires of signs and symptoms of related illnesses;
 - c) Keep records and file the stats of the findings electronically;

- d) Refer suspects to external health medical facilities for further management and record the findings;
- e) Educate employees on the related subject regarding prevention and promotion of good health.

4.2 The service provider will be responsible for the following logistical arrangements:

4.2.1 Parking, travel and accommodation between the prospective service provider's office and **the dtic** will be borne by the service provider

5 DELIVERABLES

- 5.1 Reporting; capture the stats on a daily basis and produce reports electronically
- 5.2 Monthly and quarterly project reports; health talk sessions, articles, and events.

6 QUALIFICATIONS, EXPERIENCE AND EXPERTISE

6.1 Prospective service providers must have:

- a) A minimum of three (3) years' experience in providing staffing solutions.
- b) A minimum of two (2) years' experience in providing primary and occupational health care locum nurses as part of their staffing solutions.
- c) Proof of delivering similar projects (providing primary and occupational health care locum nurses) i.e. Reference Letters with contact details from three (3) customers where similar projects were implemented. Reference must include scope and quality of services rendered.

6.2 At any given time, when the services of an Occupational Health Nursing Practitioner are requested and the main resources are not available, the service provider must supply **the dtic** with the ***Locum Professional Occupational Health Nursing Practitioner together with the*** proof of the following requirements within 24 hours of receiving the request:

- a) National Diploma in Nursing or/and Bachelor's degree in Nursing, qualification in Primary and or Occupational Health Nursing;
- b) At least one (2) years' experience as an Occupational Health Nursing Practitioner supported by at least one reference when required; and
- c) Proof of qualifications and registration with the South African Nursing Council as well as having a dispensing licence.

6.3 Prospective service provider must submit :

- a) Certified ID copy of one main Occupational Nursing Practitioner;
- b) Certified copies of the National Diploma in Nursing or/and Bachelor's degree in Nursing, qualification in Primary and or Occupational Health Nursing of the Occupational Nursing Practitioner;

- c) Minimum of two (2) years experience as a Primary and or Occupational Health Nursing Practitioner supported by at least one reference;
- d) Certified copy of registration with the South African Nursing Council; and
- e) Certified copy of the dispensing licence.

NB: In cases where the services of the Occupational Nursing Practitioner are needed and the Occupational Nursing Practitioner provided is not available, the service provider must provide the Occupational Nursing Practitioner with the same qualifications and/or higher.

the dtic reserves the right to vet all documentation and information provided by bidders to prove their relevant experience and ability to perform the service.

7 DUE DILIGENCE

- 7.1 The bidder must have current technical and logistical capacity to perform the work required. **the dtic** reserves the right to perform due diligence on facilities, resources and capacity of a bidder prior to the appointment of a service provider.

8 SPECIAL CONDITIONS

- 8.1 A Service Level Agreement must be signed with the successful bidder before work commences. A contractual relationship will only commence once a Service Level Agreement is signed between the parties.
- 8.2 Proposed key staff members must participate actively and be available to perform services in accordance with the contract. In instances where a proposed key staff member is not available to perform services at a specific period in time, the bidder will be responsible to provide a replacement with similar qualifications and experience in order to guarantee the same standard of work to **the dtic**. Each team member's role must be clearly outlined in the project plan.
- 8.3 A project plan detailing the tasks, activities and target dates for the work to be undertaken should be submitted to **the dtic** within 10 working days after appointment of the successful Service Provider. Each team member's role must be clearly outlined in the project plan;
- 8.4 As previously indicated **the dtic** reserves the right to vet all qualifications and other documentation provided by bidders to prove relevant qualifications, experience and expertise prior to the appointment of a Service Provider;
- 8.5 Copyright and intellectual property rights to all documentation, reports etc. that emanate from this assignment will vest with **the dtic**.
- 8.6 This bid and all contracts emanating there from will be subject to the General Conditions of Contract issued in accordance with Treasury Regulation 16A published in terms of the Public

Finance Management Act, 1999 (Act 1 of 1999). Special Conditions of Contract are supplementary to that of the General Conditions of Contract. Not all bids will contain special conditions of contract. Where, however, the Special Conditions of Contract are in conflict with the General Conditions of Contract, the Special Conditions of Contract prevail.

- 8.7 Bids received after the closing date and time, at the address indicated in the bid documents, will not be accepted for consideration and where possible, be returned unopened to the bidder.
- 8.8 Bidders' attention is drawn to the fact that amendments to any of the Bid Conditions or setting of counter conditions by bidders may result in the invalidation of such bids.
- 8.9 The State reserves the right to conduct supplier due diligence prior to final award or at any time during the contract period. This may include site visits.
- 8.10 The Bid Office Officials of **the dtic** may communicate with bidders where clarity is sought after the closing date of the bid and prior to the award of the contract, or to extend the validity period of the bid, if necessary.
- 8.11 All communication between the bidder and the Bid Office Officials of **the dtic** must be done in writing.
- 8.12 Bidders must ensure that they are registered on the Central Supplier Database of the National Treasury as this is compulsory with effect of 1 April 2016 in order for bidders to be considered for bids.
- 8.13 Bidders must ensure that their tax matters are in order in line with the Preferential Procurement Policy Framework Act and the Treasury Regulations.
- 8.14 Bidders' whose tax matters are not declared to be in order will be disqualified.
- 8.15 Bidders' attention is drawn to the tax requirements stated on the SBD 1 form.
- 8.16 Where applicable acceptance of a bid will be subject to the condition that both the contracting firm and its personnel providing the service must be cleared by the appropriate authorities to the level of CONFIDENTIAL/SECRET/TOP SECRET (whichever one is stipulated in the relevant specification / ToR). Obtaining a positive recommendation is the responsibility of the contracting firm concerned. If the principal contractor appoints a subcontractor, the same provisions and measures will apply to the subcontractor. Acceptance of the tender is also subject to the condition that the contractor will implement all such security measures as the safe performance of the contract may require." (Minimum Information Security Standards. Chapter 5).
- 8.17 The points scored for functionality, price and specific goals will be rounded off to the nearest 2 decimals as determined in the PP Regulations 2022.
- 8.18 In cases where the tender invitation is subject to a pre-qualification requirement based on sub-contracting, then it is the responsibility of the tenderer to select competent sub-

contractors that meet all the requirements of the tender in order to ensure that the bidders tender is not jeopardized by the subcontractor during evaluation. Bidders are responsible for all due diligence on their subcontractors.

- 8.19 In cases where above market related prices are quoted the right is reserved to negotiate with the three preferred bidders (three highest on final points for price and Specific goals).
- 8.20 Bidders to take note that the award of the tender may be subject to price negotiation with the preferred bidder.
- 8.21 This bid is subject to the PPPFA and its Regulations.
- 8.22 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 8.23 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 8.24 Bidders must submit concrete proof of the existence of joint ventures and/or consortium arrangements. **the dtic** will accept signed agreements as acceptable proof of the existence of a joint venture and/or consortium arrangement.
- 8.25 The joint venture and/or consortium agreements must clearly set out the roles and responsibilities of the Lead Partner and the joint venture and/or consortium party. The agreement must also clearly identify the Lead Partner, who shall be given the power of attorney to bind the other party/parties in respect of matters pertaining to the joint venture and/or consortium arrangement.
- 8.26 Regulation 13 (c) of the Public Service Regulations 2016 determines that an employee shall not conduct business with an organ of state or be a director of a public or private company conducting business with an organ of state unless such employee is in an official capacity a director of a company listed in schedule 2 and 3 of the Public Finance Management Act. **As this regulation prohibits public service employees from conducting business with an organ of state; either in a personal capacity or as a director of a private or public company, non-compliance with this regulation will lead to automatic disqualification of a bid.**

the dtic reserves the right:

- 8.27 To award this tender to a bidder that did not score the highest total number of points, only in accordance with section 2(1)(f) of the PPPFA (Act 5 of 2000).

- 8.28 To negotiate with one or more preferred bidder(s) identified in the evaluation process, regarding any terms and conditions, including price without offering the same opportunity to any other bidder(s) who has not been awarded the status of the preferred bidder(s).
- 8.29 To accept part of a tender rather than the whole tender.
- 8.30 To carry out site inspections, product evaluations or explanatory meetings in order to verify the nature and quality of the services offered by the bidder(s), whether before or after adjudication of the Bid.
- 8.31 To correct any mistakes at any stage of the tender that may have been in the Bid documents or occurred at any stage of the tender process.
- 8.32 To cancel and/or terminate the tender process at any stage, including after the Closing Date and/or after presentations have been made, and/or after tenders have been evaluated and/or after the preferred bidder(s) have been notified of their status as such.
- 8.33 Award to multiple bidders based either on size or geographic considerations.
- 8.34 Bidders will be allowed to submit queries or request clarification up to one week prior to the closing date of this bid. Thereafter no queries / clarification requests will be responded to.

9 PRICE

- 9.1 Bid prices are required in the form of hourly rates. The bid price must represent hourly rates of the project leader and key team members allocated to **the dtic**. Three fixed hourly rates, one for each year of the contract period, for each key team member and the project leader is required. Payment based on hourly rates will be payable by **the dtic** to the successful Service Provider upon satisfactory work delivery, in accordance with an agreed payment schedule which will be linked to set deliverables. Please see the attached SBD 3.3 on how pricing must be quoted. The average hourly rate will be used for price comparison purposes in the 80/20 point system
- 9.2 The bid price must be inclusive of VAT and quoted in RSA currency.
- 9.3 Consultants will only be remunerated in accordance with the cost containment measures determined by National Treasury:

- 9.3.1 The rates as determined in the “guidelines for fees”, issued by the South African Institute of Chartered Accountants (SAICA); or
- 9.3.2 The rates as set out in the “Guide on Hourly Fee Rates for Consultants”, by the Department of Public Service and Administration (DPSA); or
- 9.3.3 The rates as prescribed by the body regulating the profession of the consultant; e.g. Law Society of South Africa. Proof of the latest approved rates should be attached to the pricing SBD 3.3;

TRAVEL AND ACCOMMODATION REQUIRED FOR THE PROJECT

- 9.4 Travel and accommodation required for the project will be approved in line with the maximum allowable rates issued by the National Treasury.

10 the dtic OBLIGATIONS

- 10.1 the dtic** Project Manager will serve as the contact person on all matters relating to the project;
- 10.2 the dtic** Project Manager will review, evaluate and approve the services provided by the Service Provider against the Service Level Agreement on an ongoing basis and prior to payment is made;
- 10.3 the dtic** will supply all reasonable, relevant, available data and information required and requested by the Service Provider for the proper execution of the services and such assistance as shall reasonably be required by Service Provider in carrying out their duties under this contract.

11 SERVICE PROVIDER’S OBLIGATION

- 11.1 The Service Provider undertakes to act as an independent contractor in respect of the work;
- 11.2 To work closely with the Project Manager responsible for the project in **the dtic**;
- 11.3 Attend meetings when required by the Project Manager for the purposes of obtaining information or advice with regard to the work and assignments or any matters arising from or in connection therewith;
- 11.4 The Service Provider will be responsible for its own computers and technical literature to adequately perform all the functions;
- 11.5 The Service Provider must exercise all reasonable skill, care and diligence in the execution of the work and shall carry out their obligation in accordance with professional standards;
- 11.6 The Service Provider must in all professional matters act as a faithful advisor to **the dtic**, as well as respecting the laws and customs of any country and provinces in which any business in relation to the project is conducted;

- 11.7 All information availed to the Service Provider in the course of the project must be deemed confidential and will remain the property of **the dtic**;
- 11.8 The Service Provider will be required to sign a confidentiality declaration form, undertaking to keep all the information at his/her disposal as a result of being awarded the contract by **the dtic** strictly confidential;
- 11.9 The Service Provider must not disseminate any information gathered during the conduct of the project, publicize or release media statements in relation to the assignment;
- 11.10 Any information gathered during the conduct of the assignment is the property of **the dtic** and may not be distributed without prior written approval of **the dtic**;
- 11.11 The Service Provider will be deemed to have been satisfied as to the correctness and sufficiency of the rates and prices set out in their bid for the services to be rendered;
- 11.12 The Service Provider must plan and provide for all possible risks that may affect the delivery of the project on time and indicate what mechanisms are in place to manage such risks.

12 BID EVALUATION CRITERIA

- 12.1 The 80/20 principle and **two envelope / file system** will apply in evaluating the proposals in accordance with the latest PPP Regulations pertaining to the Preferential Procurement Policy Framework Act; Act no 5 of 2000. The reason for applying the **two envelope / file system** is to ensure that price does not influence the evaluation of the functional proposals.

12.2 Two envelope system

- 12.2.1 The two envelope system is based on the submission of the functional and financial proposals in two separate envelopes / file. NO financial information may be contained in the functional envelope as this will lead to automatic disqualification. Submission must be done as follows:

12.3 Functional proposal:

- 12.2.2 Bidders who wish to claim for preferential procurement points applicable to this TOR must ensure that the SBD 6.1 claim form is completed and accompanied by the relevant proof required.

Financial information in a functional proposal will lead to automatic disqualification of that specific proposal.

12.4 Financial proposal:

12.4.1 The financial proposal (SBD 3.3) must be submitted in a **SEPARATE** sealed envelope / file / email with the name of the bidder, closing date and time and the bid number clearly indicated on the envelope / file / email to **FinancialProposals@thedtic.gov.za**.

12.5 FAILURE TO COMPLY WITH THE TWO ENVELOPE / TWO FILE REQUIREMENT WILL AUTOMATICALLY INVALIDATE A BID.

12.5.1 All proposals will be evaluated in terms of the two phase process once the pre-qualifying of bids received is done. All bid proposals received are subject to a pre-qualification process to determine compliance with compulsory requirements / conditions.
