### FRAMEWORK AGREEMENT: IDT-KN.RFQ-24.DOE-001

FRAMEWORK CONTRACT FOR THE SUPPLY OF NEW MOBILE CLASSROOM UNITS, MOBILE SOUP KITCHENS AND RELOCATION OF MOBILE CLASSROOMS & SOUP KITCHEN UNITS IN KWAZULU NATAL PROVINCE FOR A PERIOD OF 36 MONTHS.

The Independent Development Trust (IDT) hereby invite reputable and experience bidders to submit bids for the supply of new Mobile Classroom units, relocation and repairs of Mobile Classroom unit and Mobile Kitchens units to various schools across the KZN province for a period of 36 months.

#### STAGE 1: ELIGIBILITY CRITERIA

Tenderers must meet the following mandatory requirements in order to be considered for this bid:

1. Proof of National Treasury Central Supplier Database (CSD) registration. Bidder will be required to have compliant status at the time of appointment.
2. Compensation for Occupational Injuries and Diseases Act (COIDA Certificate) Or the Federated Employers Mutual (FEM Certificate) or Rand Mutual Assurance (RAM certificate).
3. Fully signed and Completed all Standard Bid Documents (SBD) forms (SBD 1; 4; 6.1 and 7.1)
4. Completion of form of offer in the tender document in full
5. Completion of Bills of Quantities in full.
6. Copy of the Joint venture agreement signed by both parties (where applicable).
7. Signed authority to sign on behalf of the bidding entity (i.e. Signed by the company director).
8. Proof of existing manufacturing facility and warehouse accompanied by physical address with lease or ownership. agreement in place for a manufacturing site.
9. Proof of ownership or lease of panel manufacturing equipment and machines.

Only bidders who passed all the above mandatory requirements will be considered for functionality evaluation stage.

#### FUNCTIONALITY EVALUATION

Bidder will be evaluated on functionality as follows:

Relevant Experience on similar projects	35
Client Reference Letters on similar projects	20
Proof of truck flatbed ownership or lease agreement or rental agreement	20
Detailed project programme schedule/ lead time/turnaround time schedule	15
Financial Viability	10
<b>TOTAL ALLOCATED POINTS</b>	<b>100</b>

Only bidders who obtained minimum of 70% under functionality evaluation will be considered for price and preferential points evaluation.

The 90/80 or 10/20 Preferential Point System will be applied as per PPPFA regulation of 2022, where 90/80 points will be allocated for price and 10/20 points for Specific Goals Status. In order to Claim and be awarded Specific Goals points bidders must submit evidence as stipulated under SBD 6.1 in the bid document. Where necessary, IDT may enter into price negotiations with some or all recommended bidders to ensure appointment is based on market related rates.
