## **Scope of work/Works Information/Employers Requirements**

The scope of work shall be derived from Category C all-inclusive security services, for the purpose of the coal automation system (CAS), specifically Armed Security escorting.

Armed Grade C security officers for vehicle patrols and escorts for Eskom employees/contractors/service providers deployed in high-risk areas or performing high risk tasks (as determined by the business risk assessment).

The security service applicable to this contract, shall comprise of the escorting of CAS Eskom Team by fully accredited and trained armed Security Escort officers, associated equipment and vehicles, during and after hours in high-risk identified, but not limited to 10 Generation Power Stations and their associated mines, as per the security risks and threats identified. The List of Power stations and Mines are as per the Annexure 1. Upon execution the teams will be based in the local towns closest to the project.

## **NATURE OF SERVICES TO BE PROVIDED**

- The services shall include the armed escorting of the CAS team, the armed escorting team shall be required to meet the Eskom employees at an Eskom site (MWP and Duvha Power Station) or predetermined place, escort, protect and monitor the Eskom employees for the required period on site, and safely return the employees to the predetermined drop off point.
  - The armed security officers are to travel in their own company vehicle and provide protection to the Eskom employee/s.
- The service will be required on an, as and when required bases, as per the identified security threat condition. A 48-to-72-hour notice to the Security service provider will be given, to ensure the availability of sufficient armed escorting personnel and vehicles. Requests be made by the duly appointed CAS Project Manager.
  - Reimbursed for the kilometers incurred in providing this service. The reimbursable kilometers are as per the AA rate and/or context included in the fixed priced of the vehicle as per the contract terms.
- The armed escort team/s must be in constant contact with a security contractor's control room for regular reporting and to obtain assistance when needed. A proper register must be kept at the security contractor's control room containing situation reports, incident reports and any communication with the armed escort team.
- The armed escort team must do the escorting in a tactically sound manner:
  - Possible ambush positions must be secured before the Eskom members being escorted are allowed to proceed through the position.
  - When the site where the Eskom members are to perform their duties is reached, the armed escort team needs to secure the area before the Eskom employees commence

- The armed escort must take up a position for all round defense of the area where the Eskom employees are working and be constantly vigilant and conduct situation awareness.
- Each armed response vehicle must be equipped with a minimum of two Grade C, fully trained and equipped armed escort officers at all times when service is rendered (driver and crew).
- The CAS team will utilize 1 – 4 vehicles to travel on any given day, all vehicles to the same site on the day, or different vehicles dispatching to different sites on any given day. The team member that will frequent the site is as follows: 4 x supervisors (permanent upon execution), 1x Construction Manager (rotating around the PS during execution), 1 x Project Manager, 1x Contracts Manager, 2x SHEQ, 2x QS, and 7x Engineering Technical Leads
- Depending on the daily need between 2 to 8 fully trained & equipped armed escort officers and 1-to-4-armed response vehicles will be required.

Example:

- CAS team travelling in 1 to 3 vehicles to the same site per day, requirement 1 x fully equipped armed response vehicle with 2 x fully trained armed escort personnel.
- CAS team travelling in one or more vehicles to different sites, requirement 1 x fully equipped armed response vehicle with 2 x armed escort officers per CAS vehicle travelling. Only applicable when CAS vehicles are not travelling in the same direction and to different sites.
- A road worthy all-terrain vehicle, 4x4 (4 door) suited for the terrain where Eskom employees will be travelling to.
  - The vehicle must be equipped with a first aid kit and fire extinguisher.
  - All armed escort vehicles shall be equipped with a local global positioning system or Satellite Surveillance or any other system that would assist them.
  - Vehicle contingency plan: The contractor shall have contingency plans in place to react immediately to any emergency request, vehicle breakdowns and vehicle accidents.
  - A valid fuel card for repairs, fuel, and toll-fees.
