



**TENDER NOTICE AND INVITATION TO TENDER

**South African National Parks** invites prospective bidders for the **Renovations of 10 Chalets in Addo Rest Camp at the Addo Elephant National Park, Eastern Cape Province.**

The following tenderers who are registered with the CIDB, or are capable of being so registered prior to the evaluation of submissions are eligible to submit tenders:

- Contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations, for a **4 GB** or **3 GBPE** or **Higher** rating of construction work, are eligible to have their tenders evaluated.
- Joint ventures are eligible to submit tenders provided that:
  - (i) Every member of the joint venture is registered with the CIDB;
  - (ii) The lead partner has a contractor grading designation in the **4 GB** or higher class of general building construction work; and
  - (iii) The combined contractor grading designation calculated in accordance with the Construction industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a **4 GB** class of general building construction work or a value determined in accordance with Regulation 25 (1B) of 25(7A) of the Construction Industry Development Regulations

Tenderers are informed that a contract participation goal is included for sub-contracting of local EME's and QSE's that are 51% black owned.

SANParks has identified the following specific goals to advance the categories of persons as part of its procurement processes:

• Bidders that are located with <u>Sarah Baartman District Municipality</u>	10
• Bidders that located outside the borders of Sara Baartman District Municipality but within the <u>Eastern cape Province</u>	8
• Bidders located <u>outside of Eastern Cape Province</u>	0

**Important Notes:**

- A “zero” score will be applied if Tenderers does not qualify for any of the above mentioned “specific goals”.
- The Tender will not be disqualified if any of the two “specific goals” mentioned above are not met.

This tender will include functionality as part of the evaluation criteria, tenderers shall further be required to satisfy the following functionality (quality) criteria and be required to demonstrate their ability to undertake the work and to provide proof of experience, expertise and personnel to undertake work of this nature. Tenderers are required to score a minimum of **17 points out of a possible 24 points (70%)** in order to be responsive. Tender Data, of the proposed functionality criteria and point system for evaluation with points being awarded in accordance with the following provisions:

- a) General Building Construction Experience (maximum 12 points)
- b) Technical Expertise and Competency (maximum 12 points)
