1.1 DESCRIPTION OF SERVICE: SUPPLY AND DELIVERY OF AN UPRIGHT 92-93L BAR FRIDGE

BACKGROUND:

A small bar fridge is required for PCR products, DNA, PCR reagents and lab consumables (chloroform, isopropanol, ethanol, isoamyl alcohol, potassium acetate etc.) for molecular identification of fungi. These reagents and chemicals must be kept separate from plant material (contamination risk), food (safety, health risk) and fungal cultures (contamination). Therefore, a separate designated bar fridge is needed for the molecular lab to ensure accurate and reliable results

PURPOSE

Bar fridge is essential to store PCR products and molecular-based consumables for researchers engaged in molecular work that are dependent upon DNA and RNA extraction for PCR and qPCR.

Supply, and delivery of a 92-93L up-right bar fridge to the ARC Nietvoorbij Plant Protection division on the corner of R44 and Helshoogte road, Stellenbosch
