#### 1. Introduction

The Agricultural Research Council (ARC) invites quotations from qualified and suitably accredited service providers to submit proposals for the authentication of baby hamster kidney cell line and testing thereof for listed extraneous agents. The master cell stock is stored in 1.8 mL glass ampules with a concentration of approximately  $2.0 \times 10^6$  cells/mL and viability of approximately 90-100 %. This material is proprietary to ARC and must not be reproduced for commercial purposes. A Material Transfer Agreement (MTA) with ARC will be signed with the successful service provider prior to the release of any material.

## 2. Scope of Services

A suitably accredited service provider will conduct Good Manufacturing Practice (GMP) compliant cells authentication and extraneous agents testing as per U.S. FDA (Food and Drug Administration), European Medicines Agency (EMA), and/or UK's Medicines and Healthcare products Regulatory Agency (MHRA). The tests required shall include:

Species identification [Short Tandem Repeat (STR) profiling] of the two cell lines, i.e., Baby Hamster Kidney (BHK-21) clones 13 and 38 cell lines used for vaccine preparation and quality control tests.

Testing of extraneous agents of the two cell lines, to include:

- i. Blue tongue virus (BTV),
- ii. Bovine adenovirus (BAdV),
- iii. Bovine respiratory syncytial virus (BRSV),
- iv. Reovirus,
- v. Rabies virus,
- vi. Bovine viral diarrhea virus (BVDV),
- vii. Bovine coronavirus (BCV),
- viii. Bovine parainfluenza virus-3 (BPiV3),
- ix. Bovine herpesvirus (BHV)
- x. Hamster Antibody Production (HAP) test

# **Deliverables**

The successful service provider must deliver:

- Provide a destruction certificate for all cell lines provided, including cultivation media, as per MTA.
- Authentication outcome and certificate and detailed analysis report
- Test report for all the listed extraneous agents' outcomes
- Notification of any discrepancies or contamination
- A GMP/ISO compliant Certificate of Analysis for each tested cell line.

# **Functionality scoring**

With regard to technicality / functionality, the following criteria are applicable. Bidders must score a minimum of 80% (80 points) for Quality and Functionality in order to move on to the next stage of evaluation. The maximum points of each criterion are indicated in the table below:

- 6. All price quotations that have a rand value of R 2,000.00 to below R 50,000,000.00, including VAT, will be evaluated by applying the 80/20 principle as prescribed by the Preferential Procurement Policy Framework Act 5 of 2022 and its Regulations.

# PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

### 2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
