iThemba LABS requires the design of a logo for the Southern African Institute of Nuclear Science and Technology.

Background:

The Southern African Institute for Nuclear Technology and Sciences (SAINTS) is housed at the iThemba Laboratory for Accelerator Based Sciences (iThemba LABS). It aims to contribute to the growth, training and expansion of a scientific and technically competent workforce to drive and sustain advancements in accelerator-based science and technology. This is achieved through the provision of excellent education, training and practice opportunities in partnership with higher education institutions.

i.e. Empowerment through education, training and practice

The mission of SAINTS is to deliver a world-class training programme in particle accelerator technology and associated radiation sciences in order to sustainably develop human resources in the Sciences,

Engineering and Technology (SET) sector in South Africa and, more generally, in Southern Africa and the rest of the African continent.

Some of the key aims and objectives of SAINTS are the improvement of the throughput of postgraduate students linked to research at iThemba LABS, the improvement of research outputs (such as dissertations, publications and presentations) by students and staff at iThemba LABS, and enhancing the general research/supervision skills and specialised research-related knowledge of students and staff.

1. Requirements:

- 1.1. The logo must be copyrightable by iThemba LABS.
- 1.2. The logo should be consistent with the SAINTS brand and its service category.
- 1.3. The target audience will be higher education institutions, international laboratories and postgraduate students. For that reason, the logo should be eye-catching and exciting, but still capture the seriousness of the overall mission of SAINTS.
- 1.4. The logo should be easily recognisable so that when seen, the SAINTS brand and associations are immediately called to mind.
- 1.5. The logo should be unique and not trend focussed or reminiscent of any other brands.
- 1.6. The logo should be timeless.
- 1.7. The logo must be scalable.
- 1.8. The logo design must take into account that the logo will be used in a variety of contexts, e.g. websites, social media (Twitter, LinkedIn, Facebook, and Instagram) and documentation, etc. so we require multiple versions of the logo that can be used effectively in each context. This includes a design of a favicon.
- 1.9. A brand style guide that covers the specifications of the usage of the logo across different media must be provided.
- 1.10. The logo must be made available in various scalar and vector formats (.png, .svg, .pdf, .ai, .jpg).
- 1.11. A version of the logo must still look good in black and white or grayscale.
- 1.12. If a white background is incorporated into the logo design, versions of the logo with the white background as well as with a transparent background must be provided.

2. General remarks re: the submission from the supplier

- 2.1. The billing for this logo design should be done on a per-project basis and not on an hourly basis since the quote from the successful supplier will be accepted by iThemba LABS in its entirety before work can begin. Thereafter, only small deviations from the quoted values are acceptable but this is not desirable.
- 2.2. An estimate of the time-to-deliver must be indicated in the submitted documentation.

- 2.3. The submitted quote must consider the back-and-forth interaction between iThemba LABS and the supplier so that the design can be reviewed and revised/adapted to achieve the final product. Please specify the number of revisions that will be included in the quoted amount.
