Where it appears that the supplier is not executing the contract in accordance with the true intent and meaning thereof, or that he/she is refusing or delaying to execute the contract or that he/she is carrying on the work at such rate of progress as to ensure delivery by the “date of delivery” that the time has expired within which delivery should have taken place, general poor performance or in the event of any other failure or default or has misrepresented information provided, JCPZ shall:

## REQUEST FOR QUOTATION

### DESCRIPTION: APPOINTMENT OF SUTABLE SERVICE PROVIDER (1) FOR THE JCPZ' s

### SECURITY RISK ASSESSMENT FOR 110 SITES IN OUR OPEN SPACES & OFFICES AND DEPOTS

1. **Purpose: Appointment of suitable service provider/s for the JCPZ's Security Risk Assessment (110 Offices Depots & Some Open Spaces)**

The Security sub-unit at Facilities Management would like to request that the Supply Chain Management services assist with the appointment of potential and accredited service providers through a tender system.

Security Assessments are an excellent way to evaluate your existing security program and a great first step to take prior to making security improvements at your facility or when trying to solve a specific security problem. During a Security Assessment, all aspects of your security program are examined, any weaknesses are identified, and suggestions for security improvements are made. In addition, opportunities where costs can be reduced or where security operations can be made more efficient are identified. This assessment process is constantly evolving, allowing us to take advantage of lessons learned from previous assessments, and to keep up with the latest security best practices.

The Security Assessment uses a structured, formal analysis process that allows us to develop a deep understanding of your business, operating conditions, corporate culture, and unique security risks and threats. The successful bidder will have to involve JCPZ every step of the way in their risk assessment, keeping the project on track, and making sure that all important elements are examined. The SCM tender process is being activated to ensure that we comply with the MFMA stipulations.

The Security Assessment is custom tailored for each project, with three categories (Identification, Evaluation & Controls) but typically includes the following tasks:

- Risk identification and analysis
- Review of site and facility security
- Analysis of crime data including loss history, police calls for service, crime statistics, and crime forecast reports.
- Review of facility operating procedures
- Review of physical security systems
- Review of electronic security systems (biometrics, alarms, cloaking, cctv....)
- Review of security personnel(effectiveness)
- Evaluation of present security program and identification of any weaknesses and vulnerabilities
- Development of recommendations for security improvements

- Identification of short-term and long-term costs
- Prioritization of recommendations and development of implementation plan
- Preparation of written Security Assessment Report
- Recommendation of Mitigation Strategies

## 2. Exclusions:

- IT data centers security

### **Conduct Security Risk Assessment:**

The following is a brief outline of the typical assessment process:

1. The prescribed methodology on how the assessment will be carried out is listed expanded on below and must occur between 8am and 3pm.
2. Prior to coming to your site, we will request a number of documents for our use during the assessment. These typically include plans of the site and buildings, copies of any existing security policies and procedures
3. Identify the people within your organization that we would like to interview. The goal is to get a good cross-representation of all of the major operating and support departments within your organization. Typically, this would include members of senior management (CEO, CFO, CIO, etc.) , department heads, and people who occupy roles which are directly related to security, such as building receptionist's, security officers, and shipping/receiving personnel. The typical interview session lasts between 30 and 45 minutes.
4. For each site conducting an in-depth interview with the person who presently serves as "security manager" or highest ranking officer for the facility. This may be an actual security manager, or may be the facilities manager or other person who manages the security function for the organization. This interview session covers a lot of details, and typically takes 1-2 hours. After this interview, we ask this person to give us a brief guided tour of the facility.
5. Conducting individual interview sessions with each of the employees identified in Step #2 above. Depending on the size of the organization, this process could take one, two, or more days.
6. At the conclusion of the interviews, conduct detailed inspections of certain areas of the facility and site. Spend extended periods of time observing certain areas of your facility, such as the building, offices, depots and open spaces.
7. Observe facilities at night, and to get a general feel for the neighborhood during the hours of darkness.
8. Offer some preliminary findings and recommendations, using the data gathered.
9. During this process, identify critical assets, analyze potential threats, review loss history, study crime forecasts for your site, evaluate existing security measures, and identify potential weaknesses and areas for improvements. At the conclusion of this process, write the Draft Security Assessment Report (between two and three weeks from the time site visits are completed).
10. Conduct additional interviews or to examine certain things more closely.
11. When the draft Security Assessment Report is completed, give JCPZ opportunity to digest the document and respond to any of your questions or comments.
12. After obtaining JCPZ's input, prepare a final Security Assessment Report that incorporates your comments and make a formal presentation of the Security Assessment Report to your senior management team or others.

13. At the conclusion of the assessment process, the successful bidder must remain available to assist you with implementation of the recommendations contained within the final report. This can include identifying vendors and sources of products and services, reviewing bid proposals, developing security policies and procedures, providing training, and assisting in other ways.
