**1. Introduction**

Elias Motsoaledi Local Municipality requests the proposals from experienced service providers for supply and erect of precast concrete palisade for fencing of Ntwane cemetery.

**2. Executive summary**

Elias Motsoaledi Local Municipality in the 2024/25 financial year budget has prioritized capital projects. Amongst other projects that are prioritized is the project that is serving on this Bid document classified as follows: Appointment of contractor for fencing of Ntwane Cemetery (Ward 10)

**2.1. Labour intensive based construction**

Municipality expect the successful bidder to apply innovations on maximizing applications of labour-intensive methods without compromising quality standard of the work. The municipality has estimated sufficient maximization of local labour components that were identified are but not limited to: -

- Site clearance
- Supply, digging and erection of 25mpa concrete palisade fence for 400 meters' x 1.8m height

**2.2 Quality control and quality Assurance**
