TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER FOR GRAP WORKSHOP

1. BACKGROUND

The South African Diamond and Precious Metals Regulator (SADPMR) is a Schedule 3A PFMA entity established in terms of section 3 of the Diamonds Act, 1986 (Act No.56 of 1986), as amended (Diamonds Act as amended). The SADPMR derives its mandate from the Diamonds Act and the Precious Metals Act, 2005 (Act No. 37 of 2005).

2. PURPOSE

The purpose of this workshop is to provide the Financial Reporting Team with updates on GRAP, thereby supporting the preparation of financial statements that comply with the requirements issued by the Accounting Standards Board and facilitating improvements in audit outcomes raised by the Auditor-General.

3. SCOPE OF WORK

The GRAP workshop is designed to enhance the Financial Reporting Team's technical competencies, strengthen compliance with the Standards of GRAP, and support improvements in audit outcomes. The scope of the workshop includes, but is not limited to, the following components:

3.1 Review of Accounting Policies

Review the organisation's accounting policies for compliance with GRAP requirements and provide recommendations for updates or improvements where necessary.

3.2 Review of Disclosure Notes

Assess the disclosure notes to the financial statements to ensure compliance with GRAP and assist the team in making appropriate enhancements.

3.3 Review of Audited Financial Statements

Examine the 2024/25 audited financial statements and management report and provide recommendations on identified shortcomings.

3.4 Guidance on Updated and New GRAP Standards

Provide guidance on newly issued and updated GRAP standards relevant to the entity's financial reporting process. Discuss upcoming amendments, exposure drafts, and other emerging issues that may impact future financial reporting and compliance.

3.5 Assessment of GRAP Implementation Challenges

Identify common challenges encountered in implementing GRAP within the organisation and provide practical solutions to address them.

3.6 Review of Significant Accounting Estimates and Judgements

Evaluate key areas requiring significant estimates and judgments under GRAP and advise on proper documentation and justification practices.

4.1 Qualified CA (SA) with experience in public sector financial reporting training.

5. DURATION

5.1 Training should be scheduled for two days for four finance reporting team members.
