## Background Information

The water laboratory at Research Testing & Development (R,T&D) is in possession of the Inductively Coupled Plasma (ICP) instruments & chiller. The Inductively Coupled Plasma is a technique used to identify and quantify the metals/cations in water samples. The metals/cations must be analysed for research, environmental and legislative compliance. The samples received for the analyses are from Generation Power Stations, Transmission Substations, Distribution Substations and Research Testing & Development. The concentrations are not supposed to exceed the specified limits for legal standards and guidelines

## Scope of work

Bi-annual service of the Inductively Coupled Plasma (ICP) instrument & chiller for period 3 years on as and when required basis. The bi-annual service should include parts, labour, travel & consumables

## Benefits to Eskom

The analyses of water samples is mandatory for monitoring of the quality of water for dams, underground, surface, waste and potable water. The instruments must be operational for analysis at all times. The annual service will ensure continuous operation of instruments or minimise downtime. The work which can be performed by the water laboratory will not be outsourced. The instrument must be available to perform the analyses at all times, to be able to manage samples workflow successfully and to meet the turnaround time required by line groups for regular monthly water samples. Monitoring of potable water is mandatory to determine the fitness of potable water for human consumption or drinking for the Power Stations. Also monitoring of borehole water for the human consumption/drinking purpose for the Transmission substations.

## Benefits to Eskom

The water samples received for chemical analyses are from Power Stations, Transmission substations, Distribution Power Plant Maintenance & Land Development and Research, Testing & Development (R,T&D). The Power stations are required to report the results monthly and/or when overflows had occurred to the Department of Environmental Affairs to prevent withdrawal of licences and/or fines. Also report potable water results on a monthly basis for compliance to maintain the blue drop status with the relevant Municipalities. The assurance that the quality of potable water produced at the Power Stations and borehole water at the Transmission substations are fit for human consumption
