1.5. Bid Responses

SECTION 2: EVALUATION CRITERIA

2.1 Evaluation Criteria

- 2.1.1 ACSA will use a pre-determined evaluation criteria when considering received bids. The evaluation criteria will consider mandatory administrative, functionality, Price and Preference, objective criteria (where applicable) During the evaluation of received bids ACSA will make an assessment whether all the bids comply with set minimum requirements and whether all returnable documents/information have been submitted. Bidders which fail to meet minimum requirements, thresholds or have not submitted required mandatory documents will be disqualified from the bid process.
- 2.1.2 The requirements of any given stage must be complied with prior to progression to the next stage. ACSA reserves the right to give bidders reasonable time to submit information that will be required in Stage 1 below.
- 2.2 A staged approach will be used to evaluate bids and the approach will be as follows:

2.2.2 **Stage** 2 Functionality

In determining the bidders capacity and capability to execute the contract/project, bidders will be evaluated on functionality. Functionality is the terminology used to define the technical ability of the Tenderer, based on experience to deliver the required product in accordance with the specialised quality, reliability and functionality.

Points allocated for Functionality shall be evaluated in accordance with the criteria as listed below. An overall minimum threshold of **45 points out of 75 points** must be achieved for the tender to be eligible for further evaluation on Price and Preference (80/20 split). Bidders who also fail to achieve the minimum score per criteria will be disqualified and not be eligible for further evaluations.

2.2.4. Stage 4: Objective Criteria Evaluation

In line with the PPPFA, the tender must be awarded to the bidder who scores the highest points, unless objective criteria in addition to those contemplated in the specific goals (Preference) justify the award to another bidder. Should there be no bidder the complies with the objective criteria, the highest point scorer shall be awarded the bid



SECTION 3: SCOPE OF WORK

3.1 Background and/or Purpose of this Bid

The project scope includes provision of a multi-discipline professional services consortium comprising of Engineering Consultants (Civil and Electrical), Quantity Surveyor and Construction Health and Safety Agent for the Implementation of the,

- rehabilitation and construction of runway access roads,
- construction of runway turn pad for Runway 24,
- repairs of the concrete apron,
- extension of taxilane.

The project started in March 2017 for full implementation, where successful implementation continued up to stage 5 with the approval of the business decision and subsequent appointment of contractor, however work was stopped in August 2020 on termination of the contractor's contract. The project was eventually deferred to future years sighting capex budget constraint and subsequently reactivated in March 2023 for implementation and completion. Upon reactivation, the initial scope of works was increased to include extension and reconfiguration of the taxilane adjacent to the main apron.

This development has necessitated the reinitiation of the project from FIDPM stage 1 (Initiation), allowing for added scope conceptualization, to stage 7 (Close-out project).

The project scope of works is split in two parts, Original Scope of Works and Additional Scope of Works. The Professional services (JMT) for Original Scope of Works will commence from FIDPM stage 3 (Design development) to Stage 6 (Close-Out) and the professional services (JMT) for Additional Scope of Works will commence from stage 1 (Inception stage) to stage 6 (Close-Out)

IMPORTANT: The Joint Monitoring Team scope of services will include review and monitoring of the design team project stage deliverables.

3.2 Scope of Work

Refer to Section C3 for Full Scope of Works for Professional Services

PROJECT SCOPE OF WORKS:

The following project scope highlights the project construction activities for better understandig of the works involved. The design and construction of these works will be the responsibility of the contractor appointed on the design and construction basis.



ORIGINAL SCOPE OF WORKS

1 Turn pad at runway 24

A turning pad (turning ear) at runway 24 is required to allow turnaround movement for aircraft, because runway 24 has not a direct taxiway link. The turning pad will also be equipped with a shoulder for yet blast purposes and support in case of over steering.

Part of this activity is to convert the runway elevated lights to embedded lights within the turn pad area and to provide additional taxiway edge lights for the turning pad.

2. Runway access roads

The reason to improve the runway access roads is that ICAO specifies at least 90 m of surfaced road to avoid debris and FOD from vehicles entering the runways. The runway access roads comprise of access for Fire & Rescue vehicles at all runway ends and from the Fire Training Facility, as well as access to/from existing infrastructures along the runways.

2.1 Heavy duty pavement (for fire tender)

2.1.1 Emergency access roads to runway ends

At least 90 m of surfaced roads or part thereof will be constructed to all runway ends. There will be four in total. Should a section of the road run along a taxiway, it will be subtracted from the 90 m . A further requirement is that an additional 1 000 m should be cleared at least or less when linked another road. A gravel layer will be provided to keep the road indistinguishable from its surroundings.

2.1.2 Access road to the Fire Training Facility

The current dilapidated road to the Fire Training Facility is too narrow for the Fire Tender and 90 m will be reconstructed to support the 36 tonnes Fire & Rescue vehicle.

2.2 Light vehicle access roads to aerodrome infrastructure and maintenance workshops

Existing gravel roads from the runway leading to runway infrastructure (glide path indicators and runway sock) will either be reconstructed (in case of gravel) or rehabilitated (where already surfaced)

A section of the surfaced road leading to the Maintenance Department failed and has to be rehabilitated.

3. Removal of infrastructure

A surfaced section in proximity of the new runway turning pad will be removed, which previously was used as a temporary turning facility for aircraft. An unused gravel road close to Runway 11 will be also be removed in order to prevent usage thereof as debris could be conveyed on the runway by vehicles.



4. Stormwater drainage improvements

Storm water along the runway access road to the Glide Path Indicator in proximity of Runway 11 is ponding and will be addressed by installing subsoil draining pipes that will link with the existing storm water reticulation system.

5. Concrete apron repairs

- Repairing of edge breaks, corner breaks and spalling.
- Sealing of cracks.
- Replacement of concrete blocks (to be finally assessed and confirmed during construction).
- Repairs to concrete joints.

ADDITIONAL SCOPE

6. Extension of taxilane.

The extention/ expansion of the taxilane adjacent the apron aircraft parking bay number 3 and 4 and realign the taxilane centre line to improve clearance between aircraft parked on the apron and aircraft taxiing along the taxilane.

3.3 Pricing Schedule

Bidders must only price in accordance with the pricing schedule attached in our NEC PSC Contract – Section C2.2, , this will enable ACSA to compare priced offers. Failure to submit a priced offer using the prescribed schedule will make the bid liable for disqualification.

4. SECTION 4: MANDATORY AND ADMINISTRATION DOCUMENTS

4.1 Mandatory Returnable documents

ACSA will disqualify from the bid process any bidder that has failed to submit mandatory returnable documents and information. Bidders should therefore ensure that all the mandatory returnable documents and information have been submitted.

4.2 Other Returnable Documents and information

These types of documents and information are required but are not mandatory or are only mandatory at specific stages of the process. 1. **INTERPRETATION**

In this agreement -

- 1.1 "confidential Information" is information which is confidential to the disclosing party, and includes whether in written, graphic, oral, proprietary, tangible, intangible, electronic or other form, and, -

4 NON-DISCLOSURE

- 4.1 THE RECEIVING PARTY undertakes that -
- 4.1.1 it will treat the disclosing party's confidential information as private and confidential and safeguard it accordingly;
- 4.1.2 it will not use (except as permitted in 3 above) or disclose or release or copy or reproduce or publish or circulate or reverse or engineer and/or decompile or otherwise transfer, whether directly or indirectly, the confidential information of the disclosing party to any other person or entity; and the receiving party shall take all such steps as may be reasonably necessary to prevent the disclosing party's confidential information failing into the hands of unauthorised persons or entities;
- 4.1.3 it shall not disclose the confidential information of the disclosing party to any employee, consultant, professional adviser, contractor or sub-contractor or agent of the receiving party (collectively referred to herein as "representative") or an affiliate of the receiving party, nor shall they be given access thereto by the receiving party -
- 4.1.4 unless it is strictly necessary for the purposes referred to in 2.1 above; and
- 4.1.5 the receiving party shall have procured that the representative, affiliate or consultant to whom or to which such information is disclosed or made available shall have agreed to be bound by all the terms of this agreement, and, in such event, the receiving party hereby indemnifies the disclosing party against any loss, harm or damage which it may suffer as a result of the unauthorised disclosure of confidential information by a representative, affiliate or consultant.
- 4.2 Any documentation or written record or other material containing confidential information (in whatsoever form) which comes into the possession of the receiving party shall itself be deemed to form part of the confidential information of the disclosing party. The receiving party shall, on request, and in any event if the discussions referred to in 2.1 above should not result in an agreement, return



to the disclosing party all of its confidential information which is in physical form (including all copies) and shall destroy any other records (including, without limitation, those in machine readable form) as far as they contain the disclosing party's confidential information. The receiving party will, upon written or oral request from the disclosing party and within five (5) business days of the disclosing party's request, provide the disclosing party with written confirmation that all such records have been destroyed.

5. **COPIES**

- 5.1 The receiving party may only make such copies of the disclosing party's confidential information as are strictly necessary for the purpose and the disclosures which are not in breach of this agreement and authorised in terms of this agreement. The receiving party shall clearly mark all such copies as "Confidential".
- 5.2 At the written request of the disclosing party, the receiving party shall supply to the disclosing party a list showing, to the extent practical –
- 5.2.1 where copies of the confidential Information are held;
- 5.2.2 copies that have been made by the receiving party (except where they contain insignificant extracts from or references to confidential information) and where they are held; and
- 5.2.3 the names and addresses of the persons to whom confidential information has been disclosed and, if applicable, a copy of the confidentiality undertaking signed by such persons complying with the provisions of this agreement.

6. THE USE OF THE COMPANY'S INTELLECTUAL PROPERTY

- 6.1 The receiving party shall not use any intellectual property of the Company (including trademarks, service marks, logos, slogans, trade names, brand names and other indicia of origin) (collectively, the "Company IP") for any reason whatsoever without first obtaining the Company's prior written consent which consent the Company shall be entitled to grant solely at its own discretion.
- 6.2 If the receiving party requires the use of such Company IP, a request must be sent to the sibusiso.mazibuko@airports.co.za. Each single request by the same receiving party shall be treated as a new request.
- 6.3 Should the Company provide its consent in terms of clause 6.1 above, the receiving party shall comply with the Company's policies and standards with regard to the use of the Company IP. - 10.1 This agreement shall be governed by and interpreted according to the laws of the Republic of South Africa, without reference to the choice of laws' provisions of the Republic of South Africa. In the event of a conflict between or inconsistency in the laws applicable in the various provinces of the Republic of South Africa, the law as applied and interpreted in the Gauteng Province shall prevail.
- 10.2 The parties irrevocably submit to the exclusive jurisdiction of the High Court of South Africa, Witwatersrand Local Division, in respect of any action or proceeding arising from this agreement.
- 10.3 The parties agree that, in the event of a breach of this agreement, monetary damages would not be an adequate remedy. In the event of a breach or threatened breach of any provisions of this agreement by the receiving party, the disclosing party (and/or its relevant affiliate) shall be entitled to injunctive relief in any court of competent jurisdiction and the receiving party shall reimburse the disclosing party for any costs, claims, demands or liabilities arising directly or indirectly out of a breach. Nothing contained in this agreement shall be construed as prohibiting a party or its affiliate from pursuing any other remedies available to it for a breach or threatened breach.
- The failure by the disclosing party to enforce or to require the performance at any time of any of the provisions of this agreement shall not be construed to be a waiver of such provision, and shall not affect either the validity of this agreement or any part hereof or the right of the disclosing party to enforce the provisions of this agreement.

11. **DOMICILIUM**

11.1 The parties choose as their *domicilium* the addresses indicated in the heading to this agreement for the purposes of giving any notice, the payment of any sum, the serving of any process and for any other purpose arising from this agreement.



- 11.2 Each of the parties shall be entitled from time to time, by written notice to the other, to vary its domicilium to any other address which is not a post office box or poste restante.
- Any notice required or permitted to be given in terms of this agreement shall be valid and effective only if in writing.
- 11.4 Any notice given and any payment made by one party to the other ("the addressee") which:
 - 11.4.1 is delivered by hand during the normal business hours of the addressee at the addressee's domicilium for the time being shall be presumed, until the contrary is proved, to have been received by the addressee at the time of delivery;
 - 11.4.2 is posted by prepaid registered post from an address within the Republic of South Africa to the addressee at the addressee's domicilium for the time being shall be presumed, until the contrary is proved, to have been received by the addressee on the fourth day after the date of posting;
 - is transmitted by facsimile to the addressee's receiving machine shall be presumed, until the contrary is proved, to have been received within one (1) hour of transmission where it is transmitted during normal business hours or, if transmitted outside normal business hours, within one (1) hour of the resumption of normal business hours on the next normal business day.

12. **GENERAL**

- 12.1 No party shall be bound by any representation, warranty, undertaking, promise or the like not recorded in this agreement.
- 12.2 No addition to, variation or agreed cancellation of this agreement shall be of any force or effect unless in writing and signed by or on behalf of the parties.
- 12.3 Any indulgence which either party may show to the other in terms of or pursuant to the provisions contained in this agreement shall not constitute a waiver of any of the rights of the party which granted such indulgence.
- 12.4 The parties acknowledge that this agreement and the undertakings given by it in terms hereof are fair and reasonable in regard to their nature, extent and period and go no further than is reasonably necessary to protect the interests of the parties.
- The parties hereby confirm that they have entered into this agreement with full and clear understanding of the nature, significance and effect thereof and freely and voluntarily and without duress.
- 12.6 Neither party shall have the right to assign or otherwise transfer any of its rights or obligations under this agreement.
- 12.7 This agreement may be executed in several counterparts that together shall constitute one and the same instrument.
- 12.8 In this agreement, clause headings are for convenience and shall not be used in its interpretation.
- 12.9 Each clause of this agreement is severable, the one from the other and if any one or more clauses are found to be invalid or unenforceable, that clause shall not affect the balance of the clauses which shall remain in full force and effect.

 - d. the duties and obligations imposed by this Act on any vendor or other person shall, as respects the enterprise carried on by that body, be performed by it separately from the duties and obligations imposed on any of its members.

3. Application of the Law

When a body of persons forms a joint venture, partnership or consortium, such a body is treated as a separate legal person for VAT purposes and, is in terms of section 51(1) of the VAT Act ,required to register for VAT with the South African Revenue Services ("SARS")where the body's taxable supplies exceed the registration threshold.

Should the joint venture or partnership or consortium not be registered for VAT, **VAT cannot be levied on any invoice** that will be issued out to Airports Company South Africa for services rendered.
