## Phase II Functionality evaluation as per attached Terms of Reference

- a) Bidders must as part of their bid documents, submit supportive documentation for all technical requirements as indicated hereunder. The panel responsible for scoring for the respective bids will evaluate and score all bids based on their submissions and the information provided.
- b) Bidders will not rate themselves, but need to ensure that all information is supplied as required. The Bid Evaluation committee (BEC) will evaluate and score all responsive bids and will verify all documents submitted by the bidders.
- c) The BEC members will individually evaluate the responses received against the following criteria as set out below:

Only bidders who attain a minimum of 70 percent on Functionality will qualify to proceed for further evaluation on Price and Preference points.

NB: The Department reserves the right to verify the authenticity of all CVs and qualifications submitted as part of the bid.

The bid evaluation committee MAY conduct physical verification during the evaluation process.

Service Providers accredited on the panel should note that, being on the panel does not guarantee any project allocated to them.

d) Each panel member will rate each individual criterion on the score sheet using the following scale:

## 1-Poor, 2- Below average, 3- Good, 4- Very good, 5- Excellent

- e) Individual value scores will be multiplied with the specified weighting for the criterion to obtain the marks scored for all elements. These marks will be added and expressed as a fraction of the best possible score for all criteria. This score will be converted to a percentage and only bidders that have met or exceeded the minimum threshold of 70% for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.
- f) The value scored for each criterion will be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for each criterion. These marks will be added and expressed as a fraction of the best possible score for all criteria.
- g) This score will be converted to a percentage and only bidders that have met or exceeded the minimum threshold of 70 percent for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.
- h) Any proposal not meeting a minimum score of 70% functionality will be disqualified.
- i) The price will not be evaluated at this stage.
