Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort precinct. Refer to [www.dubetradeport.co.za](http://www.dubetradeport.co.za) for more information on DTPC.

The current ongoing electricity supply challenges, coupled with the rising electricity cost compels the DTPC to look for cost effective and reliable alternative energy solutions for the Dube TradePort. DTPC wishes to procure a Transaction Advisor with appropriate technical, legal, planning and financial expertise to undertake a feasibility study and oversee the implementation of the Energy Utility Management Centre to manage the generation and distribution of various renewable energy sources to identified off-takers within the DTPC precinct.

The appointment of professional service providers will be for a period of 60 months reckoned from the date of signing service level agreements with the DTPC.

### EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following as included in the bid document:

- I. Enterprises (bidders) who are at least 51% or more owned by Black People.
