3. Factory Assessment

These assessments are performed to assess the tenderer's capability to enter a contract with Eskom with respect to installation of Fibre optic cables.

3.1. Scope

Eskom will do factory assessments to assess the ability and capacity of the tenderer to install Fibre Cable as and when required. Eskom assessment representative(s) will arrange visits to the premises of the tenderers that have qualified for factory evaluations.

Eskom assessment representative(s) will conduct the assessment and scoring using of Table 4 provided below. The requirements as submitted during the Desktop evaluation stage will be verified. Table 4 (Installer Score Sheet) will be used during factory visit assessment and if a tenderer scores less than the threshold of 80% during the factory assessment, they will fail the evaluation.
