DTPC hereby invites proposals for the appointment of a contractor for once-off repair work of the Dube AgriLab Greenhouse Hardening Facility.

The work includes, but is not limited to the following:

- Provide multi-disciplinary project management
- Repair and/or replacement works of the greenhouse structure plastic, nets, and side curtains.
- Refurbishment of the greenhouse vents,
- Testing, upgrade, and recommissioning of the Netafim NMC pro-climate control system,
- Replacement of damaged Ebb and Flood benches,
- Cleaning, repairs, and flushing of the misting system,
- Supply, delivery, installation, and commissioning of the water softener system.
- Removal of existing damaged infrastructure and dispose or seclude it accordingly as per DTPC instruction.
- Ad hoc callouts for any additional repairs that may be required within the duration of the contract.

It is estimated that tenderers must have an active **CIDB grading of 3SH/3CE/3ME or higher** by the closing date of the bid. **No Potential Emerging (PE) status is allowed.**

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.
