SECTION 2: BACKGROUND, PURPOSE, AND SCOPE OF WORK

2.1 Background and/or Purpose of this Bid

This project consists of two projects that were brought together for ease of execution. The first project is the underground main water line project which addresses the water supply challenges at BFIA and the second project is the Service Road project which addresses road infrastructure challenges at the airport.

Both projects were initiated pre-covid and delivered up to Stage 3: Design Development but had to be halted due to the challenges that the business was faced with during COVID 19. ACSA is now ready to implement both projects and due to the locality of the projects a decision to combine both projects was taken for ease of execution.

Objectives of the project are as follows:

Main water lines:

- 1. Upgrade the main water line that is running through the terminal building basement complete with isolation valves.
- 2. Construct new domestic water line from Mangaung Municipality at Masselspoort water line to provide an additional water feeder to the airport reservoirs.
- 3. Installation of two new water bore holes on airport for emergency situations during municipal water shutdowns.
- 4. Upgrade the fire water pump to comply with SANS and ASIB Regulations.
- 5. Removal of old asbestos pipe.
- 6. Replacing all eight (8) hydrant boosters including pipelines
- 7. Re-establish the other leg of the booster pipeline that was previously blanked off to increase the hydrant boosters by an additional two (2) taking the total hydrant boosters to ten (10).
- 8. The upgrading the fire hydrant water line to a minimum of 5 bar when 2 out of 10 fire hydrants are opened simultaneously.

Service Roads:

- 1. Provision of land-side access for solar plant farm ad reservoir pump station including the road to the solar plant. This entails new junctions/intersection to the facilities.
- 2. Provision of all-weather surface to the land-side truck turning circle, which is predominantly used by heavy vehicles.
- 3. Repair of the concrete standing panels outside of the fire station (airside).
- 4. Rehabilitation of the airside service road adjacent to the main terminal building.
- 5. Provision of all-weather surfaced road around the maintenance complex.
- 6. Rehabilitation/improvement of the stormwater management associated with the service roads.
