TERMS OF REFERENCE/SCOPE OF WORK

1. BACKGROUND

The Mine Health and Safety Council (MHSC) is a national public entity (Schedule 3A) established in terms of the Mine Health and Safety Act, No. 29 of 1996, as amended. The MHSC continues to conduct research and development to improve health and safety in the South African Mining Industry (SAMI), with the aim to achieve its vision of seeing every mineworker returning from work unharmed every day. The MHSC's main role in the South African Mining Industry (SAMI) is to promote a culture of occupational health and safety through effective dissemination of research outcomes, promulgated guidelines and regulatory instruments through various forums and platforms such as conferences, events, seminars, and workshops, hosted by MHSC or invited by the industry.

The Executive Authority (Minister of Mineral and Petroleum Resources) appoints the MHSC Board in accordance with the Mine Health and Safety Act and principles of the King Code on Corporate Governance and good corporate governance practices. The Board is the Accounting Authority in accordance with the Public Finance Management Act (PFMA) and is supported by independent governance committees, advisory technical committees in the execution of its oversight responsibilities. The MHSC Board currently has seven approved Advisory Technical Committees, namely:

- **Mining Regulatory Advisory Committee (MRAC)** which advises the Council on proposed regulatory changes, guidelines for codes of practice; and national standards to be approved by the South African Bureau of Standards.
- **Mining Occupational Health Advisory Committee (MOHAC)** which is tasked with advising the Council on health policies, standards, systems and procedures related to occupational health risks, health regulations, health research and health data.
- **Safety in Mines Research Advisory Committee (SIMRAC)** which reviews occupational health and safety risks; establishes the need for occupational health and safety research projects; and establishes criteria for determining the funding of health and safety research.
- **Mining Industry TB and HIV/AIDS Advisory Committee (MITHAC)** which is tasked with pursuing



the potential contribution of TB & HIV/AIDS policies towards improvement in the health and safety performance of the mining industry.

- **Culture Transformation Advisory Committee (CTAC)** which advises the Council on the overall performance of culture transformation against the set standards of the mining sector.
- **Mining Occupational Safety Advisory Committee (MOSAC)** which advises the Board on legislative, training, technology development matters to promote and address mine occupational safety related issues in the mining industry.
- **Women in Mining Advisory Committee (WIMAC)** which advises the Board on occupational health and safety matters for women in the mining industry.

The delegation to Advisory Committees is captured in formal Terms of Reference which indicate that each committee chairperson should *foster an environment where committee trust one another and feel able to communicate their views in an open, honest, frank and transparent manner.*

The objective of the training is to offer structured training that will equip members with strategies for meeting preparation, participation, and facilitation.

2. REQUIREMENTS

The MHSC seeks to appoint a service provider to provide/facilitate training for fourteen (14) MHSC Advisory committee chairpersons and their alternates on Meeting governance and effective chairing of meetings.

3. TERMS OF REFERENCE

3.1 Detailed Scope of work/specifications:

The detailed scope of work is as follows:

The service provider will be required to train MHSC Advisory Committee Members on meeting governance and effecting chairing of meetings. The training content should cover the following:



The training should cover the following key areas:

Chairing Meetings Effectively

- Functions and responsibilities of a chairperson.
- Effective committee work plans and monitoring progress against such plans.
- Establishing objectives and agendas for meetings.
- Managing the processes of decision-making and discussion.
- Managing a decision making framework, i.e. consensus, dissent, voting etc
- Resolving disputes and preserving inclusivity.
- Addressing dominance or disengagement constructively.
- Best practices for hosting and managing online and in-person meetings.
- Creating an interactive and engaging the committee environment.
- Compliance and record keeping.

Meeting Governance

- Ethical Conduct and Conflict of Interest Management.
- Confidentiality and fiduciary responsibilities.
- Management of action items and meeting minutes.

Meeting Participation

- Understanding the protocols and documentation of meetings.
- Preparing reports and presentations for meetings.
- Increasing engagement and active participation.
- Techniques for effectively managing time.

3.2 Special Conditions

The training is expected to be conducted in person at a venue that will be provided by the MHSC over the course of one day, anticipated to occur between July and September 2025.

The training provider must:

- Be accredited as a training provider with the relevant SETA.

- Provide comprehensive training that covers both virtual and in-person meetings.
- Provide an accredited Skills Development Facilitator to conduct the training.
- Provide training learning material for reference.

4. EVALUATION PROCESS

The evaluation process will be conducted in various stages. To move to the next stage of evaluation, the previous stage of evaluation must have been fully complied with.

4.1 MANDATORY TECHNICAL EVALUATION – STAGE 1

- Verify that mandatory requirements are met as per the bid document.

- (ii) **Preference** - preference points are allocated in accordance with the Preferential Procurement Policy Framework Act (Act 5 of 2000) and its Regulations 2022 as claimed in the specific goals claim form (SBD 6.1) are added to the price ranking scores. The points for specific goals must be supported by a valid B-BBEE certificate or certified sworn affidavit.

- Bidders may not make any alterations or additions to the content of this bid document, except to comply with the instructions issued by the MHSC.
- There shall be no discussions with any enterprise until evaluation of the proposal has been complete.
- RFQ's received after closing time and date will be classified as LATE and will not be considered.
- MHSC reserves the right to cancel this RFQ due to the following reasons:
 - a) Due to changed circumstances, there is no longer a need for the services specified in this RFQ.
 - b) Funds are no longer available to cover the total envisaged expenditure for the project.
 - c) No RFQ meets the required specifications.
 - d) There is a material irregularity in the RFQ process.

- e) Bidder fails to deliver in accordance with the requirements of the RFQ. The MHSC reserves the right to terminate the contract/PO during the first week after work has commenced should the appointed service provider have misrepresented themselves and/or their product and will not be able to fulfil the requirements as contained in the contract.
 - f) Payment will be made in accordance with section 38(1)(f) and 76(4)(b) of the PFMA and Treasury Regulations 15.10.1. and 8.2.3 (within 30 days from receipt of invoice after completion of deliverables).

DUE DILIGENCE

The MHSC reserves the right to conduct supplier due diligence prior to final award or at any time during the contract period. This may include site visits, reference checks and requests for additional information. The MHSC may where applicable request samples from the bidder/s to confirm capability.

RFQ AWARD

Awarding of RFQ's will not be published on the National Treasury e-tender portal or MHSC' website. No regret letters will be sent out. An RFQ is considered awarded when an official purchase order as signed by the delegated authority of the MSC is issued to the service provider. Goods may be delivered, or services may be rendered only with an official purchase order as signed and issued by the MHSC.



REASONS FOR DISQUALIFICATION

MHSC reserves the right to disqualify any bidders who do not comply with one or more of the following RFQ requirements and may take place without prior notice to the bidder:

- Bidder whose tax matters are not in order (Instruction Note 09 of 2017/2018 Tax Compliance Status will apply).
- Bidders who are not registered with the Central Supplier Database (CSD).
- submitted incomplete information and documentation according to the requirements of this RFQ document.
- submitted information that is fraudulent, factually untrue or inaccurate information.
- received information not available to other potential bidders through fraudulent means.
- failed to comply with mandatory and technical requirements as stipulated in the RFQ document.
- misrepresented or altered material information in whatever way or manner.
- promised, offered, or made gifts, benefits to any The Mine Health and Safety Council (MHSC) employee.
- canvassed, lobbied to gain unfair advantage.
- committed fraudulent acts; and

- 3.3 The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However, communication between partners in a joint venture or consortium² will not be construed as collusive bidding.

the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.

- 3.6 I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
