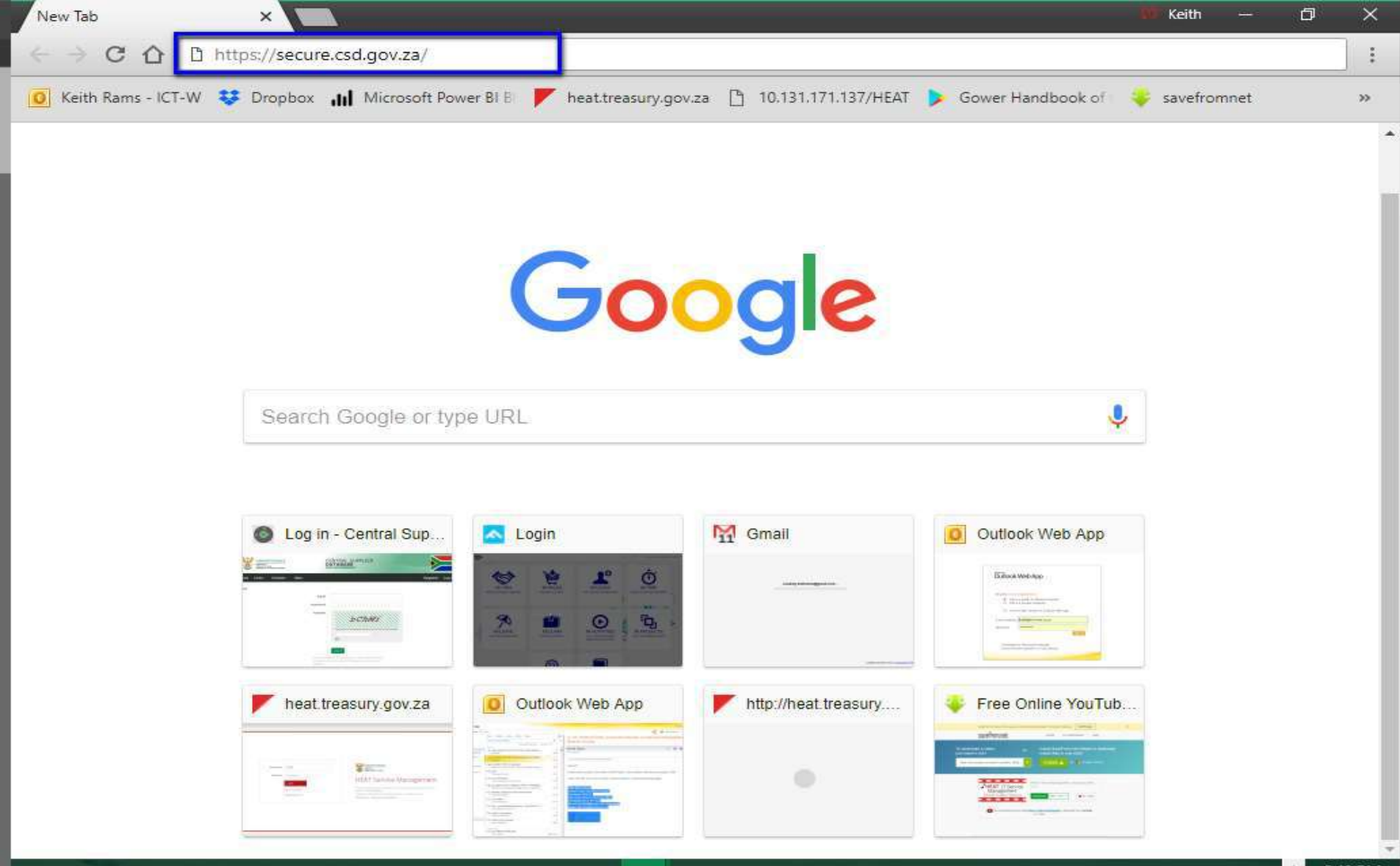

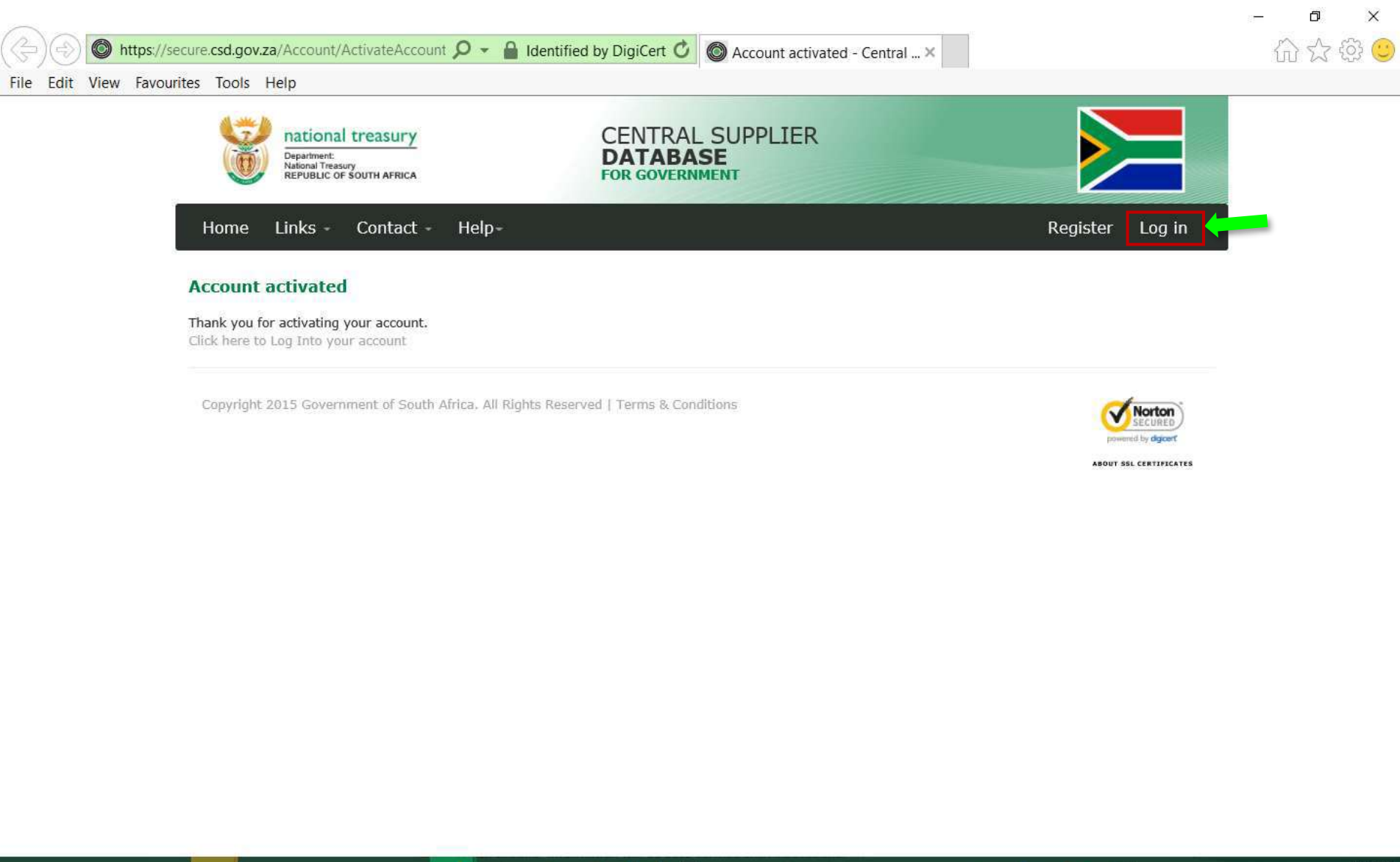

THESE TERMS AND CONDITIONS ARE BINDING ON AND ENFORCEABLE AGAINST A PERSON WHO ACCESSES THE CENTRAL SUPPLIER DATABASE

1. **DEFINITIONS AND INTERPRETATION**

In these terms and conditions, unless the context otherwise indicates, the singular includes the plural and vice versa, and -

"authorised institutional user" means a person who has been duly authorised by the primary institutional user to access the supplier information on the Central Supplier Database;

"authorised user" means a person who has been duly authorised by the primary user to access supplier information on the Central Supplier Database;

"automated verification" means electronic verification of the key information of the supplier through interfaces between the Central Supplier Database system and the systems of interfacing institutions;

"interfacing institution" means any institution that provides services or functionality to perform electronic verification of information;

"key information" means, in relation to a supplier -

- (i) business registration, including details of directorship and membership;
- (ii) tax compliance information;
- (iii) tender defaulter and restricted supplier information;
- (iv) Broad-based Black Economic Empowerment (BBBEE) information; or
- (v) bank account information.

"Central Supplier Database" means the national standardised and centralised electronic supplier database administered by the National Treasury which provides supplier information to an organ of state. The supplier database is accessible via the CSD web site or CSD mobile application (app);

"National Treasury" means the National Treasury established by section 5 of the Public Finance Management Act, 1999 (Act No. 1 of 1999) in its capacity as an administrator of the Central Supplier Database

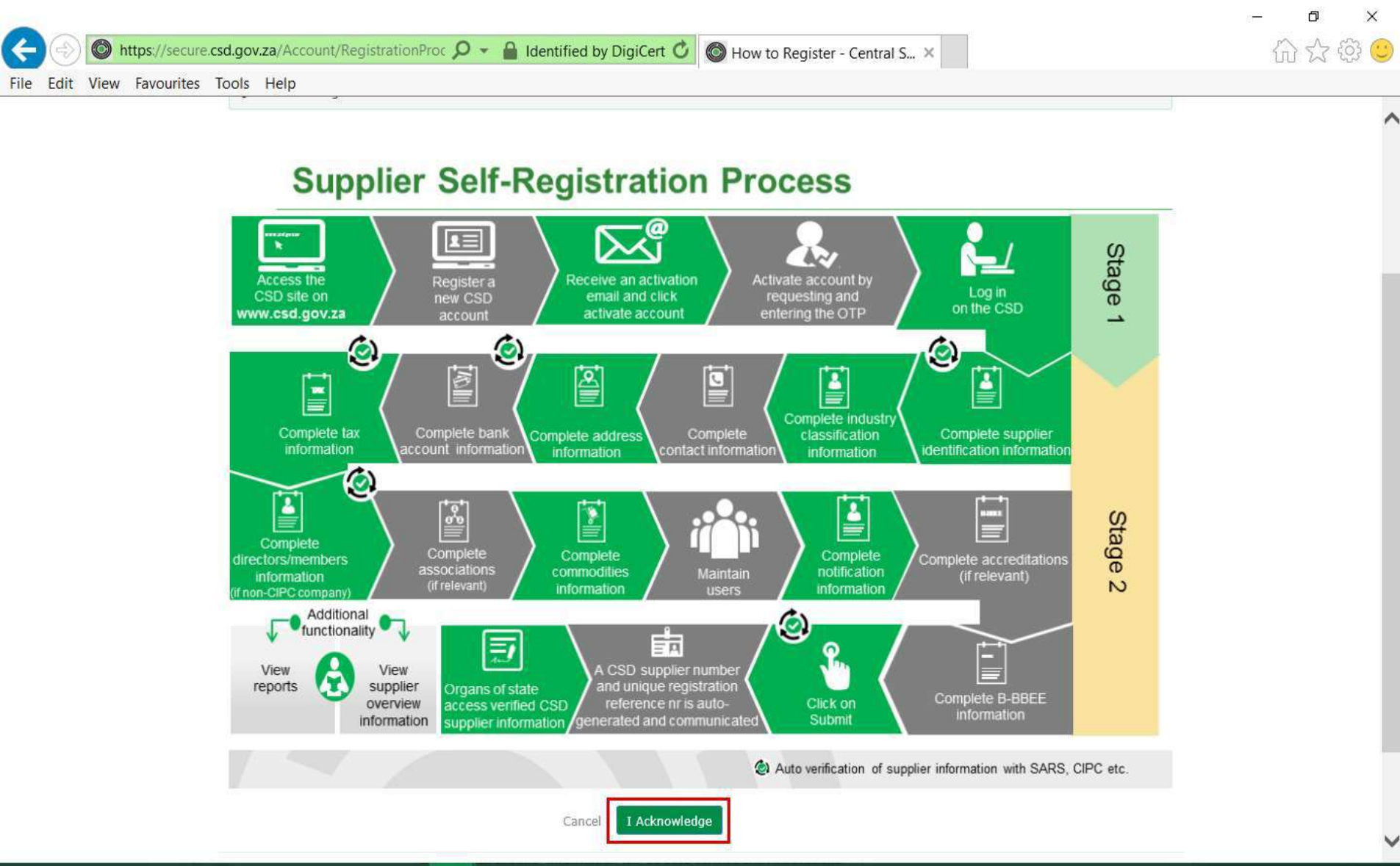

Over the past four years a number of companies have lost tens of thousands of Rands due to alleged fraudulent request for quotations (RFQS) and orders, supposedly from government departments.

The fraudsters would send a fictitious RFQ from what would seem to be a governmental email address, use a fake RFQ form with a logo and contact details of the contact person. These requests are usually "urgent" and the whole process is concluded within a short period of time. During the process the "SCM officials" will be in contact with the unsuspecting service provider until the goods are delivered either outside the building or at an agreed address.

Companies are therefore advised to verify all the RFQs and orders by calling the respective departments using the Departmental contact details listed on their respective websites to verify authenticity prior to responding to any RFQs or orders to avoid falling prey to these fraudsters.
