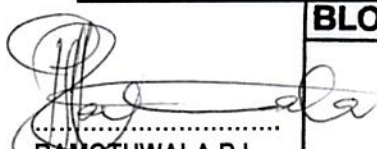
The following documents are compulsory for all Bidders:

- The Master Registration Number or Tax compliance status pin or a valid copy of tax clearance certificate
- Original or Certified copy of the up-to-date statement of Municipal rates and taxes and municipal service charges for company and company owners/directors (not more than three months and not in arrears) and if renting a lease agreement with proof of payment. If the bidder is operating where municipal rates are not applicable, a certified (not more than three months) copy of residence from the traditional authority and a letter from the municipality confirming that the area is not billed/charged rates and taxes must be submitted.
- Company profile with list of experience projects and traceable reference,
- Bank rating Code A-C; Joint venture agreement in cases of joint venture pages must be printed according to colors indicated on the table of content.

[N.B. Failure to attach the above documents will disqualify the bidder from further evaluation]

The following condition will apply:
