1. INTRODUCTION AND PURPOSE

The City of Tshwane Metropolitan Municipality seeks qualified service providers to render the repair, calibration and offer refresher training on the Spirometer as and when for a period of a year.

2. BACKGROUND INFORMATION

The Occupational Health and Safety Operations Management Subsection in the Occupational and Employee Health, Safety and Wellness Section of Group Human Capital Management operates according to the requirements of the Occupational Health and Safety Act, 1993 (Act 85 of 1993) and its regulations.

This act stipulates that regular, usually annual, testing must be done on employees who are exposed to certain hazards, for example Diesel Mechanics, employees previously exposed to asbestos and initial health evaluations for certain categories of workers. These lung function tests are done every year during medical surveillance, and they consist of medical surveillance and an initial health evaluation.

There are 7 occupational health clinics throughout Tshwane, these seven clinics perform these legally required tests on employees. The Occupational Health and Safety Operations Management Subsection need to comply with the requirements and there for the Spirometry equipment must be calibrated on an annual basis.

3. PROJECT SCOPE

1. PROJECT WORK - SPECIFICATION

The aim of this project is to assist the Occupational Health and Safety Operations Management Subsection to provide a lung function testing service

to City of Tshwane employees for yearly medical surveillance and initial health evaluations.

The Bidders are required to adhere to the following legislative and regulatory specifications. Non-compliance with these conditions may invalidate the bid for such services offered. Medical Surveillance is done to comply with relevant Acts and their regulations and with Corporate Policies, e.g.

- € Occupational Health and Safety Act No.85 of 1993 and its regulations
- € Hazardous Chemical substances Regulations
- € Asbestos Regulations
- € Mine Health and Safety Act 29 of 1996
- € City of Tshwane standard operating procedure on Hazardous Chemical Substances
- € Spirometry standards and SANS 451:2008

During the execution of the medical surveillance examinations the lung function tests that are performed require specialized equipment, including spirometers (lung function tests). To be subjected to a lung function test, the employee is required to blow into a pneumotag that adheres to the required legal specifications including yearly calibration.

The Spirometry testing equipment including the pneumotag must be calibrated daily by the person operating the machine. The syringe needed to do this calibration must also be calibrated on a yearly basis to comply with all the above.

The following equipment and action are required:

- € Spirometers complying with legal specifications
- € Calibration of spirometer and calibration syringe performed on a yearly basis by an Authorized Inspection Authority.
- € Software for Spirometers must comply with legal requirements.
- € Software must be updated annually.

The target group who should be evaluated using such meters are:

Artisans (Welders, plumbers, vehicle mechanics, etc.)

Employees previously exposed to asbestos

Fire Fighters

Initial Health evaluations

Employees exposed to silica dust (cement)

Employees exposed to various hazardous chemicals in the workplace (pesticides)

4. DELIVERABLES

To render the calibration and repairs of the Spirometer as and when required and will be done at the following Occupational Health clinics:

5. VALIDITY PERIOD

The validity period for the quotation after closure is 90 days.

6. CONDITION

Spirometers and calibration syringe must be complying with legal specifications:

- € Calibration of spirometer and calibration syringes must be performed on a yearly basis by an Authorized Inspection Authority.

Screening Spirometers and Calibration syringes must comply with SANS 451:2008

The equipment's must also comply to the American Thoracic Standards

Screening Spirometers and Calibration Syringes must:

Be issued with a calibration certificate of compliance by an accredited inspection authority that contains all the information required.

Be calibrated annually by an accredited inspection authority

NB: The City of Tshwane is currently using Koko Spirometers.

Further action on failures by the supplier to deliver will be handled in terms of the contract, including performance warnings, and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market-related price with a tenderer scoring the highest points.

If the tenderer does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring the second-highest points. If the tenderer scoring the second-highest points does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring the third-highest points. If a market-related price is not agreed upon, the City reserves the right to cancel the quotation.
