1.1 DESCRIPTION OF SERVICE: UPGRADE SENSORY CUBICLES

BACKGROUND:

The sensory cubicles need improvements. The current hatch openings are too big enabling judges to see the serving area. This is not a problem with research wines where all bottles look the same, but is a problem when commercial products with distinctive packaging. Upgraded cubicles will enable us to provide sensory evaluation as a service to clients.

PURPOSE

The sensory cubicles are used to isolate judges when evaluating food and beverages. In order to make the cubicles suitable for the evaluation of items for external parties (income generation) the current cubicles need to be upgraded by adjusting the size of the hatch openings.

SCOPE OF WORK

Installation of hatch doors in the sensory facility, Nietvoorbij Research Cellar, Nietvoorbij Campus.			
The current cubicle hatch openings need to be made smaller by an adjustable door. The existing openings will only be partially closed.			
All 24 cubicles must receive doors and all doors must look the same.			
Current opening needs to be partially closed with a door so that the new opening when the door is closed is 190 cm high from the work surface. The width of the opening should remain the same.			
Option 1 A hinged door that can partially close the existing hatch. Hinged at the top with a butt hinge (grey/silver). When open, the hatch needs a securing mechanism (white and magnetic).			

The door should be larger than the opening to prevent swinging.			
Option 2 A slide down door that can close the existing hatch opening on various levels. The largest opening should be 190 cm from the work surface.			
For both options, the material used for the doors should be constructed of PVC foam board for furniture use. No particle board/chip board/ melamine chip board/painted wood is allowed. The doors must be edged in contrasting grey high impact edging. <i>Samples of all material should be signed-off by the ARC staff end –user before installation commences.</i>			
The colour of the doors must match the existing colour of the cubicles.			
Three contactable references to previous installations done with pvc foam boards required.			
Compulsory site visit required.
