## 3 PROPOSAL SUBMISSION

Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

a) The Transnet e-Tender Submission Portal can be accessed as follows:

- a) Log on to the Transnet eTenders management platform website/ Portal ([transnetetenders.azurewebsites.net](https://transnetetenders.azurewebsites.net))
- b) Click on "ADVERTISED TENDERS" to view advertised tenders;
- c) Click on "SIGN IN/REGISTER –to register new bidder information and ensure that all mandatory information is completed) OR;
- d) to sign in if already registered;
- e) Toggle (click to switch) the "Log an Intent" button to submit a bid;
- f) Submit bid documents by uploading them into the system against each tender selected.
- g) Respondents are to submit bid documents by uploading them onto the Transnet system against each tender selected. A Bidder can upload 30mb per upload and multiple uploads are permitted.
- h) Bidders should ensure that electronic bid submissions are submitted at least a day before the closing date and bidders should not wait for the last hour before the deadline to submit. This is to enable them to timeously address issues which they may encounter due to internet speed, bandwidth or the size of the number of uploads being submitted. Transnet will not be held liable for any challenges experienced by bidders as a result of their own technical challenges.

- j) Each company must register its own profile using its company details and use the corresponding registered profile to log an intent to bid as well as submitting any bid.
- k) Transnet will not accept a bid or will disqualify a bidder who submits a bid in the Transnet e-tender submission through another bidders'/Company's profile. In other words, each bidder must register the intent to bid and submit its bid through its own profile under the same company name that will

eventually bid for the tender. No company shall submit a bid on behalf of another company regardless of the company being a subsidiary or holding company.

#### 4 RFP INSTRUCTIONS

- 4.1 Please sign documents [sign, stamp and date the bottom of each page] before uploading them on the system. The person or persons signing the submission must be legally authorised by the respondent to do so.
- 4.2 **All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**
- 4.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.

#### 5 JOINT VENTURES OR CONSORTIUMS

Respondents who would wish to respond to this RFP as a Joint Venture **[JV]** or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by Transnet through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to Transnet.

- Respondents are to note that for the purpose of Evaluation, a JV will be evaluated based on one consolidated B-BBEE score card (a consolidated B-BBEE Status Level verification certificate) Preference points will be awarded to a bidder for attaining the specific goals requirements in accordance with the table indicated in Section 4.1 of the specific goals Claim Form.

##### COMMUNICATION (CLARIFICATIONS AND COMPLAINTS)

- 5.1 For specific clarification relating to this RFP, an RFP Clarification Request Form should be submitted to Mpho Mohapi Transnet Corporate Centre JHB before **12:00 pm on 31 May 2024** substantially in the

form set out in Section 8 hereto. In the interest of fairness and transparency, Transnet's response to such a query will be published on the e-tender portal and Transnet website.

- 5.2 Specific complaints relating to this RFP before or after the closing date should be formally submitted by emailing to [groupscmcomplaints@transnet.net](mailto:groupscmcomplaints@transnet.net). Once the complaint has been submitted, the Transnet SCM Complaints office will acknowledge your complaint and send you a complaint form for completion.
- 5.3 After the closing date of the RFP, a Respondent may only communicate with the Mpho Mohapi, at telephone number 0716093576, [Mpho.Mohapi@Transnet.net](mailto:Mpho.Mohapi@Transnet.net) on any matter relating to its RFP Proposal.
- 5.4 Respondents are to note that changes to its submission will not be considered after the closing date.
- 5.5 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFP between the closing date and the date of the award of the business.
- 5.6 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.
- 5.7 Transnet will publish the outcome of this RFP in the National Treasury e-tender portal and Transnet website with 10 days after the award has been finalised. Respondents are required to check the National Treasury e-tender Portal and Transnet website for the results of the tender process. All unsuccessful bidders have a right to request Transnet to furnish reasons for their bid not being successful. This requested must be directed to the contact person stated in the SBD 1 form

## 6 CONFIDENTIALITY

All information related to this RFP is to be treated with strict confidence. In this regard Respondents are required to certify that they have acquainted themselves with the Non-Disclosure Agreement. All information related to a subsequent contract, both during and after completion thereof, will be treated with strict confidence. Should the need however arise to divulge any information related to this RFP or the subsequent contract, written approval must be obtained from Transnet.

## 7 COMPLIANCE

The successful Respondent [hereinafter referred to as the **Service provider**] shall be in full and complete compliance with any and all applicable laws and regulations.

## 8 EMPLOYMENT EQUITY ACT

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

## 9 DISCLAIMERS

Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Transnet reserves the right to:

- 9.1 modify the RFP's Goods/Services;
- 9.2 award a contract in connection with this Proposal at any time after the RFP's closing date;
- 9.3 award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP;

- 9.4 split the award of the contract between more than one Supplier/Service provider, as may be explicitly articulated in the conditions or objective criteria to this RFP;
- 9.5 cancel the bid process;
- 9.6 validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;
- 9.7 request audited financial statements or other documentation for the purposes of a due diligence exercise;
- 9.8 not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provided for it;
- 9.9 to cancel the contract and/request that National Treasury place the Respondent on its Database of Restricted Suppliers for a period not exceeding 10 years, on the basis that a contract was awarded on the strength of incorrect information furnished by the Respondent or on any other basis recognised in law;
- 9.10 to award the business to the next ranked bidder, provided that he/she is still prepared to provide the required Goods at the quoted price, should the preferred bidder fail to sign or commence with the contract within a reasonable period after being requested to do so. Under such circumstances, the validity of the bids of the next ranked bidder(s) will be deemed to remain valid, irrespective of whether the outcome of the tender has been published the outcome of the bid process on the National Treasury e-tender Portal and Transnet website. Bidders may therefore be requested to advise whether they would still be prepared to provide the required Goods at their quoted price.
- 9.11 Request a bidder to furnish further information relating to its Environmental, Social and Governance (ESG) standing at any stage of the procurement or contracting process. This information may not be used for purposes of evaluation and/or disqualify bidder, but may be use for purpose of record and analysis of ESG compliance.
- 9.12 Where sub-contracting is applied in a tender, conduct due diligence assessment on the sub-contractor(s) and this may entail requesting the bidder to provide further information relating to the sub-contractor(s) or directly requesting the information from the sub-contractor(s) as well as conducting any necessary investigations on the sub-contractor(s) to detect issues of "FRONTING".

Note that Transnet will not reimburse any Respondent for any preparatory costs or other work performed in connection with its Proposal, whether or not the Respondent is awarded a contract.

## 10 LEGAL REVIEW

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business. A material deviation from the Standard terms or conditions could result in disqualification.

## 11 SECURITY CLEARANCE

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the Goods/Services and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of **CONFIDENTIAL/ SECRET/TOP SECRET**. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

## SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

### 1 BACKGROUND

Transnet started a journey to develop Young Leaders in the organization, through the implementation of Leadership Programmes specifically for the Youth in the organisation. Transnet seeks to capacitate Transnet Young Leaders to allow for strategic enhancement and workforce innovation. They should also be able to respond timeously to an ever-changing economic and technological environment whilst planning and executing operations. This journey should have a personalised journey of discovery and growth but also for future growth and betterment for Transnet as a whole. Young Leaders should be equipped for the future with the tools and confidence to excel in their spheres of influence.

Transnet seeks to appoint a suitable service provider for the implementation of a Young Leaders Programme for a period of three (3) years. A total number of 150 learners from across the country in all Transnet Operating Divisions, is anticipated to be enrolled on the programme over the 3-year period (50 delegates per annum). The Young Leaders Programme is intended to be delivered in a blended learning approach.

### 2 SCOPE OF REQUIREMENTS

#### OBJECTIVES

Beyond this programme, the Young Leaders must be able to demonstrate strategic capability and leadership, self and team mastery; as well as the ability to think and debate through critical thinking and decision-making skills. Young Leaders who go through this programme, should be able to go through day- to- day operations effectively, whilst displaying the ability to operate in an agile environment. The Transnet Young Leaders' Programme should be accredited on NQF level 6 (Advanced Certificate in Management Practice - 120 credits) and completed in twelve (12) months.

The academic programme should as a minimum focus on:

- a. Strategic management, inclusive of shared value, micro and macro environment,
- b. governance, and ethics,
- c. Systems thinking,
- d. Technological innovation and understanding (i.e Artificial Intelligence and Robotics)
- e. Data analyses, problem solving and decision making,
- f. Personal brand leadership, inclusive of networking and influential skills,
- g. Change Management – inclusive of leading and managing teams in an agile context,
- h. Media and presentation skills, as well as
- i. Emotional intelligence, inclusive of Personal Mastery.

The programme should *inter alia* be supplemented with book reviews, academic talks and each element of the programme should be inclusive of theory as well as the practical application thereof.

The minimum practical key elements of the programme should include the following:

- a. Participation in a community volunteerism project, to assist in adding value to a chosen Non-Governmental Organisation (NGO) by means of skills transfer, to ultimately position the NGO for future growth and betterment.
- b. Shadowing Programme with Executive Managers with the aim to understand the role of a leader and manager in Transnet.
- c. Coaching and mentoring, inclusive of reverse mentoring, and
- d. Participation in an International Youth Summit, such as the One Young World.

Learning should be supported by a Learning Management platform to enable self-study.

Upon completion of annual programmes a graduation must be conducted and certificates of competence issued to graduates.

### 3. TERMS OF REFERENCE

#### **THE INTENDED IN SCOPE REQUIREMENTS FOR THE PROGRAMME ARE AS FOLLOW:**

- 3.1 Design, development, and delivery of a blended Leadership development training programme, with learning material applicable to Young Leaders.
- 3.2 The programme should be accredited on NQF level 6 (Advanced Certificate in Management Practice - 120 credits) and completed in twelve (12) months.
- 3.3 Include formative and summative assessments inclusive of case studies / assignments / a work-based project as part of the curriculum, that is relevant to our industry and the South African sector.
- 3.4 Content must be engaging, interesting, interactive, and adaptive, and allow for testing and scoring for each module.
- 3.5 The learning modules should be supported by a Learning Management platform to enable self-study.
- 3.6 The curriculum should be customized for Transnet.
- 3.7 The service provider must have a national footprint with available resources in participating provinces.
- 3.8 The service provider must capacitate Transnet Trainers through skills transfer.
- 3.9 The learning material designed and developed by the service provider will remain the intellectual property of Transnet.
- 3.10 The service provider facilitators should be accredited and registered to roll out a programme of this nature.
- 3.11 The Service Provider should be registered and capable to capture learner training data on Services Sector Education and Training Authority (SSETA); and/or Quality Council for Trades and Occupations (QCTO); and or Department of Higher Education and Training data bases.
- 3.12 The service provider is expected to produce monthly reports on milestones achieved and programme progress.
- 3.13 The Service Provider should provide an Annual Return on Investment (ROI) report.
- 3.14 Service provider must have a dedicated Project Manager as a point of contact during the implementation of the programme.
- 3.15 Training should be delivered in Johannesburg and Cape Town and/or Durban.
- 3.16 Conduct annual in person or virtual graduation ceremony upon successful completion of programme.
- 3.17 Certificates of competence must be issued to graduates.

#### **THE SERVICE PROVIDER MUST ENSURE COMPLIANCE AND BE FAMILIAR WITH THE FOLLOWING FOR THE DURATION OF THE CONTRACT:**

- 3.18 The successful Service Provider should be an accredited and registered training Service Provider with the relevant Services Sector Education and Training Authority (SSETA); and/or Quality Council for Trades and Occupations (QCTO) and/or Department of Higher Education.
- 3.19 Knowledge of Education, Training and Development Practitioners' (ETDP) environment.  
Knowledge of both formative and summative assessment methods, using a range of methodologies.
- 3.20 The Service Provider must clearly demonstrate extensive experience of not less than 10 years in line to the programme learning tools design, development, and delivery, both manual (if relevant) and electronic learning systems with delivery experience in large logistic corporates in South Africa. International experience would be an added advantage.
- 3.21 Ability to apply creativity and innovation when developing learning programmes.
- 3.22 The Service provider should ensure that Accredited Bodies provide Statement of results, relevant to completed training.
- 3.25 All training must be available through classroom and online learning (blended learning).
- 3.26 The Learning Management platform should support online Learning for self-study purposes.
- 3.27 The Program training modules must include Learner Guides, Assessment guides, Learner Workbooks and Facilitator Guides both manual and electronic formats;
- 3.28 Implement a Train the Trainer programme for completion by identified Transnet employees.
- 3.29 As part of the proposal the provider should show examples of similar work done previously with references.
- 3.30 Provide company scope of relevant services, modules, and curriculum on offer.
- 3.31 Ascertain return on investment using an approved methodology.
- 3.32 The service provider should have capacity and resources to successfully complete the project.

**THE METHODOLOGY TO BE FOLLOWED SHOULD AS A MINIMUM INCLUDE THE FOLLOWING:**

- 3.33 Relationship interaction between the Provider and Transnet Subject Matter Experts (SMEs) to allow both to become familiar with some of the key business issues critical to business success.
- 3.34 Address real business issues in a more practical manner;
- 3.35 All Transnet documents are the company's intellectual property and should be dealt with accordingly.
- 3.36 Problem solving, inclusive of assistance with internal change / communication on suggested rollout plan.
- 3.37 Well researched content to be presented, by collaborating with TRANSNET's SMEs.
- 3.38 Administer annual intake application process.
- 3.39 Ensuring that change takes place continuously, through integration of acquired knowledge with real business challenges.
- 3.40 Provide clearly detailed project plan with relevant project deliverables. The project plan should further detail the execution plan and details of the design strategy for learning material.
- 3.41 Be willing to share best practices in respect of content and delivery.
- 3.42 Provide electronic training documentation (e.g Learner Documentation, Portfolio of Evidence, attendance registers), to Transnet Academy upon completion of training modules.
- 3.43 Conduct and report on assessment and moderation processes.
- 3.44 Provide proof of learner registration and statement of results from relevant institutions.
- 3.45 Provide Transnet monthly programme reports on milestones achieved and progress, inclusive but not limited to:
  - a. Names of learners that completed training,
  - b. Number of learners trained, per course, per Operating Division per month, per annum,
  - c. Monthly no shows of learners,
  - d. Training cancellation,
  - e. Training assessments,
  - f. Training moderation (internal and external) status,
  - g. Learner registration and statement of results,

**IN THE PROCESS OF DEVELOPING AND DESIGNING THE TRAINING PROGRAMME, THE SERVICE PROVIDER WILL ENGAGE IN THE FOLLOWING ACTIVITIES:**

- 3.46 Conduct consultation sessions with the relevant stakeholders within Transnet to acquire the necessary information that will inform the content of the training programme.
- 3.47 Familiarize themselves with the expectations of the business, learning methodologies, training programme content, the Transnet Capacity Building policies.
- 3.48 Conduct a consultative session with the Curriculum Development & Assessment Department to discuss instructional design framework and the 'look and feel' of the learner material and the suggested layout design template (corporate branding).
- 3.49 Consult with subject matter experts (SME's) as referred to by the project team regarding skills needs identification and analyses relevant to the youth in the organization.
- 3.50 Present the learning programme to the Transnet project cross-functional team.
- 3.51 Revise the learning programme based on recommendations made by the Quality Assurers (and Subject Matter Experts), and input by the cross functional teams.
- 3.52 Conduct consultative workshops with Subject Matter Experts (SME's) and Curriculum Development Specialists as deemed necessary by Transnet Academy.
- 3.53 Provide the required services in compliance of the applicable Transnet company policies (national and international legislation).

3.54 Implement a Train the Trainer programme for completion by identified Transnet employees.



5.6 **STEP FIVE : Price Negotiations (if applicable)**
