1. PROJECT PURPOSE

To supply a quotation to conduct a complete vulnerability assessment, internal and external penetration test and configuration review for PPECB's ICT Infrastructure.

2. SPECIFICATION

PPECB is seeking proposals from qualified vendors to perform a comprehensive penetration testing exercise, including internal and external penetration testing, vulnerability scanning, and firewall review. The objective is to identify and mitigate security risks, vulnerabilities, and weaknesses in the company's ICT infrastructure.

The penetration testing exercise shall include the following components:

2.1 External Penetration Testing

- **Objective:** To assess the security of all external-facing assets, including web applications, network infrastructure, and public-facing APIs.
- **Scope:** All externally accessible IP addresses, domains, and services owned or operated by PPECB.
- **Activities:**
 - Network mapping and service identification.
 - Vulnerability scanning of external assets.
 - Exploitation of identified vulnerabilities to assess the potential impact.
 - Analysis of security controls and configurations.
 - Reporting and recommendations.

2.2 Internal Penetration Testing

- **Objective:** To simulate an attacker with internal access (e.g., an insider threat or compromised user) and identify vulnerabilities that could be exploited within the internal network.
- **Scope:** The entire internal network, including all servers, workstations, network devices, and applications.
- **Activities:**
 - Network enumeration and mapping.
 - Vulnerability scanning of internal assets.

- Privilege escalation and lateral movement tests.
- Exploitation of identified vulnerabilities.
- Assessment of endpoint security and configuration management.
- Reporting and recommendations.

2.3 Vulnerability Scanning

- **Objective:** To perform scanning of the company's assets to identify known vulnerabilities in systems and applications.
- **Scope:** All assets within the internal and external scope, as defined above.
- **Activities:**
 - Scanning of all identified assets.
 - Identification and classification of vulnerabilities.
 - Validation of identified vulnerabilities.

2.4 Firewall Review

- **Objective:** To review the configuration and effectiveness of the company's firewalls in protecting internal and external network boundaries.
- **Scope:** All firewalls in use within the company, including perimeter firewalls, internal segment firewalls, and any cloud-based firewalls.
- **Activities:**
 - Review of firewall rule sets and configurations.
 - Assessment of firewall management practices and change control.
 - Testing of firewall effectiveness against identified threats.
 - Reporting on misconfigurations, unnecessary rules, and potential weaknesses.
 - Recommendations for optimisation and hardening.

2.5 Deliverables

The selected vendor will be required to deliver the following:

- **Detailed Penetration Testing Report:** A comprehensive report for both internal and external penetration tests, including:
 - Executive summary of findings.
 - Detailed technical findings, including exploited vulnerabilities.
 - Risk assessments for each identified vulnerability.
 - Evidence of successful exploitation.
 - Recommendations for remediation.
- **Vulnerability Scan Reports:** A report from vulnerability scans with identified vulnerabilities, their severity, and remediation guidance.
- **Firewall Review Report:** A report detailing the findings of the firewall review, including misconfigurations, weaknesses, and recommendations for improvement.
- **Post-Engagement Support:** A defined period for retesting and validation of remediated vulnerabilities, along with a support window for addressing any issues or questions arising from the reports.

2.6 Vendor Requirements

Vendors submitting proposals must meet the following criteria:

- **Experience:** Demonstrated experience in performing similar penetration tests for companies of comparable size and industry.
- **Certifications:** Relevant certifications for team members, such as OSCP, CEH, CISSP, or equivalent.
- **Tools:** Use of industry-standard tools and methodologies for penetration testing and vulnerability scanning.
- **Compliance:** Very good understanding of relevant industry regulations and standards (e.g., OWASP, POPIA, GDPR, PCI-DSS, ISO 27001, NIST).

2.7 Proposal Submission

Vendors must submit a detailed proposal that includes:

- **Approach and Methodology:** A detailed description of how the vendor plans to execute the scope of work.
- **Project Timeline:** Estimated timeframes for each phase of the engagement.
- **Team Composition:** Resumes and qualifications of key personnel who will be involved in the project.
- **References:** Contact information for at least three references from past engagements.
- **Cost:** Detailed pricing, including a breakdown of costs for each component of the scope of work.

2.8 Evaluation Criteria

Proposals will be evaluated based on the following criteria:

- **Technical Approach:** Understanding of the requirements and the proposed methodology.
- **Experience and Qualifications:** Relevant experience and certifications of the team.
- **References:** Feedback from previous clients.
- **Cost:** Cost-effectiveness and transparency of pricing.
- **Support and Retesting:** Commitment to post-engagement support and retesting.

3. TERMS AND CONDITIONS OF BID

3.1 Bid Submission

3.2 Closing Date

- 3.2.1 Bids must be delivered by the stipulated date and time to the correct address. Late bids will not be accepted for consideration.

3.2.2 PPECB reserves the right to extend the closing date. Bidders invited to bid, will be informed should the closing date change.

3.3 Revisions to Request for Quotation

If it becomes necessary to revise any part of this Request for Quotation, an addendum setting out such revisions will be provided to all Service Providers by an email.

3.4 Bid Validity Period

The quotation must be valid for the duration specified on page 1 (Bid Validity Period).

3.5 CSD Registration

3.5.1 Only bid responses from bidders that are registered on the Central Supplier Database (CSD) will be considered.

3.5.2 Bidders are required to register on the CSD and to include in the SBD1 the Master Registration Number in order to enable the PPECB to verify the supplier's status on the CSD.

3.5.3 Responses from bidders not registered on the CSD at bid closing time or bidders that is prohibited from doing business with the state will be disqualified.

3.6 Acknowledgement and Acceptance

The bidder warrants by signature in this document that the bidder has read and accepts each page of the RFQ, including the terms and conditions of this bid.

3.7 Insurance

3.7.1 The successful Service Provider will be responsible for its work and every part thereof, and for all materials, tools, equipment, appliances, and property of all descriptions issued in connection with this Request for Proposal.

3.8 Response Preparation Cost and Ongoing Engagement

The PPECB is not liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

3.9 Reservations

3.9.1 PPECB's decision/s regarding the acceptance or non-acceptance of a quotation shall be final and PPECB is not obliged to furnish any reason for such decision.

3.9.2 Proposals shall be considered and evaluated against a pre-determined evaluation value structure determined by PPECB. All Suppliers shall provide all information requested in this RFQ to facilitate the evaluation process. Suppliers shall strictly adhere to the instructions stated in this RFQ.

3.9.3 PPECB may, during and after the evaluation of the Proposals and in its sole and absolute discretion, decide to:

- Accept a Quotation other than the lowest priced quotation.
- Refuse to consider any Quotation not conforming with the requirements of this RFQ;
- Ask any Service Provider to supply further information after the closing date;
- Cancel this RFQ or any part thereof at any time.
- Award the contract pursuant to this RFQ or any part thereof to any one or more Suppliers,
- Not to award the quotation at all.

4. DATA PROTECTION

4.1 Any personal information and Confidential Information of the PPECB which may be provided during the bidding process may only be processed by the bidder for the purposes of this bid.

5. NEWS AND PRESS RELEASES

5.1 Bidders or their agents shall not make any news releases concerning this RFP or the awarding of the same or any resulting agreement(s) without the consent of, and then only in co-ordination with PPECB.

6. DISCLAIMER

6.1 This RFQ is a request for quotation only and not an offer document; answers to it must not be construed as acceptance of an offer or imply the existence of a contract between the parties.

6.2 By submission of its proposal, bidders shall be deemed to have satisfied themselves with and to have accepted all Terms & Conditions of this RFQ.

6.3 The PPECB makes no representation, warranty, assurance, guarantee or endorsements to bidder concerning the RFQ, whether with regard to its accuracy, completeness or otherwise and the PPECB shall have no liability towards the bidder or any other party in connection therewith.

7. GENERAL TERMS AND CONDITIONS

The attached terms and conditions must be signed and send back with the RFQ response.

8. COMPLIANCE DOCUMENTS

The following documents are required for the proposal to be considered for the evaluation process.

1. SBD1 – Invitation to bid;
2. SBD4 - Bidder's Disclosure;
3. Valid Tax Clearance Certificate or Pin;
4. Valid B-BEE Certificate or EME/QSE Affidavit;
5. SBD6.1 – Preference Point Claim Form;
6. Central Supplier Database Registration (CSD) Report – Proof of CSD registration.

9. RFQ EVALUATION PROCESS AND CRITERIA

All quotations or bids will be evaluated according to the following stages. Should a bidder fail any of the previous stages, they will be disqualified and not be considered for the next evaluation stage.

9.1 Stage 1 – Compliance Evaluation

Bidders must comply with all the terms and conditions of the RFQ and must submit all returnable documents as listed in **Section 8**. Bidders must ensure that they complete and sign returnable documents.

Any Bidder who fails to meet the Compliance Evaluation criteria may be disqualified and not be considered for further evaluation.

9.2 Stage 2 - Technical Evaluation

A technical evaluation will be conducted to determine the preferred supplier.

The evaluation will be based on the below criteria:

The minimum functional threshold is 60. Points. Bidders who score less than this threshold will be disqualified and not considered for any further evaluation.

9.3 Stage 3 – Price and Specific Goals

Bidders that passed the previous evaluation stage(s) will be evaluated on one of the following two options:

9.3.1 **Price and Specific Goals** - Where the price of the lowest acceptable bidder is R 2,000 or greater, the bid will be evaluated using the 80/20 preference point system as per the current Preferential Procurement Regulations;

9.3.2 **Price** - Where the price of the lowest acceptable bidder is less than R 2,000, the bid will be evaluated using price as the key determinant.

9.4 Points Awarded for Specific Goals

9.4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

9.4.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.



9.5 Stage 4 - Objective Criteria

In terms of Preferential Procurement Regulation 11 and section 2(1)(f) of the Preferential Procurement Policy Framework Act, the PPECB may consider the following objective criteria in the bid award:

- I. The risk of fruitless and wasteful expenditure to the PPECB;
- II. The risk of an abnormally low bid;
- III. The risk of a material irregularity;
- IV. The PPECB reserve the right not to consider bids from Bidders who are currently in litigation with the PPECB; and

V. The PPECB further reserve the right not to award this tender to any Bidder based on the proven poor record of accomplishment of the Bidder in previous projects within the PPECB and the referee submitted by the Bidder.
