
Building Signage

- Mounted to Aluminium / Steel Framework




North Wing - Window measurements

- Frost Vynal – 0.48m x 1.86m (x9)




North Wing - Window measurements

- Frost Vynal – 0.33m x 1.86m (x1)




West Wing - Window measurements

- Frost Vynal - 0.66m x 1.82m




