Specification for provision of Skip waste bins and rubble removal at PRASA Stations

1. PURPOSE

The purpose is to procure 3 x service providers to provide quality waste removal services for the PRASA to comply with environmental and health legislation and public expectations. Waste management is governed by the Waste Management Act 59 of 2009 which has its main objectives as waste minimization and waste data collection.

The purpose of this scope is to align waste removal activities of PRASA Cres to those of National, Provincial and Local government and adhere to by-laws. As a utility of Government parastatal, PRASA can only lead by example and provide leadership in waste removal for commuters, business units in the buildings managed by the company and to potential investors.

The provision of a seamless waste management service by PRASA will profile the company as a quality orientated company that is committed to a clean and healthy environment. As a company that derives its income on attracting and recruiting commuters and tenants, cleanliness of our facilities is paramount from an aesthetic and presentation point of view.

2. OBJECTIVES

- Improve environmental cleanliness of the facilities and promote a healthy and safe environment.
- Profile the company as an environmental conscious company committed to the quality health and cleanliness.
- Improve aesthetics of facilities.
- Create an environment that will deter pests and rodents.
- Establish volumes and statistics of waste streams generated by the users of services.

3. THE PRIMARY OBJECTIVE OF THIS CONTRACT IS TO:

- Procure services of 3 x contractors who will be fully responsible for a provision **of skip waste bins and waste removal.**
- To contract for cost effective and effective and professional high-quality services

4. **ACTIVITIES**

The provision of a waste collection service will be informed by the waste generation of the facilities involved. Approximately 70% of waste generated by the stations and depots operations is general waste with the rest being garden waste.

To support the use of these long-term assets, stations will require dedicated waste pickers or general workers that will ensure there is not windblown litter or scattered waste within the jurisdiction of the company sites.

- Skip rental and removal of waste and rubble for the below clusters

- Removal of waste on the following days: **Wednesday & Friday** and on the as and when basis.
- Delivery notes to be signed by a PRASA Rail, Shosholoza Meyl or Cres employee on every job done and shall submitted with invoices as proof of service rendered.
- All the waste around the bins should be collected and area should be cleaned after removal
- **The preferred bidder will be expected to start providing the required services within 24hrs after receiving the appointment letter, failing which PRASA will cancel the contract.**
(Placing of bins at the specified stations and pick up bins at specified days).
- Skip bins should be sanitised at least once a month.

NB: 3 X CONTRACTORS WILL BE APPOINTED, 1 X CONTRACTOR APPOINTED PER CLUSTER
