5 LATE BIDS

5.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be dispatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

5.2 The official Telkom time, which can be observed by dialing 1026 from any phone, will be used to verify the exact closing time.

5.3 Bids sent to the NEMISA via normal post, or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises

(tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

6 PAYMENTS

- 6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.
- 6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.
- 6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.

TERMS OF REFERENCE (TOR)

REQUEST FOR PROPOSAL/S FROM SERVICE PROVIDERS FOR THE DEVELOPMENT OF ONLINE LEARNING CONTENT FOR NEMISA ACCREDITED CREATIVE MEDIA FULL QUALIFICATIONS PROGRAMMES.

1. BACKGROUND

The National Electronic Media Institute of South Africa was established as a non-profit institute for education in terms of the Companies Act (1973) and is listed as a schedule 3A public entity in terms of the Public Finance Management Act (1999). NEMISA derives its mandate from the Department of Communications and Digital Technology (DCDT), and DCDT's constitutional function is e-skilling the nation for equitable prosperity and global competitiveness.

NEMISA is an accredited training provider with the Media, Information and Communication Technologies Sector Education and Training Authority (MICT SETA) in creative media and digital skills. Recently, NEMISA's mandate was expanded to include 4IR skills for South African citizens. The organisation seeks to review its existing curriculum and content and develop or source new course content to improve its offerings and remain relevant while delivering on its mandate.

2. PURPOSE

The National Electronic Media Institute of South Africa (NEMISA) invites experienced and suitably qualified service providers to submit bids for the review of NEMISA's curriculum, existing training materials and the development/sourcing of new training content. The aim of the project is to improve NEMISA's training offerings to meet its mandate of delivering leading-edge Digital Skills and Creative Media learning programmes. The curriculum and the courses to be reviewed, developed, or sourced must also meet South Africa's accreditation requirements for them to be on par with international practice. The curriculum and the courses must be adaptable to blended learning and online learning, be deployed on NEMISA's Digital Skills Platform and remain the Intellectual Property (IP) of NEMISA.

3. CONTRACT PERIOD

NEMISA requires **Twenty-Four Months (24)** contract with the appointed service provider (work to include further needs analysis, development maintenance and updating of the course content).

4. SCOPE OF WORK

NEMISA would like to appoint a service provider to review NEMISA's curriculum, existing training materials and the development/sourcing of new training content. This project aims to enhance NEMISA's current training offerings by offering courses via an online platform that will be accessible to learners across the country and be aligned to Sector Education and Training Authority (SETA) quality assurance standards.

The expected deliverables for this project are depicted in Table 1 below with the following additions:

5. SPECIFICATIONS OF CONTRACT

- 5.1 The curriculum and the courses to be reviewed, developed, or sourced must meet South Africa's accreditation requirements and be on par with international practice.
- 5.2 The curriculum and the courses must be fully online with options for hybrid learning.
- 5.3 The training content to be reviewed or sourced must enable the skilling, upskilling and reskilling of South African citizens, particularly in Digital Skills, Digital Literacy, and 4IR, both technical skills and soft skills and targeting unemployed and employed citizens.
- 5.4 The service provider will be required to facilitate stakeholder and industry consultative processes as part of the content review and establish the need for new content.

Section A 2: Terms of Reference

- 5.5 Once the needs for the development or sourcing of new content are in place, the service provider will be expected to submit a report to NEMISA and only proceed with the development or sourcing of the content once approval is granted by NEMISA.
- 5.6 Each course will require a Facilitator Guide, Learner Guide, Assessment Guide and Moderation Guide.
- 5.7 Each course must have clearly stated outcomes that are aligned with assessment activities
- 5.8 Each course must have formative and summative assessments to measure the skills acquired by the learners during the course.
- 5.9 The courses should be multimodal: in that, they should target multiple senses during the learning process. (Visual, Auditory, Kinaesthetic).
- 5.10 Each course must identify learning support mechanisms for the learners.
- 5.11 Each course must provide guidance on how the learners should apply the skills they learn and link the learning to the working environment or entrepreneurial opportunities.
- 5.12 The courses must expose learners to innovation, critical thinking, creative thinking, problem-solving, communication, working in teams, being productive and other critical skills.
- 5.13 Where applicable, the courses must refer to regulatory compliance specific to each course.
- 5.14 The courses must be presented in English with subtitles.
- 5.15 NEMISA will hold the Intellectual Property (IP) of the reviewed curriculum and courses developed or sourced.
- 5.16 The courses must comply with NEMISA branding requirements.

6. COURSE DEVELOPMENT REQUIREMENTS

6.1 STRUCTURAL REQUIREMENTS

- 6.1.2 Courses must allow the activation, of Course, Tracking with limited access

1.3.2 The score for functionality shall be calculated as follows:

- ☐ Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.
- ☐ The score of each panel member shall be added together and divided by the

number of panel members to establish the average score obtained by each individual bidder for functionality.

1.4 DETERMINATION OF SCORE FOR PRESENTATIONS

1.4.1 NEMISA will not call for presentations.

OR

1.4.2 NEMISA has decided/may decide to have compulsory presentations made either by all bidders who have obtained at least 80% of the marks for functionality, or by the bidders ranked first to a maximum of six, but not less than the three highest scoring bidders once the price and preference marks have been combined.

- 1.4.3 Presentations shall only affect the marks awarded for functionality. If NEMISA wishes to use presentations to discriminate between bidders, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme and indicated in paragraph 1.2.1.
- 1.4.4 Points determined by the presentation will be awarded to each bidder by each member of the Bid Evaluation Committee and then an average calculated. Such score will be added to the original score for functionality.
- 1.4.5 A bidder will be disqualified if the combined score for functionality fails to meet the minimum threshold for functionality as per paragraph 1.341.
- 1.5 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY**
- 1.5.1 Bids that score less than **80%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.
- 1.6 PRICE AND B-BBEE STATUS LEVEL POINTS**
- 1.6.1 All remaining bids will be evaluated as follows:
- 1.6.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.
- 1.6.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.6.4 The point scored for the B-BBEE status level certificate for each acceptable bid will now be added to the price point.
- 1.6.5 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.5.4 or to a lower scoring bid on justifiable grounds.
- 1.7 ADJUDICATION OF BID**
- 1.7.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
