DETAILED TECHNICAL SPECIFICATION

1. RFQ Background

The plant rooms' floor and walls conditions are poor. The current paint, on the floors and walls need to be removed, and walls and floors prepared for re-painting, then paint the floors and walls. This project is part of the plant rooms' renewal initiative which seeks to improve the current state of our plant rooms. The service provider must provide all the materials required (paints, poly fillers, thinners, gap filler, etc).

2. Motivation

The floors and walls of Radio and TV Campuses' plant rooms need to be re-painted. The floors need to be colour-coded so that walkways and storage areas are well-defined. The walls also need to be painted. The plants at Radio Park Building that needs to be painted are Ground Floor Plant, K2 Central Plant, K2 Inrack Units Plant, K3 Plant, K4 Plant, D1 Plant, D2 Plant, D4 Plant, D5 Plant, D6 Plant, D7 Plant and EL Plant. The plants to be painted at TV Campus are B1 Plant, B2 Plant, S2 Plant, Main Plant, S4 Plant and S6 Plant.

3. Scope of Work Requirements

The work shall be done as per scope, specifications' conditions. The contract shall provide all labour, material, tools, equipment, supervision services, and other related items required to complete the project as per the scope of work and specifications. Contracts are advised to visit the site, verify the existing site conditions to develop their proposal.

The work include: painting floor and interior walls of the plant rooms. The contractor must observe manufacturer's recommendations in regard to preparation of surfaces to receive paint and application of paint itself.

Scope of Work:

- Cleaning/Surface Preparation high pressure clean and remove oil, grease and loose
 foreign matter including mould, dirt and corrosion products, in a matter which causes neither
 undue damage to the substrate nor damage to, or contamination of, the surroundings or paint
 system to be applied. Do not paint over dirt, dust, scale, grease, moisture, or conditions
 detrimental to the formation of a durable and acceptable finish.
- Filling fill cracks and holes with fillers, sealants, or grouting cements as appropriate for the finishing system and substrate, and sand smooth, to ensure all coats finish smooth. Walls should be wiped down as necessary before painting.
- **Drying** ensure that surfaces are cured and dry before applying additional coats of paint. RFQ/LOG/2022/187

 Generally – remove any objectionable surface irregularities, remove any rust and apply rust primer. Apply an oil-based primer to any bare timber surfaces. Light sanding between coats for the perimeter walls painting.

Painting –

- i). apply paint and related material with an undercoat plus two coats of selected finish colour or with the number of coats specified in accordance with the manufacturer's recommendations. Allow each coat to harden for the drying time (or time between coats) recommended by the manufacturer. Ensure that each coat of paint is uniform in colour, gloss, thickness, and texture and free of runs, sags, blisters, wrinkles, or other discontinuities. Place "wet paint warnings" and do not remove until paint is dry.
- ii). All painted timber, front entry doors and frames should be painted with the same colours as existing one. Repaint/Varnish all windows, window frames, doors with same colour.
- iv). Repaint downpipes and railings
- v). Repaint all cable runs, conduits, and pipe work.

N.B. final paint shall be applied in two coats and according to the manufacturer's instructions.

- Work Area Protection before painting in any section of the building, use drop sheets and
 masking tape and other suitable covers wherever necessary prior to surface preparation and
 painting operations to protect finished work or other surfaces liable to damage during
 painting.
- **Touch Ups** clean off marks, paint spots and stains throughout including on glass, restoring damaged surfaces to their original condition.

Paint Types and Specifications –

- i). use only premium quality paints from approved manufacturers.
- ii). Do not combine paints from different manufacturers.
- iii). Use only the type and quantity of thinners recommended by the paint manufacturer.
- iv). Provide finish coats which are compatible with prime and undercoat paints used. Provide barrier coats over incompatible primers or remove and reprise as required.
- v). do not apply paint when surrounding temperatures and the paint manufacturer exceeds humidity conditions beyond that recommended.

Safety

i). contractor is responsible for implementation and management of a safety and health programme throughout the project.

- ii). SABC Representative reserve the right to suspend work when and where contractor contravenes internal and legislative safety rules (not wearing appropriate Personal Protective Equipment). And the lapse of time shall be at the contractor's expense.
- iii). Contractor shall provide all Personal Protective Equipment for the workers as per site requirement (i.e., overalls, hard hat, gloves, goggles, safety shoes, ear plugs/muffs, dust musk and respirator with cartridges suitable for paint fumes).
- iv). Contractor will not leave the work site in an unsafe condition or any other condition that may result to injury to personnel, damage to equipment and plants.

Workmanship Standards

- i). care shall be taken to ensure that the base surfaces are properly prepared and that the materials are used correctly.
- ii). Paints should be stored and applied as per manufacturers direction to avoid contamination and deterioration. Use applicators and techniques best suited for the type of material being applied.
- iii). Ridging at roller overlaps shall not be permitted.
- iv). Paint surfaces behind mobile equipment and/or furniture must be the same as similar exposed surfaces.
- v). Use a scraper tool remove the old finish on wood surfaces, wipe with spirits to remove residual stripper, allow the surface to fully dry before moving on to sanding, wipe down whole surface to remove any dust from sanding, apply two coats of oil-based varnish and ensure smooth finish.
- vi). Upon completion of the work, all paints cans, containers, debris, and other protective coverings shall be cleaned up and removed from site. The contractor shall leave the area in a clean, neat, and orderly condition.
- vii). Workers shall be skilled in their job and have related job experience.
- Warranty the contractor shall guarantee that all work performed will be free from all defects in workmanship. The contract shall further guarantee that if, during a period of one year from the date of certificate of completion and acceptance of the work. Any defect will be repaired by the contractor at his own cost.
- Final Inspection and Acceptance the final inspection shall be attended by SABC representative, project engineer and contractor. At this time a comparison of the statement of works to the completed project shall take place. Any discrepancies will be added to the snag list for the contractor to complete. The contractor must correct and fix the snag list items for final inspection.

7. ADJUDICATION USING A POINT SYSTEM

- 7.1 The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder
- 7.2 Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- 7.3 In the event that two or more bids have scored equal pints, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 7.4 However, when functionality is part of the evaluation process and two or more bids have scored equal points for B-BBEE, the successful bid must be the one scoring the highest score for functionality
- 7.5 Should two or more bids be equal in all respect, the award shall be decided by the drawing of lots.

- b. Bidders other than EMEs must submit their original and valid B-BBEE status levels verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a verification agency accredited by SANAS.

A tenderer will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intend sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended Sub-contractor is an EME that has the capacity and the ability to execute the sub-contract.
- g. A tenderer awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capacity and the ability to execute the sub-contract.

9. COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.

2 SUB-CONTRACTING

- 2.1 A person awarded a contract may only enter into a subcontracting arrangement with the approval of the organ of state.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe* se prohibition meaning that it cannot be justified under any grounds.
