**1. PURPOSE**

The purpose of this Request for Quotation (RFQ) is to invite suitable qualified Recycling companies to bid for the electronic scrap and other assets for disposal at the NAC.

**2. BACKGROUND**

The National Arts Council of South Africa, an Agency of the Department of Arts and Culture, is the de- facto successor in title to the Foundation for the Creative Arts, originally established in 1989. NACSA's mandate as set out in the National Arts Council Act, Act 56 of 1997, specifies its Objects as:

- To provide, and encourage the provision of, opportunities for persons to practice the arts
- To promote the appreciation, understanding and enjoyment of the arts
- To promote the general application of the arts in the community
- To foster the expression of a national identity and consciousness by means of the arts
- To uphold and promote the right of any person to freedom in the practice of the arts
- To give the historically disadvantaged such additional help and resources as are required to give them greater access to the arts
- To address historical imbalances in providing infrastructure for the promotion of the arts
- To promote and facilitate national and international liaison between individuals

### 3. SCOPE OF WORK

The National Arts Council of South Africa (NAC) hereby invites Recycling companies to bid for the electronic scrap assets for disposal at the NAC.

3.1 Disposed / Written-off movable assets comprising electronic waste / scrapped equipment needs to be removed from site by recycling firms and issue a destruction certificate for the electronic assets. The recyclers may arrange for viewing the electronic waste listed below if needed. Accounting officer has approved the request to dispose of the assets.

#### **Project Deliverables:**

- Recycling companies are invited to bid for the electronic scrap and other redundant assets.
- The highest bidder will pay for the assets and remove the assets from the building at NAC offices.
- The recycling company will be required to issue the NAC with a destruction certificate that confirms that the assets have been destroyed/ recycled and not be resold.

Bidders are advised that their proposals should be concise, written in plain English and simply presented in the same order as indicted below:-

- (a) Financial proposal to deliver the assignment including any other cost NAC should be aware off for the successful completion of the assignment;

## 6. EVALUATION METHOD

The cost proposals will be evaluated on Comparative Price and Specific goals, using the 80/20 preference point system contemplated in the Preferential Procurement Regulations 2022, where 80 points will be awarded for price while 20 points will be allocated for Specific goals as prescribed in the regulations.

The points for Price and for Specific goals will be added together based on bidders price proposal in accordance with the below table:

## PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

- 1.5** Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6** The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## **2. DEFINITIONS**

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, the 80/20 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

  - (a) disqualify the person from the tendering process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution, if deemed necessary
