The following **compulsory documents** must be accompanied with the tender, and failure to provide such documentations shall constitute automatic disqualification: Original certified copy of valid BBBEE Certificate SANAS accredited BBBEE or Affidavits will be accepted (Compulsory but failure to submit, no points will be awarded for BBB-EE), Copy of company registration certificate (CK), Copy/ print Tax Compliance status pin issued by SARS - Directors or Company's municipal Services account (not older than 3 months), CSD report must be submitted, Duly Signed and Dated Authority of Signatory on Company Letterhead, Certified ID Copies of Companies Directors, CIDB Grading of 4CE PE/5CE or Higher, Valid COIDA Letter of Good Standing/Workmen's Compensation Registration Certificate, Local Content is Applicable as per MBD 6.2 as well as Annexure C, Approval of Exemption on local content from DTI must be Attached with bidding document, as and when applicable. Joint Venture Agreement (In case of a Joint Venture)

A preferential point system should apply whereby this project will be allocated to a bidder in accordance with the PPPF Act (No. 5 of 2000) and as defined in the conditions and requirements of this project. In terms of the supply chain management policy of the municipality all bids shall be adjudicated on an 80/20-point system if it's less than R50 000 000.00 and on a 90/10-point system if it's more than R50 000 000.00.

The municipality reserves the right to withdraw any invitation to quote and/or to re-advertise or to reject any quote or to accept a part of it. The municipality does not bind itself to accepting the lowest quotation or award a contract to the bidder scoring the highest number of points

According to the Municipality Supply Chain Regulations issued by the Minister of Finance in terms of Section 168 of the Municipal Finance Management Act, Act 56 of 2003, persons within the organs of the state, like Councillors, and other elected representatives, full time employees and other directors of the public and municipal entities are prohibited from being eligible to bid or be awarded a contract to provide any services to the municipality.

- Original or copy of valid BBBEE Certificate (Non-compulsory but failure to submit, no points will be awarded for BBB-EE) only SANAS accredited or Affidavits will be accepted, failure will lead to points for BBB-EE not allocated) – Not Compulsory
- Copy of company registration certificate (CK) – Compulsory
- Copy/ print Tax Compliance status pin issued by SARS - Non-Compulsory
- Copy of current director's or company's municipal account (not older than 3 months) – Compulsory
- CSD summary report, in case of a Joint Venture, a combined CSD must be submitted – Compulsory
- Local content is applicable as per MBD 6.2 and Annexure C – Compulsory
- Approval of exemption on local content from DTI must be attached with bidding document, as and when applicable – Compulsory
- All forms/document must be filled in full – Compulsory.
- Valid CIDB grading, to be submitted with the bid document and in case of Joint Venture, a combined CIDB grading must be submitted – Compulsory.
