- 2.2 Respondents failing to attend the compulsory RFP briefing will be disqualified.
- 2.3 Respondents are encouraged to bring a copy of the RFP to the RFP briefing.

## 3 PROPOSAL SUBMISSION

Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

- a) The Transnet e-Tender Submission Portal can be accessed as follows:

In other words, each bidder must register the intent to bid and submit its bid through its own profile under the same company name that will eventually bid for the tender. No company shall submit a bid on behalf of another company regardless of the company being a subsidiary or holding company.

#### 4 RFP INSTRUCTIONS

- 4.1 Please sign documents [sign, stamp and date the bottom of each page] before uploading them on the system. The person or persons signing the submission must be legally authorised by the respondent to do so.
- 4.2 **All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**
- 4.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.
- 4.4 Any additional conditions must be embodied in an accompanying letter. Subject only to clause 15 [Alterations made by the Respondent to Bid Prices] of the General Bid Conditions, paragraph 12 below (Legal Review) and Section 6 of the RFP, alterations, additions or deletions must not be made by the Respondent to the actual RFP documents.

#### 5 JOINT VENTURES OR CONSORTIUMS

Respondents who would wish to respond to this RFP as a Joint Venture [JV] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by Transnet through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to Transnet.

- Respondents are to note that for the purpose of Evaluation, a JV will be evaluated based on one consolidated B-BBEE score card (a consolidated B-BBEE Status Level verification certificate) Preference points will be awarded to a bidder for attaining the specific goals requirements in accordance with the table indicated in Section 4.1 of the specific goals Claim Form.

## SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

### 1 BACKGROUND

The Network Asset Maintenance (NAM) function is to deploy and maintain infrastructure to enable the safe movement of freight. The NAM Telecoms manages the deployment and operations of mission-critical telecommunication infrastructure that are essential for personnel and railway-based systems to ensure the safety of operations. The level of safety is ensured by guaranteeing safety-critical systems as well as voice communication of staff that operate the railway system (e.g., shunting, train driver to train control officer).

The transmission network consists mainly of Fiber optic cables installed on the OHTE across the country (a small percentage is underground). The transmission network is used to connect relay rooms to facilitate the Train Authorization Systems (TAS), the Condition Assessment Systems (CAS), and radio networks (high sites). The capacity ranges from 155 Mbps to 100 Gbps.

The modernization and capacity upgrades on the optical transmission network executed under CAN R365 commenced in the 2018/19 FY and will be finalized in the 2024/25 FY. The operation of any future network within TFR depends on the successful completion of the Dense Wavelength Division Multiplexing (DWDM) project.

The NAM Telecoms consists of two internally managed analogue networks, and one external network. These networks ensure access to wireless voice communication for operational and technical staff. The internal analogue networks are made up of conventional and trunked radio networks. The first network is an open-channel radio communication network. This network is utilised if train authorization is based on the Radio Train Order (RTO), Radio Track Warrant (RTW), and Video Display Unit (VDU). The second network is the Trunk Radio network, which is used in locations where authorization is based on the colour light signal. Figure 1 Below depicts the areas of radio (wireless) coverage for all the networks. The two analogue radio networks (Conventional and trunk) operate in the 450MHz band with the following band plan: 455-456.65MHz paired with 465-466.65 MHz to achieve coverage.

The conventional network also makes use of channels in the 459MHz paired with the 469MHz band for narrowband, low-capacity Ultra high frequency (UHF) radio links. All these frequencies are licensed by Independent Communications Authority of South Africa (ICASA). The coal line (highlighted in yellow) is currently being operated by Mobile Telephone Networks (MTN) a private commercial network operator.

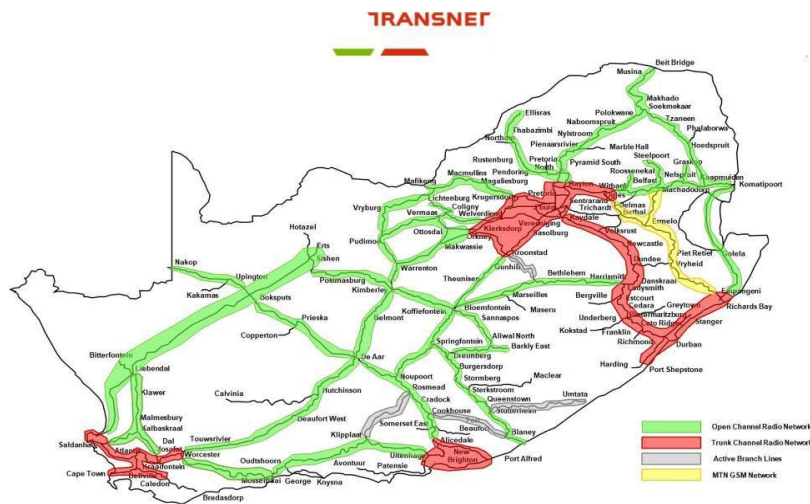


Figure 1: Mission Critical Radio Networks

These wireless communication networks provide mission-critical telecommunication services to train operations and ensure the safe movement of freight across the rail network and include the following services:

- Conventional push-to-talk voice communication between train driver and Train Control Officer (TCO).
- Group voice communication on the railways and the ports.
- Direct communication and shunting activities.
- Trunked voice communication (train driver to TCO and Transnet operational staff); and
- Data services (CAS and Tele-control).

## 2 EXECUTIVE OVERVIEW

Whereas Transnet is seeking a partner(s) to provide solutions for its Radio Network Modernization nationally, it also seeks to improve its current processes for providing these Goods/Services to its end user community throughout its locations.

The selected Supplier/Service provider(s) must share in the mission and business objectives of Transnet. These mutual goals will be met by meeting contractual requirements and new challenges in an environment of teamwork, joint participation, flexibility, innovation and open communications. In this spirit of partnership, Transnet and its Supplier/Service provider(s) will study the current ways they do business to enhance current practices and support processes and systems. Such a partnership will allow Transnet to reach higher levels of quality, service and profitability.

Specifically, Transnet seeks to benefit from this partnership in the following ways:

- 2.1 Transnet must receive reduced cost of acquisition and improved service benefits resulting from the Supplier/Service provider's economies of scale and streamlined service processes.
- 2.2 Transnet must achieve appropriate availability that meets user needs while reducing costs for both Transnet and the chosen Supplier/Service provider(s).

- 2.3 Transnet must receive proactive improvements from the Supplier/Service provider with respect to supply/provision of Goods/Services and related processes.
- 2.4 Transnet's overall competitive advantage must be strengthened by the chosen Supplier/Service provider's leading edge technology and service delivery systems.
- 2.5 Transnet end users must be able to rely on the chosen Supplier/Service provider's personnel for service enquiries, recommendations and substitutions.
- 2.6 Transnet must reduce costs by streamlining its acquisition of Goods/Services, including managed service processes on a Group basis.
- The main aim is to frame a fixed term approved list of service providers for the provision/supply, installation, commissioning, support, and delivery of National Radio Network Modernization for a period of three (03) years on an "as and when required" basis. A phased approach method will be adopted for the implementation of this project, with Phase 1 being the Ore Corridor and Container Corridor, with the other 4 corridors to follow in Phases 2 and 3.
  - Due to the legacy and the obsolescence of the radio network, it is expected to deploy digital radio technologies to modernize Rail Network National Radio Network with speed in some cases work should be implemented in parallel. The key objective of the demand request is to achieve the following:
    - Replace obsolete radio network required to improve and facilitate Train Driver-Train Control Officer, Yard, Ports, and other mission-critical communication.
    - Reduce operational costs relating to frequent maintenance, support, spare rebuilding, and overtime related to the prone-to-fault existing radio network.
    - Eliminate network gaps resulting from network de-optimization, decommissioning of sites, and failure to return to service due to the absence of spares, configurations, and materials.
    - Enable network capacity expansions to support new business coverage demands.
    - Provide required data capacity: Currently, the network does not support data capabilities due to its analogue status. There is a business need for the new radio network to support the digital transformation strategy.
    - Compliance with Government ICASA regulation.
    - A radio network is required to provide safety, an RSR regulatory requirement for train operating systems such as Signalling, axle counters, and Fail-Safe Data Transfer (FSDT).
    - Provide real-time and uninterrupted Central Train Communication (CTC) to train drivers in wireless communication.
    - Derailment avoidance: Provide wireless communication for the track and infrastructure condition monitoring systems e.g., hotbox detectors, ultra-sonic broken rail detector.
    - (UBRD) and drag equipment detector (DED).
    - Provision to support the Outcome Base Security (OBS) digital communication requirements e.g., Closed-Circuit Television (CCTV), and drones.

- Facilitation of radio communication from high site base stations to train control centres in all dark territories.
- Seamless implementation and change-over to the new technology during a dual-illumination period allowing for current analogue network to be operable before being switched off.
- Ensuring no interference between the Radio Distributed Power (RDP) system used on the Ore line and the LTE and DMR network. The RDP system transmit communication signals from the locomotive consist to consist, allowing for the running of longer trains on the section.
- The RDP system currently operates on 456,5750 and 456,4375 MHz frequency, which will be within the same band as the LTE will be deployed in, as such will require new locomotive RDP radio and repeater site modules must be procured and programmed to operate on within a different frequency band.
- Service provider to have a detailed implementation and migration plan for all data-based technologies and trackside equipment currently in use by Transnet for operations, monitoring and safety.

### 3 SCOPE OF REQUIREMENTS

#### 3.1 Business requirement (Technical Specification):

##### Introduction

Most radio high sites were implemented more than two decades ago of which conditions have changed and the network near obsolete, therefore requires modernization to meet both current and future requirements. Transnet issued a Request for Information (RFI) to assess the technologies that might be employed to assure compliance while simultaneously sustaining the current network infrastructure for operations. Long-term Evolution (LTE) and Digital Mobile Radio (DMR) were the two technologies chosen for technical evaluation. The two technically evaluated and successful digital solutions under the RFI are LTE (pilot tested) and DMR (technically tested). The scope of work covers two approved technologies:

- DMR Technology - for Northern Cape Square Kilometer Array (SKA) and Shunt yards.
- LTE Technology

#### 3.2 Scope Overview

The focus area is to modernize the existing analogue radio network by deploying digital radio Technologies i.e., upgrading Existing RF equipment to offer modern technology for the operational environment,

- The service provider must supply and deliver the radio equipment that meet Telecoms specifications (**Annexure A:** list of equipment, material and components and their associated specifications). This includes all equipment, network components and accessories for a fully functional LTE and DMR network. It is detailed in the Scope of Work **Annexure B** and **Appendix 1**.
- The service provider must be able to install, commission and test the radio equipment as per the TRIM standards/specifications (**Annexure A:** list of installation, commissioning, and testing procedures for radio equipment/network).
- The service provider must be able to provide technical support and maintenance of the radio network on an as and when basis and must be able to respond to faults reported within the



standard agreed times on as and when required basis (**Annexure F**: TFR fault management process and expected response times).

- Service provider shall be able to deliver scope of work as per **Annexure B** and **Appendix 1** on as and when required.
- Service providers must ensure equipment conformance to regulatory authority ICASA.
- Warranty period to be specified in the Specification compliance.

### 3.2.1 The Requirements

Equipment must conform to ICASA Regulations including Type approval and the 3GPP, ETSI and ITU-R Standards. The bidders must indicate their compliance to the Electronic Communications Act 36 of 2005 and spectrum regulations. Service providers authorisations:

- a) Supplier shall provide written proof from the OEM that they are authorised suppliers and are equipped to supply and provide support of the equipment according to OEM specifications.
- b) Supplier to confirm list of equipment, materials, spares proposed to TFR.
- c) Supplier to provide a detail methodology of acquiring, purchasing, renewing, testing and quality assurance of all equipment and installation, testing proposed to TFR.
- d) Supplier shall detail their repair process including locations of available workshops, technical facilities, and resources in the country.
- e) Suppliers shall indicate the value-added services such as OEM training, tier level support etc.

### 2.3.2. The Functional Requirements

The bidder must meet Transnet technical specifications provided:

- The bidders must comply to ICASA Regulations
- The bidders must comply to RSR Regulations

NB: The above specifications indicate minimum acceptance requirements however bidders are welcome to indicate additional capabilities of their equipment should they exist. See **Annexure I** Detailed specification list.

### 2.3.3. Performance Requirements

The equipment must comply with the ITU performance criteria listed in the technical specifications.

Management information must be carried from the management network, through multiple elements, to every element in the network.

The network should guarantee 99.999% availability.

The peripherals should meet the following requirements:

- IP rating: IPX6 or higher
- Operation in a noisy and hostile environment

The network equipment should meet the following requirements:

- a) The equipment used on the network should operate in remote hostile environments.
- b) Equipment must be of a modular type in some cases hot-swappable to limit any downtime.
- c) The network equipment must be future-proof and backward compatible to future versions.

#### 2.3.4. Other Requirements

The requirement is for the demand request is to achieve the following, but not limited to and may Change to meet the overall project objective and sustaining of the network:

- a) Establish fixed term approved list of service providers for the provisioning of the supply, delivery, installations and testing of National Radio Network modernization to replace existing radio network with digital radio technologies on “an as and when required” basis.
- b) Detailed operating and maintenance/workshop manuals in accordance with generally accepted industrial standards must be supplied.
- c) Detailed technical specifications of the equipment and all components where supplied must be included.
- d) The service provider must ensure that there is adequate local support for the systems supplied. A contract of this size warrants at least one full time resource dedicated to servicing TFR’s requirements.
- e) Since this is specialised equipment, the service provider must have at least one employee who is accredited and certified by the manufacturer(s) of the products offered, to install, commission and service these.
- f) The bidder must have suitable premises in South Africa to warehouse equipment components, assemble them as per order, test them and pre-commission them, and then ship them out to site. The bidder must also appoint a local installation team, training, and up-skilling them as necessary to support the network.
- g) The bidder must indicate for how long the products offered have been in the market, and how long it will take before they are superseded. TFR will not accept Beta versions nor end-of-life products.
- h) It is anticipated that, over the course of the project, improvements in features, performance and functionality of the products will be introduced. Transnet must be made aware of all information pertaining to the life cycle of the equipment and provide detailed solutions and mitigating solutions where applicable.
- i) Software upgrades to the NMS and network elements must be undertaken continuously throughout the contract and/or warranty, without disrupting services.
- j) The Tenderers must provide for consideration the maintenance proposal for support of the assets over entire duration of its life cycle. This proposal should be for indicative purposes.
- k) A warranty of a minimum of 2 years after successful acceptance testing is required and bidders must quote for this warranty in their submission.
- l) Adequate and appropriate training requirements for all systems, procedures and processes are to be provided to the relevant staff. This includes technical staff and TFR Faculty of Rail. They must be provided with full course documentation so that they may use this to train TFR technicians in the future. All persons that are trained either by TFR Faculty of Rail or the manufacturer must be certified to do module, software changes, installations and commissioning without the warranties becoming void.

#### 2.3.5. Implementation Requirements

**The implementation requirement for the LTE request is as follows:**

- a. Firstly, frame an approved list of service providers list for the provision/supply, installation, commissioning, support and delivery of National Radio Network Modernization for a period of three (3) years on an “as and when required” basis.
- b. Secondly, to appoint a maximum of six (6) service providers as part of the approved list of service contractors, the Price- specific goals scorecard will be used for the highest (x6) scoring bidder’s unit rates, to be framed on the list.
- c. Thirdly, to utilize the fixed term approved list on a rotational basis making in order to promote the principle of cost-effectiveness. The unit price itemized list will be used for this purpose.

- d. Fourthly, in order to appoint a maximum of maximum of six (6) service providers as part of the approved list of service contractors, the Price- specific goals scorecard of the highest scoring bidders will be considered under the following scenarios/conditions:
- The first x6 highest scoring bidders will be framed for LTE technology.
  - The minimum service providers that Transnet can frame is six (6) service providers for LTE. Transnet reserves the right to frame responsive bidder(s) below a minimum of two (2) service providers.
- e. Lastly, in order to appoint a maximum of six (6) service providers based on the Price- specific goals scorecard, bidders to complete in full the Unit Price Schedule (Bill of Material) (all Unit Price (ZAR) per Items filled) (Annexure H: Price Schedule).

### 2.3.6 The implementation requirement for the DMR request is as follows:

- a. To appoint a maximum of three (3) service providers as part of the approved list of service contractors, the Price- specific goals scorecard will be used for the highest (x3) scoring bidder's unit rates, to be framed on the list.
- b. To appoint a maximum of three (3) service providers as part of the approved list of service contractors, the Price- specific goals scorecard of the highest scoring bidders will be considered under the following scenarios/conditions:
- The first x3 highest scoring bidders will be framed for DMR technology.
  - The minimum service providers that Transnet can frame is one (1) and maximum is three (3) service providers for DMR.
  - Lastly, in order to appoint a maximum of three (3) service providers based on the Price- specific goals scorecard, bidders to complete in full the Unit Price Schedule (Bill of Material) (all Unit Price (ZAR) per Items filled) (Annexure H: Price Schedule)
- c. Finally, to select up to nine (9) service providers—six (6) for LTE and three (3) for DMR—according to the Price-BBBEE automated scorecard. Bidders are required to accurately complete the Unit Price Schedule (Bill of Material), ensuring all Unit Prices (ZAR) per item are provided).

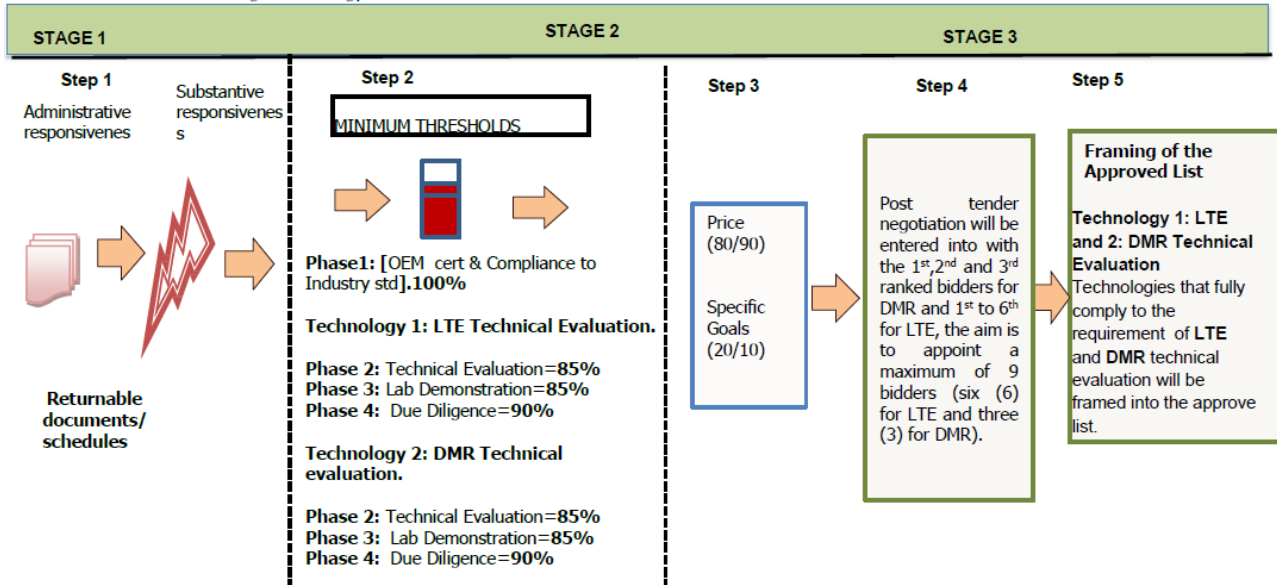
