1. INTRODUCTION

The National Consumer Tribunal (“NCT”) was established in terms of the National Credit Act, No. 34 of 2005 (“the NCA”) as amended and in terms of the Consumer Protection Act, Act No. 68 of 2008 (“the CPA”)

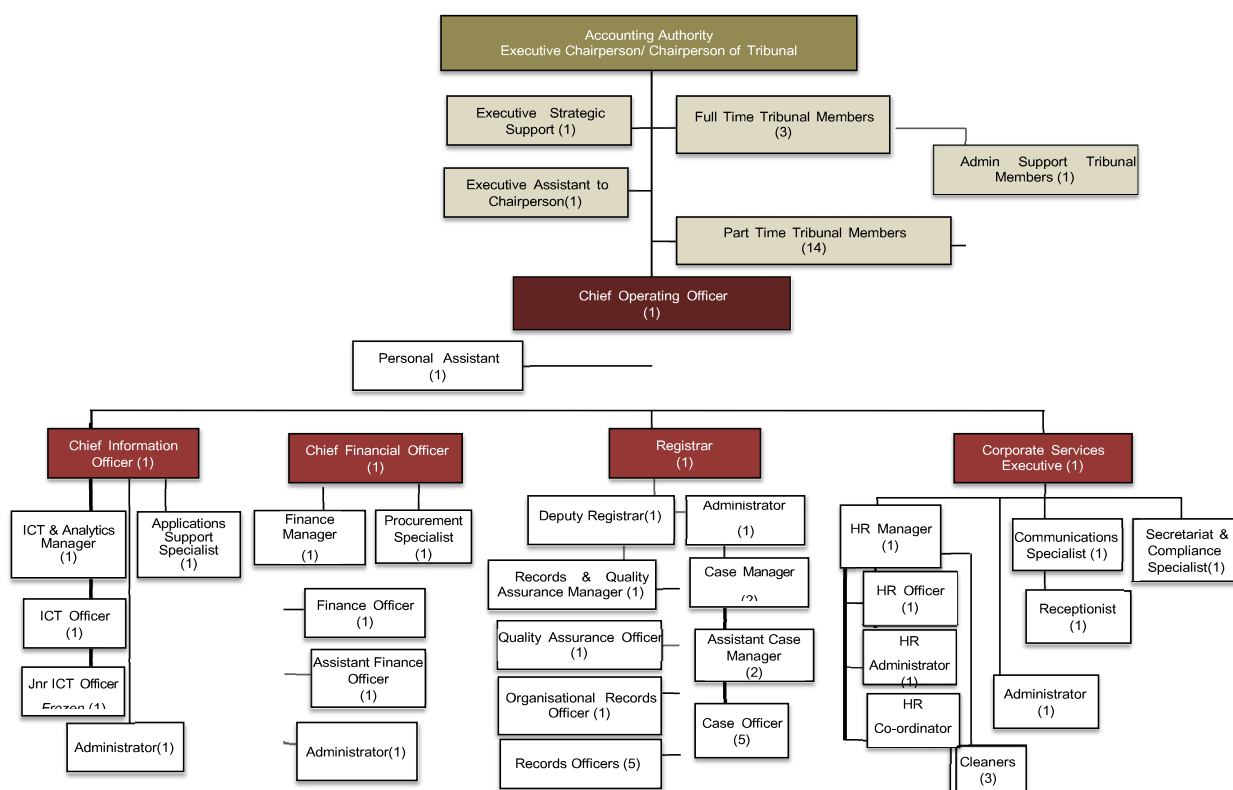
1.1 Mandate and functional purpose:

- 1.1.1 As an independent adjudicative entity, the NCT’s mandate is to hear and decide on cases involving consumers, service providers, credit providers, debt counsellors and credit bureaux. It is also responsible for reviewing decisions made by the National Credit Regulator and the National Consumer Commission.

1.2 In pursuing this mandate, the functions of the NCT is to:

- 1.2.1 Adjudicate on any application or referral that may be made to it in terms of the National Credit Act and Consumer Protection Act;
- 1.2.2 Make any order provided for in these Acts regarding such an application or referral of prohibited conduct and if finding that a contravention exists, by imposing a remedy provided for in these Acts;
- 1.2.3 Grant an order for costs in terms of these Acts;
- 1.2.4 Exercise any other power conferred on it by these Acts.

The NCT's Organogram is outlined below:



2. SERVICES REQUIRED

The Tribunal requires a software developer organization to assist with ongoing programming support to the in-house developed NCT Case Management System (CMS).

2.1 The key requirements of this resource are:

- 2.1.1 Good knowledge and experience of using Visual Studio to develop web-based applications in a Microsoft Windows environment.
- 2.1.2 Good knowledge and experience of using C# to develop web based applications in a Microsoft Windows environment.
- 2.1.3 Good knowledge and experience of database development using Microsoft SQL in a windows environment.

- 2.1.4 Good knowledge and experience of testing and debugging C# developed applications in a Microsoft windows environment.
 - 2.1.5 Good knowledge and experience of developing detailed design specifications for application enhancements in a Microsoft environment.
 - 2.1.6 Good knowledge and experience of testing web-based applications developed in Visual Studio C# and Microsoft SQL database.
 - 2.1.7 Good knowledge and experience of assisting users with problem management on the system once it is deployed into production.
 - 2.1.8 Good knowledge and experience of ASP.NET and IIS within Microsoft environment.
 - 2.1.9 Good knowledge of adaptation of AI based technologies within the Microsoft environment.
 - 2.1.10 Knowledge of SharePoint and SharePoint application program interfaces.
 - 2.1.11 Good knowledge of and experience of webservices and windows services implementation, testing and trouble shooting in a Microsoft environment.
- 2.2 The Tribunal requires the services of a software developer with in-depth knowledge and experience on the above areas to assist with the debugging, development of fixes, addition of functions and release management (production and test environments) of the operational NCT developed Case Management System (CMS) and it's associated database.
- 2.3 The appointment duration will be for an elapsed time period of 24 months and the incumbent will be expected to be available for up to 8 hours a day and 3 days a week on reasonable request from the NCT ICT unit to resolve problems that may arise.
- 2.4 The Service Level Agreement to be signed will be on a time and materials basis with the overall cost not exceeding the value of the purchase order issued to the successful bidder.

- 2.5 The current ICT environment at the NCT consists of 3 high powered DL380 HP servers, an HP P2000 MSA 32 Terabyte Storage Array network and 29 virtual servers which run the enterprise wide applications in a Microsoft Windows 2019 cluster Hyper V environment. The client or user machines consist of a combination of HP, and Apple laptops as well as tablets running the IOS, Android and Windows operating systems which interface into the main servers for access to the line of business applications such as Microsoft Office and the financial applications.
- 2.6 Whilst the NCT has one office based in Centurion, the users can connect in to the main servers using VPN or Web access from anywhere in the country.
- 2.7 The prospective service providers must have good knowledge of the Microsoft Windows operating system as the Case Management system is hosted in this environment.
- 2.8 The key performance areas include:
- 2.8.1 Ability to provide programming support to web-based applications using Visual Studio.
 - 2.8.2 Ability to provide programming support to web-based applications using C#
 - 2.8.3 Ability to provide programming support for SQL database management in Microsoft windows
 - 2.8.4 Ability to debug Visual Studio web applications in C#
 - 2.8.5 Ability to debug database applications developed using Microsoft Windows SQL.
 - 2.8.6 Good applications support skills in a Microsoft Windows environment.
 - 2.8.7 Good communications skills.
 - 2.8.8 Ability to document programmed functions.
 - 2.8.9 Good Database development and support skills using Microsoft SQL.
 - 2.8.10 Good data analysis skills.

2.8.11 User acceptance testing skills.

2.9 The expected rules of engagement are:

- 2.9.1 Specialist available to be onsite for support following on from a reasonable request by the NCT.
- 2.9.2 The appointed service provider will bill for hours utilized on a time and materials basis and not on a retainer basis.
- 2.9.3 Work closely with the resident NCT ICT unit to ensure the CMS system availability for business users.
- 2.9.4 All developed and documented code and the Intellectual Property thereof, will be the property of and owned by the NCT.
- 2.9.5 A service level agreement will be signed by the NCT with the successful bidder outlining the terms of service.

3. LEGISLATIVE FRAMEWORK OF THE BID

3.1 Tax Legislation

- 3.1.1. Bidder(s) must be compliant when submitting a proposal to the NCT and remain compliant for the entire duration of the contract with all applicable legislative prescripts, particularly the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).
- 3.1.2. It is a condition of this bid that the successful bidder should be fully tax compliant, alternatively, that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.
- 3.1.3. The Tax Compliance status requirements are also applicable to foreign bidders / individuals who wish to submit bids.

- 3.1.4. It is a requirement that bidders grant a written confirmation when submitting this bid that SARS may on an ongoing basis during the tenure of the contract disclose the bidder's tax compliance status and by submitting this bid such confirmation is deemed to have been granted.
- 3.1.5. Bidders are required to be registered on the Central Supplier Database and the National Treasury shall verify the bidder's tax compliance status through the Central Supplier Database.
- 3.1.6. Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.
- 3.1.7. Procurement Legislation.
- 3.1.8. The NCT has a detailed evaluation methodology premised on Treasury Regulation 16A3 promulgated under Section 76 of the Public Finance Management Act, 1999 (Act, No. 1 of 1999), the Preferential Procurement Policy Framework Act 2000 (Act, No.5 of 2000) and the Broad-Based Black Economic Empowerment Act, 2003 (Act, No. 53 of 2003).
- 3.1.9. Technical Legislation and/or Standards.
- 3.1.10. Bidder(s) should be cognisant of the legislation and/or standards specifically applicable to the services required.

4. TIMELINE OF THE BID PROCESS

- 4.1 The period of validity of Bids and the withdrawal of offers, after the closing date and time shall be 90 days. The project timeframes of this bid are set out below:

- 4.2 All dates and times in this bid are South African standard time.
- 4.3 Any time or date in this bid is subject to change at the NCT's discretion. The establishment of a time or date in this bid does not create an obligation on the part of the NCT to take any action or create any right in any way for any bidder to demand that any action be taken on the date established.
- 4.4 The bidder accepts that, if the NCT extends the deadline for bid submission (the closing date) for any reason, the requirements of this bid otherwise apply equally to the extended deadline.

5. COMMUNICATION DETAILS

- 5.1 A nominated official of the bidder(s) can make enquiries in writing, to the procurement@thenct.org.za. Bidder(s) must reduce all telephonic enquiries to writing and send to the abovementioned email addresses.
- 5.2 The delegated office of the NCT may communicate with Bidder(s) where clarity is sought in the bid proposal.
- 5.3 Any communication to an official or a person acting in an advisory capacity for the NCT in respect of the bid between the closing date and the award of the bid by the Bidder(s) is discouraged, unless it is for purposes of providing clarity in respect of the legitimate questions pertaining to the bid. The NCT reserves the right not to answer questions which it considers to be inappropriate.
- 5.4 All communication between the Bidder(s) and the NCT must be done in writing.
- 5.5 Whilst all due care has been taken in connection with the preparation of this bid, the NCT makes no representations or warranties that the content of the bid or an information communicated to or provided to Bidder(s) during the bidding process is, or will be, accurate, current or complete. The NCT, and its employees and advisors will not be held liable for any information communicated which may not be accurate, current, or complete.

- 5.6 If Bidder(s) finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this bid or any other information provided by the NCT (other than minor administrative matters), the Bidder(s) must promptly notify the NCT in writing of such discrepancy, ambiguity, error or inconsistency in order to afford the NCT an opportunity to consider what corrective action to take if necessary.
- 5.7 Any actual discrepancy, ambiguity, error or inconsistency in the bid or any other information provided by the NCT shall, if possible, be corrected and be provided to all Bidder(s) without attributing such discrepancy, ambiguity, error or inconsistency to the Bidder(s) who provided the written notice of such matters.
- 5.8 All persons (including Bidder(s)) obtaining or receiving the bid and any other information in connection with the Bid or the Tendering process must keep the contents of the Bid and other such information confidential, and not disclose or use the information except as required for the purpose of developing a proposal in response to this Bid.

6. LATE BIDS

Bids received **after the closing date and time**, at the address indicated in the bid documents, shall not be accepted for consideration and where practicable, shall be returned unopened to the Bidder(s).

7. COUNTER CONDITIONS

Bidders' attention is drawn to the fact that amendments to any of the Bid Conditions or setting of counter conditions by Bidders or qualifying any Bid Conditions shall render such bids invalid.

8. FRONTING

- 8.1 Attention is brought to the bidders that Fronting is a criminal offence, punishable by law.
- 8.2 The Government supports the spirit of broad based black economic empowerment and recognizes that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background, the Government condemns any form of fronting.

- 8.3 The Government, in ensuring that Bidders conduct themselves in an honest manner shall, as part of the bid evaluation processes, conduct, or initiate the necessary enquiries/investigations to determine the accuracy of the representations made in the bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry, as well as the provisions of the B-BBEE Act as amended, be established during such enquiry / investigation, the onus shall be on the Bidder / contractor to prove that fronting does not exist.
- 8.4 Failure by the Bidder(s) to provide evidence to the NCT that no fronting conduct was committed within a period of 14 days from date of notification may invalidate the bid / contract and may also result in the restriction of the Bidder /contractor to conduct business with the Government for a period not exceeding ten years, in addition to any other remedies the NCT may have against the Bidder / contractor concerned. Furthermore, the NCT shall report any suspected acts of fronting to the South African Police Services for investigation.

9. SUPPLIER DUE DILIGENCE

The NCT reserves the right to conduct supplier due diligence prior to final award or at any time during the contract period. This may include site visits and requests for additional information.

- 10.2 Bid documents shall only be considered when received by the NCT before the closing date and time.
- 10.3 The bidder(s) are required to submit Three (3) copies: One (1) original and Two (2) duplicate and submit by the closing date **28 November 2025 at 12:00 PM**. Each submission must be marked correctly and sealed separately for ease of reference during the evaluation process.
- 10.4 Bidders are requested to initial each page of the tender document on the right-hand side at the bottom of each page.

11. PRESENTATION / DEMONSTRATION

The NCT reserves the right to request presentations/demonstrations from the short-listed Bidders as part of the bid evaluation process. At this stage it is not anticipated that this is required.

12. DURATION OF THE CONTRACT

The successful bidder shall be appointed from the date of award for a period determined by the Tribunal.

13. TERMS OF REFERENCE

13.1 Purpose of the bid

- 13.1.1 The National Consumer Tribunal (NCT) requires a software developer resource to assist with ongoing support to the in-house developed NCT Case Management System (CMS) for a period of 24 months.

13.2 Scope of work and timing

- 13.2.1 Refer to section for the details of this section 2

13.3 Proposal

13.3.1 Technical approach

13.3.1.1 Bidders must, at least:

- 13.3.1.1.1 Bidder must be able to articulate and have expertise in design development and testing support of applications built in MS integrated development using C# ASP.NET SQL IIS.
- 13.3.1.1.2 They will need to have structured approach to analysis and resolution of technical problems that may arise within the systems (code logic and database administration).
- 13.3.1.1.3 They must have in depth knowledge of SDLC (Software Development Life Cycle) and PMBOK (Project Management Body of Knowledge) methodologies.

13.3.1.2 Capacity and Experience

- 13.3.1.2.1 They must have at least 5 - 10 years of experience in design, development, testing and deployment of Microsoft web-based applications using MSSQL relational databases.
- 13.3.1.2.2 They must have at least 5 - 10 years of experience in overall management and implementation of controls within web-based applications developed on the Microsoft platform.
- 13.3.1.2.3 They must have in depth knowledge of all security requirements for the development of a web-based application in Microsoft environment.

13.3.1.3 Other

- 13.3.1.3.1 Quality Control

- 13.3.1.3.1.1 They must have at least 5 – 10 years of experience in all quality control aspects required in terms of development, testing and deployment of a web-based application in a Microsoft environment

13.3.1.4 **Insurance**

- 13.3.1.4.1 Provide details of local as well as international professional indemnity insurance (where Applicable).

13.3.1.5 **Approach**

13.3.1.5.1 Detailed approach

- 13.3.1.5.1.1 Information containing the specific steps, resources and timing associated with the approach should be detailed in this section.

13.4 Key outputs/outcomes (Deliverables)

- 13.4.1 This section should include the list of deliverables that will be developed. A description of each deliverable listed should be included in the proposal.

13.5 Proposed project plan

- 13.5.1 The Bidder must provide a project plan, which shall indicate the specific tasks, timeframes and resources with each project activity. The Bidder must provide an organization structure of the project team, including responsibilities of all team members involved.

13.6 Track Record Team

- 13.6.1 Provide resumes of those officers that will be directly involved in the management of the NCT account; who the primary contact will be; and what; if any; experience these officers have in working with public sector clients.

13.7 Quality

- 13.7.1 The proposal should provide details of the approach on how to ensure and measure a quality project delivery. It should provide details of any industry-recognized quality standard to which it is, or will become, compliant (including a timeframe for compliance, if not already achieved), as well as awards received over the last two years.

13.8 References

- 13.8.1 Provide four (4) written current references where services were rendered in the last three years (and if possible, where similar services were provided) who can attest to the bidder's experience as it relates to similar services. Such information should include:

13.8.1.1 The length of time you have provided services,

13.8.1.2 Client name,

13.8.1.3 Contact name and position in company,

13.8.1.4 Address,

13.8.1.5 Phone number; and

13.8.1.6 Email address

13.9 Cost Proposal

- 13.9.1 Tenderers should provide a pricing schedule which clearly sets out the cost of providing the required services, together with any other charges. Other charges should be explained.
- 13.9.2 The terms and fees proposed for the proposed services should include a proposed escalation in fees over a multi-year period of 2 years.

- 13.9.3 The pricing schedule should clearly indicate the hours, and the hourly rate per the respondent's staff.
- 13.9.4 All assumptions made in drawing the proposal, including all cost factors such as traveling, must be detailed.
- 13.9.5 The bidder must indicate if the prices quoted include or exclude value added tax (VAT).
- 13.9.6 Prices quoted must be valid for at least **90 (ninety) days** from the closing of the tender.
- 13.9.7 Any proposal that does not include information required in this paragraph will be disqualified.

13.10 Term of Contract

- 13.10.1 The service level agreement resulting from this request for proposals shall be for a two (2) year period which will be governed in terms of Service Level Agreement.

14. NCT REQUIREMENTS FOR BIDDERS

14.1 The Technical Information should contain the following information:

- 14.1.1 Bidders are required to submit a detailed business proposal consisting of technical and financial information.
- 14.1.2 The experience and qualifications of the personnel to be allocated to the NCT;
- 14.1.3 Provide certified copies of professional qualifications and professional body registration/membership;
- 14.1.4 Provide company registration documents (if applicable), board of directors (if applicable) and management and copies of identity documents and CSD Registration Information;

- 14.1.5 Provide original or the original certified copy of BBBEE Certificate or original sworn affidavit;
- 14.1.6 Provide three (3) or more reference letters from previous clients where similar services were or are being rendered; and
- 14.1.7 Full completion of the attached SBD Forms.

15 EVALUATION AND SELECTION CRITERIA

- 15.1 The NCT has set minimum standards (Gates) that a bidder needs to meet in order to be evaluated and selected as a successful bidder. The minimum standards consist of the following:

15.3.1.1 Functional Evaluation – Bidders will be evaluated out of 100 points and are required to achieve minimum threshold of 80 points of 100 points.

15.3.1.2 The overall score must be equal or above 80 points in order to proceed to Gate 2 for Price and Specific goal evaluations. (Preferential Point system).

15.3.1.3 As part of due diligence, the NCT may conduct a site visit at a client of the Bidder (reference) for validation of the services rendered. The choice of site will be at the NCT's sole discretion.

15.3.2 The bidder's information will be scored according to the following points system:

- 22.2 Engages in any collusive tendering, anti-competitive conduct, or any other similar conduct, including but not limited to any collusion with any other bidder in respect of the subject matter of this bid;
- 22.3 Seeks any assistance, other than assistance officially provided by a Government Entity, from any employee, advisor or other representative of a Government Entity in order to obtain any unlawful advantage in relation to procurement or services provided or to be provided to a Government Entity;
