#### 1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to invitations to tender:

# 1.2 To be completed by the organ of state

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

#### 2. **DEFINITIONS**

(a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method

envisaged in legislation;

- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

#### 4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer

- will be allocated points based on the goals stated in table 1 below as may be supported by proof/documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

#### **BACKGROUND IZIKO**

Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

#### 1. SPECIFICATION

#### a. **BACKGROUND**

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

# b. SCOPE OF WORK

The Iziko Museums of South Africa (Iziko) invites quotations for professional minute taking services for Council, Committee, and ad-hoc meetings over a twelve-month period.

#### Requirements:

- 1. Attend scheduled and ad-hoc meetings (both in-person and online via MS Teams).
- 2. Take accurate notes, refer to agendas and recordings, and prepare:
- Draft minutes and matters arising schedule within 10 working days.
- Final minutes after review by appointed Iziko official
- Chairperson's report within 24 hours of each Committee meeting.
- Submit deliverables electronically in MS Word format.

# **Control Clauses:**

- All draft and final minutes and matters arising schedule must be approved by the appointed Iziko official before acceptance.

#### c. SCOPE OF WORK:

- Service Providers would be expected to attend meetings both online and at any Iziko premises.
- Service Providers must refer to the agenda and take notes during the meeting. The Service
  Provider may also refer to the recording and must utilise their own recording device when
  attending physical meetings.

- Service Providers must produce neatly typed minutes from the notes and forward the completed document to the appointed Iziko official
- Service Providers will also be required to prepare a report for the chairperson of each
  Committee meeting, which summarises the discussions and which is used by the chairperson
  of the Committee to report to Council at the Council meeting. Please note: The timelines for
  these reports are exceptionally constrained. The final report must be submitted within 24
  hours of the Committee meeting to ensure it is available for prompt review by the Chairperson
  of the Committee.
- Service Providers should have the capacity to attend online meetings.
- Traveling cost will be re-imbursed on provision of valid invoices as proof of the expenditure incurred. Land travel will be reimbursed at a rate of R4.76 per kilometre to and from the meeting venue.
- All information is confidential; breaches may result in immediate termination and legal action. Notes, drafts, and recordings must be stored securely on password-protected systems.

# d. OTHER SERVICES AND EXPENDITURE

Any other expenditure arising out of or incidental to the above services must be authorised by Iziko Museums. The cost of other services and related expenditure must be included in the invoice submitted and will be re-imbursed by Iziko provided that a valid invoice from the relevant supplier of the service is attached to the invoice.

# e. <u>TECHNICAL REQUIREMENTS</u>

Providers must demonstrate:

- Proven experience in corporate/government minute-taking.
- Strong listening, summarising, and writing skills.
- Clear, professional English communication.
- Computer literacy (MS Word, MS Teams).
- Capacity to assist with online meeting technical issues.

- b) A mere offer and acceptance shall not constitute a formal contract of any nature for any purpose between Iziko and the preferred Service Provider/s.

# 7. General Principles

a) The lowest or only quotation received will not necessarily be accepted.

b) Iziko and its Council reserves the right to accept or reject any quotation in response to the Request to Quote and to withdraw its decision to seek the provision of these services at any time.

#### 8. **DECLARATION**

The undersigned, who warrants that he / she is duly authorized to do so on behalf of the enterprise:

- confirms that neither the name of the enterprise or the name of any partner, manager, director or other person, who wholly or partly exercises, or may exercise, control over the enterprise appears on the Register of Tender Defaulters established in terms of the Prevention and Combating of Corrupt Activities Act of 2004:
- ii) confirms that no partner, member, director or other person, who wholly or partly exercises, or may exercise, control over the enterprise appears, has within the last five years been convicted of fraud or corruption;
