Tenders are hereby invited for the BODIBE WATER RETICULATION

The proposed scope of work includes development of groundwater sources, borehole equipping and chlorination, refurbishment of existing boreholes housing, submersible pumps and electrical, Refurbishment of Point A pump station building, mechanical, electrical, valves and pipework, Construction of new 2400 Kl concrete reservoir, refurbishment of existing elevated steel tank, Installation of 2 x new elevated steel tanks, Construction of new pump station at Point B with ground level steel tank, bulk and reticulation pipelines and communal standpipes.

The tenders are invited in terms of the Preferential Procurement Regulations of 2022 using compliance, functionality, and 90/10 points system.

Tenderers must have the necessary skills, experience, and capacity to complete and commission the Works successfully in terms of the tender documents and to the required standards.
