1. BACKGROUND

- 1.1 RT2-2021 a Transversal Contract for Medical Equipment commenced on 1 December 2021. It was awarded with one hundred and thirty-two (132) items out of two hundred and fifty-four (254) items advertised which caused sixty-one (61) items not to be awarded.
- 1.2 The State will be advertising a supplementary transversal contract for some of the non-awarded items.
- 1.3 There are additional items on category 5 for General Equipment and an additional category 11 for Advanced Hospital Furniture.
- 1.4 To address any short comings on the Technical Specifications, National Treasury, Transversal Contracting (TC) is embarking on consulting with the industry for the review of the Technical Specifications.
- 1.5 TC aims to achieve the following objectives by consulting with the industry:
 - 1.5.1 On obtaining the latest trends of medical equipment.
 - 1.5.2 For the Technical Specifications to be free from biasness.
 - 1.5.3 That there are potential bidders for the additional items.
 - 1.5.4 To review the current Technical Specifications to ensure bidders are able to supply offers against the Technical Specifications.

2. CONSULTATION PROCESS ON THE INPUTS TO BE RECEIVED

Upon the closing date of the inputs on the Technical Specifications, there will be an industry consultation for an inclusive outcome on the Technical Specifications.
