All proposals will be evaluated by Supply Chain Management for administrative compliance, functionality, price and B-BBEE. Based on the results of the evaluation process and upon successful negotiations, iThemba LABS will approve the awarding of the contract to the successful bidder.

- **Preference points system:**

The 80/20 preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status. “If all bids received are more than R 1 000 000.00, this request is automatically cancelled”.

Subject to section 2(1)(f) of the PPPFA, the contract will be awarded to the tenderer scoring the highest points.

No price quotations or competitive bids shall be awarded to business or persons who are not tax compliant.

SCOPE OF WORK

Calibration of Testo 545 Digital Lux Meter

1. Scope of Services

iThemba LABS requires the calibration of one Testo 545 Digital Lux Meters for a period of three (3) years, including the issuance of all applicable calibration certificates, reports, and calibration labels.

The calibration laboratory shall be SANAS accredited for Photometry Metrology (Illuminance/Lux Meter Calibration) with a scope of accreditation that includes lux meter calibration. Equivalent internationally recognized accreditation may be accepted.

2. Calibration Requirements

The service provider shall:

- Perform calibration under controlled environmental conditions.
- Record and report the temperature and humidity prevailing during calibration.
- Calibrate the instrument using procedures and methods traceable to recognized national or international standards.
- Ensure all reference standards used are traceable to national or international measurement standards.
- Maintain measurement uncertainty appropriate for the calibration performed.
- Verify instrument performance across the applicable measurement range.

3. Documentation Requirements

The bidder shall submit with its quotation:

- Valid SANAS Accreditation Certificate.
- SANAS Scope of Accreditation demonstrating competency for photometry/illuminance calibration.
- Company profile detailing relevant calibration experience.

4. Deliverables

Upon completion of each calibration, the service provider shall provide:

4.1 Calibration Sticker

A calibration label affixed to the instrument indicating:

- Instrument identification number.
- Calibration date.
- Next calibration due date.
- Certificate number.

4.2 Calibration Certificate and Report

The calibration certificate shall include:

- Instrument description and serial number.
- Date of calibration.
- Recommended next calibration date.
- Environmental conditions during calibration (temperature and humidity).
- Location where calibration was performed.
- Reference instruments used.
- Calibration dates and certificate numbers of reference standards used.
- Measurement results obtained.
- Applicable test ranges/specifications.
- Measurement uncertainty, where applicable.
- Pass/fail statement against specified acceptance criteria.
- SANAS accreditation number.
- SANAS accreditation logo (where permitted under SANAS rules).
- Authorized signatory details.

4.3 Calibration Data

The report shall include:

- Raw test data.
- Average values and calculations where applicable.
- Deviations from reference values.
- As-found and as-left results, where applicable.
- Any observations, adjustments, or limitations identified during calibration.
- Results presented in accordance with the protocol to be provided by iThemba LABS after contract award.

5. Contract Duration

The contract shall be valid for a period of three (3) years, with calibration services performed at the intervals specified by iThemba LABS.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
