The purpose of this bid is to get a service provider to assist with the development of a city-wide business continuity plan. This Business Continuity Plan will form part of the larger incident response structure within the City. It will include information describing the actions and procedures to be followed by the City to recover critical business processes in the event of an incident affecting its operations. The plan will include recovery tactics to be used during an incident that affects the City's operations, which may have been affected by an interruption to premises, information technology, documentation, suppliers and loss of people.

Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The city further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.
