Formal quotations will be evaluated in terms of the **80/20** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2017) and the Municipality’s Supply Chain Management Policy. Further note, it is prerequisite that all prospective service providers who are not yet registered on the Central Supplier Database to be registered, registration can be done online via www.csd.gov.za

Further note that Local Content and Production as well as pre-qualification criteria, will form part of evaluation and therefore all potential bidders who fail to meet the minimum threshold for local content will not be considered for award.
