INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our **vision** is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our **mandate** is the delivery of Conservation Mandate by Excelling in the Management of a National Park System

Our **mission** is to develop, protect, expand, manage, and promote a system of sustainable national parks that represents natural and cultural heritage assets, through innovation, excellence, responsible tourism and just socio-economic benefit for current and future generations.

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed in Schedule 3 Part A: Public Entities. The business unit responsible for the bid is Finance.

CONTEXT OF THIS PROCUREMENT

Over the years, SANParks has encountered difficulties in successfully executing the annual procurement plan. It has become evident that one of the primary reasons for delays in implementing the procurement plan is the development of poorly or insufficiently written specifications/Terms of Reference. This issue often leads to the cancellation or withdrawal of bids either during the Bid Evaluation or Bid Adjudication phase. Consequently, bids are frequently referred back to the Bid Specifications Committee for specification or Terms of Reference revision or amendment. This process is time-consuming and results in the extension of delivery dates.

This process is in addition to the existing panellists. The objective of this Request for Proposal is to procure the services of appropriately qualified service providers (panel) possessing the necessary capacity, experience, skills, and knowledge to aid in managing bids from specification (TOR's) through to the award stage. Additionally, they should offer strategic supply chain management (SCM) advice and support for specialized SCM projects on an as-needed basis. Ultimately, the selected service provider will contribute to enhancing the efficiency of the supply chain process. Given that SANParks is a multi-disciplinary organization, the service providers must possess or be able to furnish the required expertise as and when required.

CONTRACT PERIOD

The contract with the panel of service providers will run for a period not exceeding five (5) years. The successful bidders will form part of the panel. Request for quotations will be issued to the service providers on the panel who will compete on the basis of price, specific goals and any other evaluation criteria applicable for the specific RFQ.

TERMS OF REFERENCE – APPOINTMENT OF A PANEL OF PROFESSIONAL SERVICE PROVIDERS FOR SUPPLY CHAIN MANAGEMENT CO – SOURCING ON AN ADHOC BASIS FOR A PERIOD NOT EXCEEDING FIVE (5) YEARS

SPECIFICATIONS / SCOPE OF WORK

SANParks spends an average of approximately R1Billion on goods, services and works per financial year. The prospective service provider(s) to familiarise themselves with SANParks' historical spend patterns in order to understand the type of goods and services to be procured. The prospective service providers may access the Annual Report on SANParks website and The Annual Procurement Plan on National Treasury website for more information. Based on the historical spend patterns, the prospective service provider will be in a better position to have an idea of what goods and services they will be required to administer open bids from specification (TOR's) to awards, provide SCM strategic advise and assist with specialised SCM. Prospective service Provider may choose their areas of expertise as SANParks is cognisant of the fact that there may be no single service provider who would have expertise in all areas.

In order to ensure a clear and concise specification, it will be necessary for the service provider to consult with the end users of the proposed goods or services to be procured to ensure that their requirements are incorporated into specification /ToR.

1. The service provider will be required to provide the following SCM related services.

- a) Conduct market research to determine available solutions, approximate costings, lead times, availability of targeted service providers/ suppliers, and applicable market norms and standards.
- b) The service provider must produce a detailed market analysis report with recommendations.
- c) Form part of SANParks' Bid Specification and Evaluation Committees as and when necessary, at an advisory level.
- d) Successful service provider will be required to make inputs to the above-mentioned committees and assist in drafting the specifications and or evaluation of bids as well as BEC Reports
- e) The successful service provider will be expected to assist in drafting preliminary specifications or Terms of Reference in consultation with end user department / BSC that are and not limited to the following:
 1. Specifications should be clear, concise and easy to understand, drafted in an unbiased manner to allow all potential bidders to offer responsive bids for goods and services;
 2. Specifications must comply with the public sector SCM prescripts.
 3. Quality specifications, describing technical and other standards to be met, describe how products should be maintained or serviced
 4. Include detailed objective evaluation criteria with clear instructions, weightings and scores
 5. Environmental specifications that comply with health, safety, environmental and other applicable Legislation including environmental sustainability (green economy).

- f) The successful service provider will be expected to meet the business requirements of the end user;
- g) Assist with drafting of SCM Sourcing Strategy based on SCM Assessment and or market analysis.
- h) Assist with implementation of SCM Strategy (including procure to pay and specialised SCM).
- i) Assist SCM department in handling special projects / complex projects and PPPs to improve the SCM function.
- j) The bidder may be required to render- supply chain management functions as listed in underneath the paragraph and may be required to have exposure relating to amongst others, the following disciplines:
 - Conservation,
 - Human Capital Management,
 - Tourism and marketing,
 - Information, Communication and Technology,
 - Infrastructure,
 - Veterinary Wildlife Services and
 - Finance.

Recognizing that no single service provider may possess expertise across all areas, bidders **are requested to indicate below with an “X” the specific category(ies)** they wish to tender for, and each category will be evaluated independently based on the bidder’s capabilities and expertise.

NB: If any categories are not fully or are insufficiently covered, SANParks reserves the right to procure these services through a competitive bidding process.

Successful bidders will be expected to provide SCM-related services, including but not limited to:

1. Demand Management

- Conduct needs assessments to determine procurement requirements.
- Perform market research to assess available solutions, pricing, lead times, and market norms.
- Develop clear, concise, and unbiased specifications/TORs in consultation with end users to ensure all potential bidders can submit responsive bids.
- Ensure specifications comply with public sector SCM regulations and incorporate quality, environmental, and sustainability considerations.
- Provide detailed market analysis reports with recommendations.

2. Acquisition Management

- Assist with the development of the procurement plan (APP) and the development of SCM sourcing strategies.
- Form part of SANParks' Bid Specification and Evaluation Committees in an advisory capacity.
- Assist in drafting bid specifications and evaluation reports to support transparent and objective decision-making.
- Ensure bid documentation includes clear evaluation criteria, scoring mechanisms, and compliance with applicable laws.

3. Logistics Management

- Support inventory and asset management to optimize procurement processes.
- Provide guidance on warehousing, distribution, and transportation of procured goods.

4. Disposal Management

- Assist in developing asset disposal strategies aligned with regulatory requirements.
- Ensure compliance with disposal regulations, recycling, and waste management policies.

5. Risk Management

- Identify and mitigate supply chain risks to enhance operational efficiency.

6. Performance Management

- Develop templates and provide training on the evaluation of supplier performance and provide recommendations for improvement.
- Monitor compliance with relevant SCM frameworks and best practices.

7. Financial Management

- Conduct cost-effectiveness and value-for-money assessments in procurement decisions.
- Ensure budget alignment and financial controls throughout the procurement cycle.

8. Compliance Management

- Ensure compliance with Public Finance Management Act (PFMA) and National Treasury Regulations, as well as any relevant legislative prescripts.
- Prepare audit action plans / audit tracker for the SCM portfolio.

9. Contract Management

- Develop Service Level Agreement (SLA) enforcement strategies to ensure contractual obligations are met.
- Provide guidance on contract management and administration, including compliance and reporting.

2. Minimum Team Requirements

The service provider's project team members must be fully conversant with the public sector procurement requirements and possess the necessary qualifications, skills, experience, expertise and knowledge required to efficiently and effectively undertake projects required on an as and when basis.

To this end, considering the scope of work and the entity's previous practical experience in this regard, SANParks requires the service provider's project team to consist of the following members as a minimum: (NB- It should be noted that project teams will be specified per project as and when the need arises. Bidders should have the following minimum resources to be used for various projects as and when required;

Project Manager/ Team Leader – Minimum 10 years' experience in public sector Supply Chain Management. The service provider's project manager will be responsible for the overall management of the service provider's project team, the achievement of the project objectives and the quality of the work and products produced by the team. The Project Manager is expected to represent the appointed service provider at scheduled meetings, if any

Minimum two (2) SCM Specialist - each having a minimum 5 years' experience in public sector SCM environment

The service provider must be willing and able to deploy its team to SANParks throughout the Parks as and when required

3. Other special conditions of contract

- a) Work arrangement will be determined as and when the RFQs are issued and may be subject to travel to SANParks' Regional Offices and or Parks.

- b) Hours to be worked will be determined per project as and when the need arise.
- c) Should there be a need for a specific skill, the successful bidder should be able to source such within Seven (7) working days. Resources to be assigned to projects must be approved by SANParks and will be in line with specific Request for quotation details.
- d) Should any of the team members exit the project / employment of the service provider, a replacement with similar experience and qualifications must be provided and approved by SANParks within Seven (7) working days.
- e) The service provider is expected to provide team members with all the necessary tools of trade such as laptops, cell phones, etc.
- f) The appointed service provide shall ensure that all information submitted by SANParks will be treated with confidentiality and only be used for the intended purpose. Such information belongs to SANParks and the service provider shall have no claim to it.
- g) Successful service shall take care of the teams' travel arrangements / logistics
- h) SANParks will provide the service provider's team members with working space and printing in the respective regional office and or Parks Where necessary
- i) In an event where the appointed service provider is unable to perform, SANParks reserves the right to cancel task order and appoint another service provider within the panel.
- j) Bidders should note that work is not guaranteed since it is dependent on the projects that will be identified within the contract duration and only those who are successful in the process emanating from the RFQ
- k) Any information acquired during the process of the assignment shall remain confidential and the property of SANParks.

REPORTING REQUIRMENTS:

The successful service provider will be required to submit the periodic reports as may be agreed to with the GM SCM / respective SCM Regional Managers.

Phase 1: Mandatory evaluation criteria

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
