1. PURPOSE

The Kwazulu-Natal Growth Fund Agency (KZNGFA) invites quotations from suitably qualified service providers to provide KZNGFA with a Psychometric assessments and Background checks for the KwaZulu-Natal (KZN) Growth Fund Agency for 36 months.

2. BACKGROUND

KZN Growth Fund Agency (KZNGFA) is, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KZNGFA is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KZNGFA, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KZNGFA Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KZNGFA.

The KZNGFA wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

3. SCOPE OF SERVICES REQUIRED

KZNGFA seeks to appoint a suitably qualified and experienced service provider for psychometric assessments and background checks for KZN Growth Fund Agency. Service providers must be able to do Background Checks for the candidates anywhere within the South African Borders

The appointed service provider will be responsible for the following activities:

- The design and customisation of assessment tools and techniques in accordance with KZNGFA guidelines:
- Conduct assessments with recommended candidates from the interview:
- Compile individual reports with developmental plan (if any) and feedback report to the panel on the assessment outcomes:
- Provide psychometric assessments and background checks at different organisational levels including but not limited to Executive, Senior Management and Middle Management and any other level as and may be requested.

The Background checks:

- Grade 12 / Matric verification
- Relevant academic qualification/s verification (SA & International)
- Professional membership verification
- Criminal record verification – is this the SAPS verification?
- Identity number & citizenship verification
- Social Media Activities / Profiles report
- Credit bureau verification if necessary (ITC)
- Employment Reference verification

PSYCHOMETRIC ASSESSMENTS

The successful bidder will provide professional Psychometric services to KZNGFA. This will be done either virtually (online) or in-person. The services will include but not limited to following:

- **Administering and administration of assessments** must be done in within 72 hours from time of KZNGFA has issued an assessment request. This can be virtual but must be supervised by the psychometrist.
- **Assessment scoring and storing** must be done within 72 hours of the assessment being completed and results must be stored and backed up for retrieval at any time over the duration of the contract.

- **Interpretation and report compilation** must be comprehensive and integrative. Line manager summary reports and development reports must be dynamic and professional.
- **Feedback to assessed individuals** must be provided to the individuals assessed upon request for individual feedback. Feedback will be provided, in the case of recruitment once the recruitment process has been concluded.
- Comparative dashboard of candidates with summary of competencies
- Presentation of reports to the interview panel
- **Comprehensive report within 5 working days of request**

The Bidder should have in-depth knowledge in the following Assessment approach:

- Prepare the candidate before the assessment session and prepare for the session beforehand.
- Assist the candidate understand the purpose of the assessment.
- Ensure that the candidate is in the right frame of mind when completing assessments. – how would you measure this?
- Create/facilitate an enabling environment for the candidate to complete assessments productively.
- Practice high levels of ethical behaviour when providing psychometric services to the KZNGFA and its candidates/employees.

KZNGF will provide:

- Details of the candidates for verification and/or assessments
- Job profiles for assessments

4. CONTRACT DURATION

5. AWARD OF THE RFP

KZNGFA is not obliged to accept and award this tender to the lowest bidder or any other bidder.

6. EVALUATION PROCESS AND CRITERIA

Selection will be conducted over three stages as detailed below:

All bids duly lodged as specified in this RFQ will be examined to determine compliance with the mandatory requirements and conditions. Failure to provide any mandatory information as requested above will result in the submission being deemed non-responsive.

6.3 STAGE 2 – FUNCTIONALITY EVALUATION

Scores will be tabulated to 100 points. Respondents must score 70 points and over to be assessed on their financial offer and preference score.

- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

- Ps = Points scored for price of tender under consideration

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
