1. BACKGROUND

- a) The Municipality intends to call for bids in respect of Asset Management Support for a period of thirty-six (36) months.
- b) The Municipality requires external assistance to complement its current capacity to fulfil its obligations in terms of the Municipal Finance Management Act (MFMA).
- c) The successful Bidders will report to the Chief Financial Officer (CFO) on work allocated to them.

2. CONTRACT TERM

- 2.1 The duration of the contract is for a period of thirty-six (36) months. The successful bidder will be required to sign Service Level Agreements with Vhembe District Municipality.
- 2.2 The appointed service provider is expected to develop an implementation plan within one week of appointment.

3. SCOPE OF WORK

3.1 Provision of Asset Management System that integrates with Municipal Financial Management System and is able to perform the following functions:

- a) Importing the current Excel Fixed Asset Register to the proposed Assets Management System.
- b) The proposed Asset Management System must be mSCOA compliant.
- c) The Asset Management System that integrates with the financial management system of VDM.
- d) Integration of Project expenditure from Municipal Financial System to the proposed Asset Management system
- e) Seamless component transaction mSCOA journal exchange from Proposed Asset Management system to Municipal Financial system.
- f) Seamless mSCOA journal authorisation exchange from Municipal Financial system to Proposed Asset Management system.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
