INSTALLATION OF FRAMELESS GLASS STACKING DOOR AND BALUSTRADE

Brief:

Frameless glass stacking door and balustrade with door needs to be installed on the ISAM Block C ground and first floor between the exhibition and the collections storerooms. This needs to be done for security purposes of public, staff and collections.
