SECTION 2: BACKGROUND, PURPOSE, AND SCOPE OF WORK

ACSA has built a conferencing facility at the ACSA Western Precinct Building, located in O.R. Tambo International Airport. The facility consists of a conference plenary, VIP holding rooms, exhibition spaces, and a world-class Aviation Academy.

ACSA intends to further enhance its offering by creating a niche **aviation focused innovation centre** which will be aimed at increasing industry collaboration, exhibitions, and innovation amongst airport stakeholders.

The innovation centre will enable prototype development and testing, airport simulation, commissioning, and exhibition of airport technology; it shall further allow for use by stakeholders as an incubation hub.

The innovation centre must be welcoming to visitors, inspiring interactive engagements, creative work, as well as deep focused work. The centre must also depict the airport passenger journey and touchpoints within an airport environment, focusing on various technologies that are needed for airport operations.

The innovation centre is a component of the ACSA International Indaba Conference facility and must have a cohesive look and feel, whilst distinctly encouraging creativity and having vibrant finishes that would be typical of an innovative environment. Bidders are encouraged to familiarize themselves with these spaces to achieve a cohesive look within the building.

Bidders are requested to submit a space planning layout, décor, and furniture design solution to enable the ACSA Innovation Centre located at the ACSA International Conference Centre in OR Tambo International Airport. Further, bidders are to execute minor reconfiguration work, as per approved design, complete all electrical modifications, minor plumbing works and provide drawings and OHS evacuation plans for the innovation centre.

The bidder must provide proposed furniture fittings for the space with artistic impression including interior design elements, partitioning, basic framed glass partitioning for rooms, reinforced dry walling that can support mounted equipment (i.e. screens), furniture design for all rooms and spaces, finishes, colour scheme (in line with ACSA's colour scheme and cohesive with the ACSA International Conference Centre), materials and fabrics, artwork and ornaments and achieve the overall desired functionality of the area in line with ACSA's desired finishes. A preliminary design concept and 3D layout shall be returned as part of the bid proposal. At the awarding phase, minor adjustments may be effected prior to final design sign-off by ACSA.

The required outcome must encompass the following elements:

- A modern and welcoming client facing visitors and exhibition environment. The space must be inspired by aviation and the passenger journey through an airport environment.
- An inspiring, functional work environment that encourages innovation and collaboration

The Innovation Centre is approximately 900sqm shall consist of three zones.

Zone 1 – Exhibition and Simulation Zone

- A formal, executive boardroom with seating for at least 12 people with smart board (Technology to be installed by ACSA)
- 2 huddle rooms with smart boards on each room (Technology to be installed by ACSA)
- 1 office with 2-seater visitors' table
- 2x permanent ACSA exhibition booths. Must be 3mx3m in size and aviation themed. These booths will be used to exhibit ACSA products on a permanent basis
- Exhibition platform (floor and backdrop) to display and simulate airport technology
- The space must be able to fit an airports-of-the-future sandbox or an interactive digital display table that is 2mx1m (Technology to be installed by ACSA)
- Indicate where plug points should be placed
- Indicate walkways where necessary
- Include lighting to enhance the space

Zone 2: Reception and Waiting Area

- An inviting reception area with reception desk and lighting
- The reception area shall have a 6m wall framed LED screen to be used for displaying presentations to visitors (Technology to be installed by ACSA)
- The reception area shall have executive visitors seating with device charging capability within reach

Zone 3: Collaboration Zone

- Proof of Concept and testing room accommodating 10 people at a time, with a wall to allow mounting of screen(s), workstations, and fit any testing tool required for a specific initiative
- Simulation room accommodating 10 people, with a wall to allow mounting of airport display screens, various simulations tools and technologies
- Kitchenette, fully fitted with appliances
- Open work area for collaboration and deep work accommodating 12 people
- Quiet spaces for deep work (i.e., work booths)
- Create walkways where necessary

- Include lighting to enhance the space

The highlighted technologies are to give an impression of what needs to be fitted in the room as a minimum. The service provider is not expected to supply the technologies and equipment as these will be installed by ACSA at the conclusion of the design and build phases.

This is envisaged to be a world class, client-facing environment that would host industry leaders and international guests as well as important airport stakeholders who will from time-to-time work on innovative solutions in collaboration with ACSA.

ACSA seeks to find a service provider that will provide a turnkey solution contract which will entail the design, build, install and furniture fitout to enable the envisaged end product.

Key milestones dates shall be as follows:

1. Phase 1: Design and space planning phase to be finalised within 1 week of bid award
2. Phase 2: Completion of reconfiguration works to be completed within 3 weeks of Phase 1. This constitutes the crux of the deliverables.
3. Furnishing and fit out to be completed within one week after the completion of phase 2

ACSA is set to launch the innovation centre in February 2026 to its external and internal stakeholders.

It is important for bidders to note that it may be necessary for work to continue on weekends and to resume as soon as possible after the festive season in January 2026. The ACSA Head Office will resume work on the 5th of January 2026.

The project schedule is therefore limited to 2 months for design, build, and furnishing. An additional month shall be allowed for snags, items with a long lead time and final completion.

SECTION 2: EVALUATION CRITERIA

2.1 Evaluation Criteria

2.1.1 ACSA will use a pre-determined evaluation criteria when considering received bids. The evaluation criteria will consider mandatory administrative, functionality, Price, and Preference. During the evaluation of received bids ACSA will make an assessment whether all the bids comply with set minimum requirements and whether all returnable documents/information have been submitted. Bidders which fail to meet minimum requirements, thresholds or have not submitted required mandatory documents will be disqualified from the bid process.

2.1.2 The requirements of any given stage must be complied with prior to progression to the next stage. ACSA reserves the right to give bidders reasonable time to submit information that will be required in Stage 1 below.





4.2 Any documentation or written record or other material containing confidential information (in whatsoever form) which comes into the possession of the receiving party shall itself be deemed to form part of the confidential information of the disclosing party. - 12.4 The parties acknowledge that this agreement and the undertakings given by it in terms hereof are fair and reasonable in regard to their nature, extent and period and go no further than is reasonably necessary to protect the interests of the parties.
- 12.5 The parties hereby confirm that they have entered into this agreement with full and clear understanding of the nature, significance and effect thereof and freely and voluntarily and without duress.
- 12.6 Neither party shall have the right to assign or otherwise transfer any of its rights or obligations under this agreement.
- 12.7 This agreement may be executed in several counterparts that together shall constitute one and the same instrument.
- 12.8 In this agreement, clause headings are for convenience and shall not be used in its interpretation.
- 12.9 Each clause of this agreement is severable, the one from the other and if any one or more clauses are found to be invalid or unenforceable, that clause shall not affect the balance of the clauses which shall remain in full force and effect.
