1. INTRODUCTION

Implementation of the NQF, advance the objectives of the NQF and coordinate its three Sub-Frameworks. The South African Qualifications Authority (SAQA) is a public entity listed in Schedule 3A of the Public Finance Management Act (PFMA). It is mandated by the National Qualifications Framework (NQF) Act, 67 of 2008, to oversee the further development and implementation of the NQF, advance the objectives of the NQF and coordinate its three Sub-Frameworks.

SAQA considers background screening and pre-employment checks essential to ensure the integrity, suitability, and compliance of candidates before appointment.

2. PURPOSE

The purpose of this Request for Quotation (RFQ) is to appoint a suitably qualified service provider to conduct background screening and pre-employment checks, thereby supporting SAQA's commitment to ethical recruitment practices, safeguarding organisational integrity, and ensuring that all prospective employees meet the required standards of suitability, credibility, and compliance.

3. SCOPE OF SERVICES

The following scope of services must be delivered in line with service level standards, which will include the following, amongst others:

- 3.1 Provide the necessary equipment and software to capture and release fingerprint data of candidates for background screening purposes as and when required.
- 3.2 Deliver training and support to five designated SAQA users on the operation and maintenance of the fingerprint scanning equipment and associated software.
- 3.3 Conduct thorough, accurate background screening and pre-employment checks within a turnaround time of 4 days since fingerprint data has been released.
- 3.4 Conduct criminal record checks using digital fingerprint scanning and the Automated Fingerprint Identification System (AFIS) to verify against the South African Police Service (SAPS) database.
- 3.5 Conduct credit checks on a candidate's credit history, including defaults, judgments, notices, disputes, and previous inquiries from various credit bureaus.
- 3.6 Conduct previous employment history checks.
- 3.7 Conduct identity and passport verification including nationality or citizenship checks.

4. GENERAL REQUIREMENTS

- 4.1 The quotation presented to SAQA must include all costs and disbursements inclusive of VAT.
- 4.2 Bidders are required to provide a brochure providing their service offerings related to background screening and pre-employment checks.

5. TIMELINES

The total duration of this contract will be thirty-six (36) months.

6.1 Penalty Maximum Limit and Service Disputes:

SAQA reserves the right to enter into Service Disputes at any point in time with the view of contract cancellation, should the deliverables not be met on time during a Service Dispute, the service provider shall continue to render services per these service levels.

7. EVALUATION CRITERIA

The bid will be evaluated in two (2) stages:

- Stage 1: Screening of mandatory documents.
- Stage 2: Price and preference points.

8. STAGE 1: MANDATORY REQUIREMENTS

Bidders must comply with this section as it forms the basis of the evaluation of the bidder's proposal.

Mandatory documents

Reference letters

- The bidder must attach a minimum of three reference letters.
- The letters must be signed, confirming background screening and pre-employment checks conducted.
- Letters must be on the client's letter head.

For a bidder to qualify to be evaluated for Stage 2 for Price and Preference Points, a bidder must not have been disqualified in compliance with the Mandatory requirements above.

9. STAGE 2: PRICE AND PREFERENCE POINTS EVALUATIONS

All bidders that have passed the mandatory requirements will be evaluated in terms of the 80/20 system prescribed by SAQA in line with PPR 2022 as follows:

- 80 Points for pricing.
- 15 preference points for the company that has at least 51% black ownership.
- 5 preference Points for the company that has at least 30% black woman ownership.

- c) Bidders must complete, sign, and submit the attached SBD 4 and SBD 6.1 forms.

- e) In Instances, where brand names are mentioned, SAQA will accept equivalent items that have similar specifications.
- f) The National Treasury's General Conditions of Contract will apply and is enforceable on this RFQ.
- g) The RFQ will be evaluated in terms of the 80/20 system prescribed by the Preferential Procurement Policy Framework Act.

12. PROTECTION OF PERSONAL INFORMATION

- a) In this clause, the words "personal information", "processing" and "responsible party" have the meanings ascribed to them in the Protection of Personal Information Act, 2013 (Act No.4 of 2013).
- b) SAQA will comply with the Protection of Personal Information Act, 2013 (Act No.4 of 2013, (POPIA) by lawfully processing personal information submitted by bidders in accordance with the conditions of lawful processing as set out in POPIA.
- c) All bidders must comply with their obligations as set out in POPIA for which they are a Responsible Party before sharing any information with SAQA.
- d) SAQA will not be held liable for any non-compliance with the provisions of POPIA or unlawful processing or sharing of information by a bidder.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

DEFINITIONS

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of incomegenerating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation:
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
