## **1. PURPOSE**

The purpose of this RFQ is to appoint a photographer who will create a pop up studio at the SANParks Head Office and photograph the SANParks Executive Management, Board of Directors and a limited number of other staff no exceeding five.

## **2. BACKGROUND**

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

### **3. SCOPE OF WORK**

SANParks requires the services of a photographer who will create a pop up studio at the SANParks Head Office in Pretoria and photograph the SANParks Executive Management and Board of Directors. Two sessions or two days may be required for the photography services depending on the availability of members

Head and Shoulder length and Full length photographs wearing three outfits

- Formal (Black and White)
- Cultural / Traditional Attire
- SANParks Corporate Uniform

#### **Board of Directors (12)**

Head and Shoulder length and Full length photographs wearing two outfits

- Cultural / Traditional attire

#### **Corporate Communications Team (3)**

- Head and Shoulder length wearing SANParks Corporate uniform
